Development: Ms. Nickerson stated that this committee has one item on the agenda. Number 7 which is a first reading of an Ordinance consenting to an Ohio Enterprise Zone and Tax Abatement Agreement between the City of Chillicothe OH and J. C. Properties of Chillicothe, LLC DBA Chillicothe Steel. Ms. Nickerson stated that she would like to go ahead with the three reads but would like to add emergency language so once it is voted on, it would go into effect immediately.

Finance: Mr. Anthony Phillips stated that this committee has three items on the agenda. City Services/Transit: Mr. Fairrow stated that this committee has item number 8 on the agenda.
