Candidate Filing Period:

The period for filing a Declaration of Candidacy will be from Monday, June 2, 2025, through Friday, June 6, 2025, during regular business hours.

Declaration of Candidacy:

Qualified individuals must file in person at the Duchesne City Office, located at:

Duchesne City Office, 500 East Main Street, Duchesne, Utah, Monday through Friday, 8 am to 5pm. A \$35.00 filing fee for City Council Member Candidates and \$100.00 filing fee for Mayor Candidates will be collected during the declaration period.

Eligibility Requirements:

Candidates must be:

- A United States citizen
- A registered voter of Duchesne City
- A resident of Duchesne City for at least 12 consecutive months prior to the election.

In compliance with Utah Code § UCA 20A-16-502, Duchesne City provides the following notice to UOCAVA voters regarding the upcoming municipal elections:

Election Dates:

Primary Election (if necessary): August 12, 2025

General Election: November 4, 2025

Offices to Be Voted On:

- Mayor (4-year term)
- City Council Member (4-year term)
- City Council Member (4-year term)

Candidate Filing Period:

June 2–6, 2025

Ballot Information:

- Ballots will be mailed to UOCAVA voters at least 45 days prior to the election date.
- Ballots must be received by the Duchesne City Office no later than 8:00 PM Mountain Time on Election Day to be counted.


