



**NOTICE OF PROPOSED SUBSTANTIAL AMENDMENT NO. 1 FOR THE  
COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) PROGRAM YEAR  
2023-2024 ANNUAL ACTION PLAN AND COMMENT PERIOD**

The City of Edinburg is considering a Substantial Amendment No. 1 to the 2023-2024 Annual Action Plan. The City is an Entitlement Community in the U.S. Department of Housing and Urban Development’s (HUD) Community Development Block Grant (CDBG) Program.

As per the City’s Citizen Participation Plan and per 24 CFR Part 91, a Substantial Amendment is required when there is a deletion of a current activity and/or creation of a new activity.

**Proposed Amendment No. 1:** Amendment to the Annual Action Plan (APP) 2023-2024: The City of Edinburg is proposing to delete an activity from the Annual Action Plan 2023-2024. The City is proposing to delete the Sidewalk Improvement Project and fund a previously approved Secondary Project in the FY 2023-2024 AAP. A Secondary Project is initiated in the event that a primary project meets unforeseen obstacles to timely implement and expend appropriated funds. The City’s Citizen Participation Plan states that a Secondary Project shall not be considered a substantial amendment to the City’s Plan because all citizen participation and environmental requirements were met during the development of the Annual Action Plan. The approved Secondary Project known as the Personal Protective Equipment Project, will allow for the purchase of structural firefighting gear that includes jacket and pant ensemble. This gear will replace outdated or damaged gear for Edinburg Fire Department firefighters. This project will benefit numerous areas of the City and approximately 66,705 beneficiaries.
