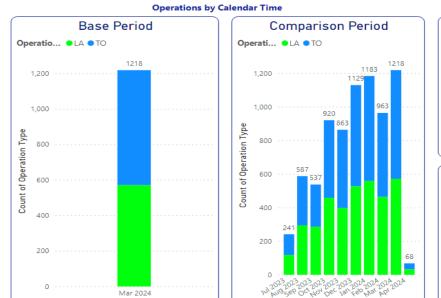


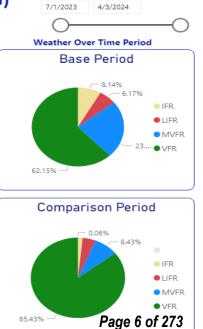

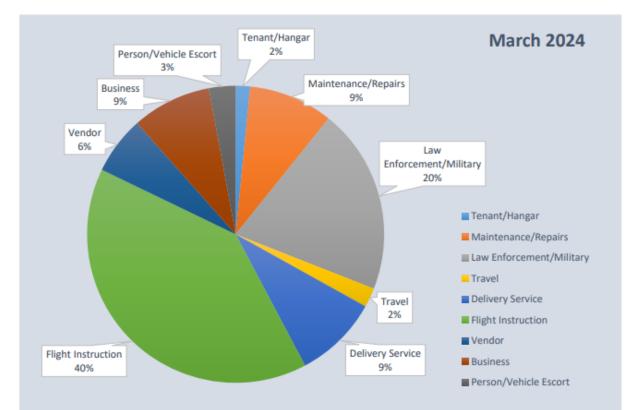

#### **GRANTS AWARDED**

- Office of the Governor FY 2023 Operation Stonegarden Grant
  - Grant application was submitted on Feb. 9, 2024. Grant was awarded on March 1, 2024 in the amount of \$340,000, with no local match, to fund overtime for police officers. Overtime funds will be used to enhance patrols along the Interstate 69C corridor in an effort to disrupt the trafficking of persons, drugs and weapons smuggled into and through Texas from Mexico. Additionally, patrols will be increased in feeder roads connected to IH69C throughout Edinburg to disrupt and deter operations of local gangs, transnational gangs and Mexican cartel criminal organizations.

#### • FY 2024 Community Project Funding

 Grant application was submitted on Feb. 16, 2023 and the City received an unofficial award announcement on March 11, 2024 from Truman Reed, from Congresswoman Monica De La Cruz's Office. The Lift Station No. 19 Force Main Realignment and Sanitary Sewer Improvements Project will be fully funded in the amount of \$1,394,655 through the 2024 Consolidated Appropriations package that was signed by President Biden on March 8. Out of the 15 projects Rep. De La Cruz recommended for funding, 12 were included in the package, and six were fully funded (including the Lift Station No. 19 Project). Project consists of rerouting the force main from Lift Station 19 and installing first time gravity sanitary sewer for properties along Rogers Road, from I69C to M Road. Grant application was submitted on March 16, 2023. The next steps will be to wait for the funding agency to provide the grant award agreement.

## • FY 2024 All-America City Award Finalist

 Application was submitted on February 13, 2024. The City was named one of 20 2024 All-America City Finalists on March 15, 2024. Of those selected as finalists, only three were from Texas (including Edinburg). Next steps include preparing a 10-minute presentation before the All-America City Jury which will take place in person in Denver, Colorado from June 7-9, 2024. The Grants Administration, Library, Parks and Recreation, Communications and Media, and City Manager's Departments will meet April 1 to review the Finalist package and award materials.

# **GRANTS SUBMITTED**

- Federal Emergency Management Agency's (FEMA) FY 2023 Assistance to Firefighters Grant (AFG) Program
  - Grant application was submitted on March 7, 2024. The Fire Department requested approximately \$100,000 with an approximate 10% match of \$10,000 for a total project cost of approximately \$110,000. This project will fund two overhead sprinkler systems to be installed at Central Station and Fire Station 3. Funds will cover the costs for equipment and installation. Awards will be made beginning in the summer of 2024 on a rolling basis until all funds have been awarded, no later than Sept. 30.
- FY 2025 Community Project Funding (CPF) Appropriations
  - Grant application was submitted on March 8, 2024. The Utilities Department requested approximately \$3.6 million, with a required minimum 20% match of approximately \$900,000, for a total project cost of approximately \$4,500,000. The match requirement may vary upon review of the project selected. This project will fund a National Environmental Laboratory Accreditation Program (NELAP) Certified Lab Project that will allow the City to construct an internal accredited NELAP certified lab to conduct water quality analysis that would otherwise be outsourced. Award notification is anticipated by Fall 2024.
- Office of the Governor's (OOG) FY 2025 Local Border Security Program (LBSP) Grant
  - Grant application was submitted on March 14, 2024. The Police Department requested approximately \$401,132.16 with no matching funds required. This project will fund overtime costs to implement increased patrol and investigative capacities to meet the program goals of the LBSP Program. Award notification is anticipated by the Summer 2024.
- Office of the Governor's (OOG) FY 2025 State and Local Cybersecurity Grant Program (SLCGP) Mitigation Projects
  - Grant application was submitted on March 14, 2024. The Information Technology Department requested approximately \$305,629.37, with a required 10% local match of \$33,958.82 for a total project cost of approximately \$339,588.19. This project will replace all twenty-four (24) end-of-life network switches with updated models. Additionally, this project aims to upgrade twelve (12) outdated voice gateways with modern versions that feature improved security features that will

reduce the risk of cyber threats to the City's telecommunications system. Award notification is anticipated by the Summer 2024.

- Office of the Governor's (OOG) FY 2025 Border Zone Fire Department (BZFD) Grant
  - Grant application was submitted on March 14, 2024. The Fire Department requested approximately \$100,000 with no local match required. This project will provide funds for a mobile cascade system to be utilized during emergency regional response. Award notification is anticipated by the Summer 2024.

## **REQUEST FOR INFORMATION (RFI)**

- RFI submitted for the following grants:
  - Office of the Governor's (OOG) FY 2025 General Victim Assistance Grant
    - Grant application was submitted on Feb. 8, 2024. The Police Department requested approximately \$33,955, with a 20% match of \$8,489, for an approximate total project cost of \$42,444. This project will continue funding the salary and fringe benefits of the Crime Victim Liaison position for another one-year period for FY 2024-2025. On March 11, the OOG requested a volunteer waiver. Requested information submitted on March 19, 2024.
  - o Office of the Governor's (OOG) FY 2025 Criminal Justice Grant
    - Grant application was submitted on Feb. 8, 2024. The Police Department requested approximately \$140,000, with no local match required, to fund the purchase of two digital message boards and two surveillance trailers and associated accessories. On March 11, the OOG requested specifics about the purpose of the surveillance trailers. The requested information was submitted on March 22, 2024.
  - o Office of the Governor's (OOG) FY 2025 Bullet-Resistant Shield Grant
    - Grant application was submitted on Feb. 8, 2024. The Police Department requested approximately \$219,936, with no local match required, to fund 35 additional NIJ Level III bullet-resistant shields for investigators in the field that can report to active shooter events. On Match 11, the OOG requested the name of the manufacturer for the items being requested. EPD aims to use the WCCTV surveillance trailers as an investigative and deterrent tool for criminal activity in neighborhoods, highways, and special events. The requested information was submitted on March 22, 2024.
  - o Office of the Governor's (OOG) FY 2025 Violence Against Women Justice and Training Grant
    - Grant application was submitted on Feb. 8, 2024 for approximately \$17,500, with a 30% match of \$7,500, for an approximate total cost of \$25,000. This grant will fund overtime costs for four existing Rape Aggression Defense (R.A.D) trained police officers to provide R.A.D training to women in the community and to send four additional officers to an out-of-state R.A.D training certification course. On March 11, OOG requested a budget revision regarding officers' total annual salary, including fringe, which was added to each budget line item. The requested information was submitted on March 22, 2024.
  - First Responder Mental Health Grant
    - Grant application was submitted on Feb. 8, 2024. The Police Department requested approximately \$40,000, with a 20% match of \$10,000, for an approximate total project

cost of \$50,000. This project will fund the continuation of previous mental health programs for peace officers by offering counseling sessions and alternative therapy such as yoga classes, kickboxing, etc. On March 25, the OOG requested additional information on the type of activity that will be performed during traditional counseling sessions and requested the names of the organizations that will provide the requested services. Additionally, the OOG requested a detailed list of supplies being requested. A response is being developed and will be submitted by the deadline of April 4, 2024.

### **GRANTS/APPLICATIONS UNDER REVIEW AND DEVELOPMENT**

- FY 2024 Law Enforcement Mental Health and Wellness Act Implementation Project Grant
  - This grant funds projects that aim to improve the delivery of and access to mental health and wellness services for law enforcement officers and their families through the implementation of peer support, training, family resources, suicide prevention, and other promising practices for wellness programs. The maximum award is \$200,000 and has no local match requirement. A grant opportunity form was sent to the Police Department on March 25 and an initial grant meeting was held on March 27 to discuss potential projects. Upon discussion, the Police Department requested additional time to develop a potential project and a follow up meeting is scheduled on April 2. The grant deadline is April 24, 2024.
- US Department of Energy's FY 2023 Energy Efficiency and Conservation Block Grant (EECBG)
  - Grant development continues. This grant funds energy efficiency improvements that maximize benefits for local and regional communities for a variety of projects, such as developing a clean energy strategy, making buildings more energy-efficient, etc. Because Edinburg's population is over 35,000, the City is eligible to apply for a formula grant. Based on population, the City is eligible to apply for a grant of \$153,020, with no local match required. Initial grant development meetings began in summer 2023 and have been ongoing. On Oct. 17, 2023, the Engineering Department identified a need for an Energy Action Plan. An energy and conservation master plan will be beneficial for future grant opportunities, and is also a required grant deliverable within one year of award. On March 15, 2024, a meeting was held to review the selected project and required application components. A follow-up grant development meeting was held on March 22. The Engineering Department will be the implementing department and weekly meetings are set up for grant development. The Engineering Department is in the process of completing the Pre-Award Grant Stakeholder Approval form by the next meeting to be held on April 2. The application deadline (Step 2 of 2) is April 30, 2024.
- USDOT Innovative Finance and Asset Concession Grant
  - This grant has two types of grants available which include 1) Technical Assistance Grants that will be awarded to build organizational capacity to develop, review, or enter into asset concessions to advance TIFIA-eligible projects; and 2) Expert Services Grants that will be awarded for project development of identified assets, including hiring professional services to explore opportunities for leverage. Grants Administration staff attended an information webinar on March 21, 2024. More information will be provided upon further review of the solicitation. Application deadline is May 10, 2024.
- US Department of the Interior Bureau of Reclamation FY 2024 Planning and Project Design Grant

- This grant combines 3 grant programs into 1 solicitation that will accept applications for FY 2023 and FY 2024 funding. This grant funds collaborative planning and design projects to support water management improvements. This includes funding for: (1) Water Strategy Grants to conduct planning activities to improve water supplies; (2) Project Design Grants to conduct project-specific design for projects to improve water management; and (3) comprehensive Drought Contingency Plans. All grant types have a 3-year performance period. The Grant Opportunity Form was sent to the Utilities Department on Nov. 30, 2023. A meeting was held on Dec. 14, 2023 with the Utilities Department, Grants Administration Department, and the Bureau of Reclamation to discuss the project for the planning of a new brackish (groundwater) water treatment plant to determine which of the 3 programs is the best fit, and to confirm cost-share requirements. Based on this meeting, this project falls under the Water Strategy Grant category and will have a 50% match requirement. Water Strategy and Project Design grants have a minimum award of \$100,000 and maximum award of \$400,000. Grants Administration staff sent follow-up email to Utilities to regroup and determine if Utilities is still interested in pursuing this grant on March 26 and April 4. The grant deadline is May 21, 2024.
- Bureau of Reclamation's (BOR) FY 2024 & 2025 WaterSMART Grant: Small-Scale Water Efficiency Projects Grant
  - This grant funds projects that conserve, better manage, or otherwise make more efficient use of water supplies. The City is eligible to apply for up to \$100,000 and have a 50 % local match requirement. The City currently has an active Small-Scale Water Efficiency Project that is funding 500 smart water meters and is pending a \$100,000 match. The period of performance for the current project ends in March 2025. A Grant Opportunity Form is in development and more information will be provided upon further review. This grant has three deadlines which are July 9, 2024; January 14, 2025; and July 8, 2025.
- USDOT FY 2024 Safe Streets and Roads for All Grant
  - This grant funds projects that support planning, infrastructure, behavioral, and operational initiatives to prevent death and serious injury on roads and streets involving all roadway users, including pedestrians; bicyclists; public transportation, personal conveyance, and micromobility users; motorists; and commercial vehicle operators. Under this program, we can apply for either an Action Plan Grant (planning grant) or an Implementation Grant (construction grant, if there is an Action Plan in place). Planning grant awards will range between \$100,000 to \$10M. The City provided a letter of support to the RGVMPO for their FY 2022 funding cycle application, which was awarded to develop a regional Action Plan that the City of Edinburg will take part in. On March 22, the Grants Administration Department had a meeting with the RGVMPO for an update on the current status and timeline of the FY 2022 grant. The RGVMPO is currently assembling regional partners for their project to begin development of the regional action plan, which would make us eligible to apply for an Implementation Grant under the FY 2024 Safe Streets and Roads for All Grant funding cycle. Based on the RGVMPO's timeline, the City is eligible to apply for this grant by the August 29, 2024 deadline.
- WaterSMART Large-Scale Water Recycling Program
  - This grant funds the planning, design, and construction of Large-Scale Water Recycling Projects.
     Maximum award size is \$180M and has a 75% local match requirement. The grant solicitation is under review and more information will be provided upon further review of the solicitation. A

Grant Opportunity will be developed and shared with the Utilities Department when completed. Application deadline is September 30, 2024.

- US Department of Transportation's (USDOT) FY 2023 and FY 2024 Bridge Investment Program Grant
  - This grant funds planning and construction activities that improve the condition of bridges in poor 0 condition and supporting activities to prevent bridges in fair condition from dropping to poor condition within the next three years, as determined by the USDOT's National Bridge Inventory (NBI). Six (6) bridges in Edinburg are in fair condition, as per the NBI. The USDOT opened the application period for this grant on Dec. 21. Award amounts range from \$2.5 million to \$100 million. A 20% match is required. A Grant Opportunity Form was sent to the Engineering Department on Jan. 2, 2024 and a preliminary grant development meeting was held on Jan. 9, 2024. The Sprague and Schunior bridges were identified as eligible projects. However, based on feedback received from the DOT and Local Infrastructure Hub, it was determined that an application for this grant will be submitted for the following FY 2025 Bridge Investment Program Grant cycle so that there is sufficient time for the Engineering Department to obtain a consultant to work on the required preliminary engineering and the required benefit cost analysis. This will in turn help leverage an application for the complete street conversion of Sprague Street to be applied for under the FY 2026 Rebuilding American Infrastructure with Sustainability and Equity (RAISE) Grant. The FY 2025 Bridge Investment Program Grant cycle deadline is Nov. 1, 2024.
- EDA's FY 2023 Public Works and Economic Adjustment Assistance Grant
  - This grant funds investments to address communities' and regions' economic development needs 0 from planning and technical assistance to construction of infrastructure. Through the primarily construction-oriented Public Works program, EDA provides catalytic investments to help distressed communities build, design, or engineer critical infrastructure and facilities that will help implement regional development strategies and advance bottom-up economic development goals to promote regional prosperity. Through the Economic Adjustment Assistance (EAA) program, EDA provides investments that support a wide range of construction and nonconstruction activities in regions experiencing adverse economic changes that may occur suddenly or over time. Supported activities include construction and non-construction such as sectoral partnerships for workforce training, design and engineering, technical assistance, economic recovery strategies, etc. The match will be 20% generally. In the past, the average size of a Public Works investment has been approximately \$1.4 million. In FY 2023, EDA expects investments ranging from \$600,000 to \$5 million. The average size of an EAA investment has been approximately \$650,000, and EDA expects to make investments ranging from \$150,000 to \$2.5 million in FY 2023. Staff provided a Grant Opportunity Form to the EDC staff at a grant development meeting on July 20, 2023. Grants Administration and EDC staff regrouped on this grant opportunity on Sept. 28 to identify potential projects, specifically a workforce development center. The EDC staff will clarify the workforce development center's purpose with the Mayor and City Management, and provide an update so that the group can reconvene. A grant development meeting was set for Nov. 1 but was canceled that day due to the EDC's scheduling conflict. To follow up again, an email was sent to the EDC on Feb. 27 to advise when EDC staff is available to regroup and discuss this grant. A follow-up meeting was held on March 20, 2024 to revisit this grant and identify potential projects. Multiple projects were discussed which include the construction of an industrial park or a workforce resource center. On March 20 and March 28, 2024, the Grants Administration Department spoke to Robert Peche, the EDA's regional economic

development representative, and received guidance which helped develop the two-page overview that was sent to City Management on March 28, 2024. The grant has a rolling deadline until grant funds are expended.

- Texas GLO's Resilient Communities Program (RCP)
  - This grant funds the development, adoption, and implementation of modern and resilient building codes and flood damage prevention ordinances to ensure that structures built within the community can withstand future hazards. The City is eligible to apply for up to \$300,000. More information will be provided upon further review. This grant has a rolling deadline until all grant funds are expended.

#### **REFERENCE DEPARTMENT**

In March, library patrons utilized reference services to access the following services: 262 online catalog searches, 123 Interlibrary Loans, 1,774 copies, scans and faxes and 806 patrons requested computer assistance. Patrons used computers and wireless internet services 2,842 times during the month of March.

The library continues to offer adult and teen programs such as nutrition programs, arts & crafts, book club, writers club, citizenship and educational classes. In March 219, adults and 121 teens attended these programs while staff provided outreach services to 68 community members in Edinburg schools and City of Edinburg departments.

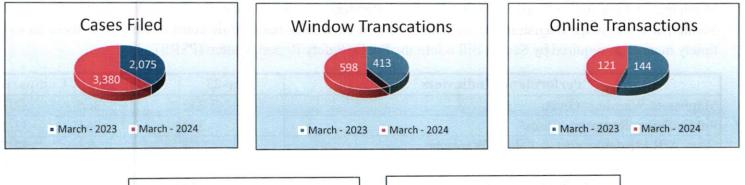


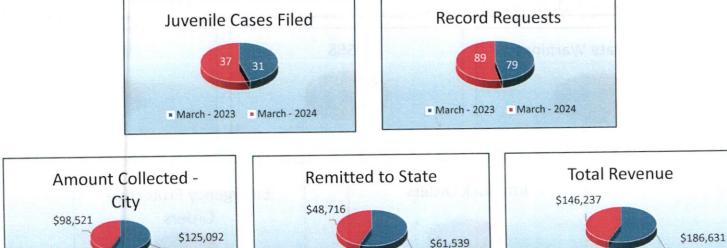

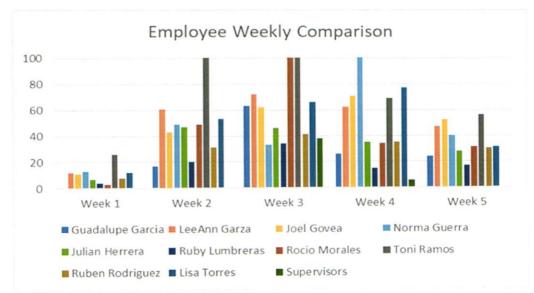

The responsibility of the court clerk's position and the scope of duties have greatly increased in recent years. Although court clerks do not have authority to exercise judicial discretion, they may carry out the duties that are legally delegated from the judge. The professionalism, timeliness, and accuracy of the court clerk's actions are important to the proper operation of the municipal court. As such, the court clerk can have tremendous impact on the perception of the justice system. The court clerk likely has more contact with individual defendants in municipal courts on a daily basis than the judge, prosecutor, or even law enforcement. Consequently, the public will develop a perception of municipal courts largely based on interactions with the court clerk.

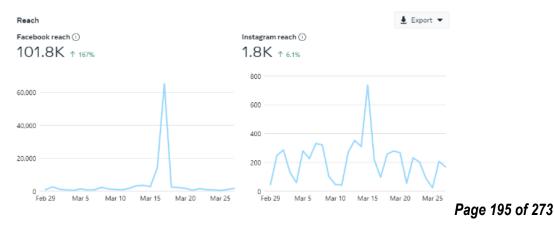


#### **SOCIAL MEDIA / OUTRECH**

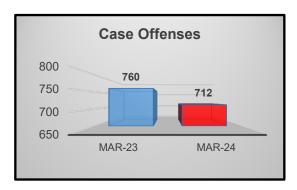

#### Hidalgo County Precinct 4 Commissioner Ellie Torres Breaks Ground on Mile 17 and 83rd Stormwater Project

Commissioner Ellie Torres of Hidalgo County Precinct 4 marked a significant milestone today as ground was broken on the Mile 17 and 83rd Stormwater Project. This transformative initiative, made possible through funding from the American Rescue Plan Act State and Local Fiscal Recovery Funds Program administered by the United States Department of Treasury, underscores the commitment to enhancing vital infrastructure within the precinct.

Commissioner Torres expressed her enthusiasm for the project, recognizing its critical role in addressing health disparities and bolstering stormwater infrastructure. "This groundbreaking marks the commencement of the 10th project out of 12 ARPA Stormwater Projects in Precinct 4," stated Commissioner Ellie Torres. "These initiatives are integral in our efforts to improve infrastructure and fortify drainage systems to prevent flooding in low-lying land."

The scope of the Mile 17 and 83rd Stormwater Project encompasses approximately 1,600 to 1,700 linear feet of an underground drainage system along Mile 17 and 83rd Street. The project also includes the installation of drainage inlets to collect water from streets, ensuring efficient flow into the main drain. Moreover, enhancements such as cleaning and widening of the main drain are incorporated to optimize stormwater management. Additionally, the project aims to establish connectivity from existing drainage in the subdivisions of San Carlos Acres and San Carlos Gardens to the main drain, fostering a comprehensive and interconnected stormwater network.

"The widening of the drainage ditch will allow more volume so water is removed from the neighborhoods into the ditch," said PE, Javier Hinojosa, Javier Hinojosa Engineering.

The Mile 17 and 83rd Stormwater Project represents a pivotal step forward in advancing the resilience and well-being of communities within Hidalgo County Precinct 4. Through strategic investments and collaborative efforts, Commissioner Torres is dedicated to creating a safer environment for all residents.

# Edinburg State of the City Address highlights remarkable progress and ambitious future plans



Experience Edinburg. That was the theme on March 7, 2024, when Mayor Ramiro Garza, Jr. delivered the Edinburg State of the City Address at the Region One Education Service Center. The address showcased the city's remarkable achievements in 2023 and outlined ambitious plans for the future. In his speech, Mayor Garza highlighted numerous key projects and initiatives that have propelled Edinburg forward. Economic development took center stage as construction activity soared to a historic \$397 million, marking a significant increase of \$103 million over 2022.

"As we proudly make history, our heads are held high, and the construction activity of \$397 million stands as the pinnacle achievement for our city," Mayor Garza said. "Our growth is downright explosive." Residential growth also experienced a boom, with 54 subdivisions recorded in 2023, including over 2,000 new lots. Mayor Garza announced that Edinburg is on track to surpass these numbers in 2024, with 145 active subdivisions currently under review or in the construction phase, expected to bring over 4,000 lots onto the market.

Furthermore, sales tax revenue hit an all-time high in Edinburg, with almost \$37 million collected in 2023, representing a 6.2% increase compared to 2022.

Mayor Garza also championed regionalism, highlighting the historic Rio Grande Valley Economic Summit and the establishment of the South Texas Alliance of Cities, which garnered national attention during President Joe Biden's recent visit to Brownsville.

"Our unity is the key to addressing the challenges of our rapidly growing region, and we've already seen the payoff of working together," the mayor said. "This push for a unified voice is now bringing us the national attention we deserve."

The address also acknowledged a 4.6% overall reduction in crime in the past year and honored beloved Fire Chief Shawn Snider with a moment of silence. Infrastructure developments totaling \$96 million were highlighted, including street and drainage improvements, park and trail upgrades, and public facilities enhancements.

"In Edinburg, we are not just talking about growth and success. We're making it happen," Mayor Garza said.

Exciting announcements included Edinburg being chosen as the home for UTRGV Vaqueros football games, marking a significant milestone for the city. Cultural arts events and fitness initiatives were also spotlighted, along with inclusivity efforts through the creation of an inclusivity task force. Looking ahead to 2024, Mayor Garza outlined ongoing projects such as the Ebony Hills Golf Course improvements, a new service center, and a major wastewater treatment plant expansion.

Mayor Garza concluded the address by expressing pride in Edinburg's explosive growth, emphasizing the city's diverse offerings ranging from Division 1 football to festivals and cultural events.

"We have so much in this Hometown of Heroes that sets us apart," Mayor Garza said. "Where else can you go to a semi-pro game, college game, high school game, a concert, or a festival all on the same night?

#### **Edinburg Police Department to** Launch 'Operation Safe Spring Break' Initiative

Program aims to reduce drunk driving throughout the holiday

Edinburg, TX - Throughout the course of 2023, the Edinburg Police Department made a total of 452 DWI arrests, six of which resulted in serious consequences leading to fatalities. This Spring Break, in collaboration with Mothers Against Drunk Driving (MADD) and local bars and restaurants, the Edinburg Police Department aims to decrease the number of potential impaired drivers getting behind the wheel and reduce the number of victims resulting from DWI incidents.

Through their Business Watch program and coordinated efforts, flyers containing QR codes will be distributed,



prompting citizens to access rideshare services such as Uber, Lyft, or taxi rides. Managers, bartenders, and servers will be briefed on Operation Safe Spring Break and encouraged to refer customers to the flyers.

The program runs from March 8-18. The Edinburg Police Department will establish High-Visibility Saturation Patrols to prevent, discourage, and intercept impaired drivers. These patrols will consist of patrol officers focusing on routes in areas where DWI arrests were prevalent, according to statistics from 2023.



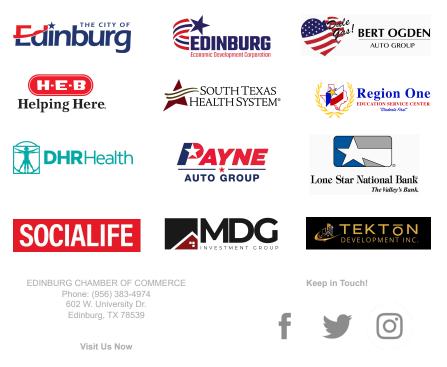

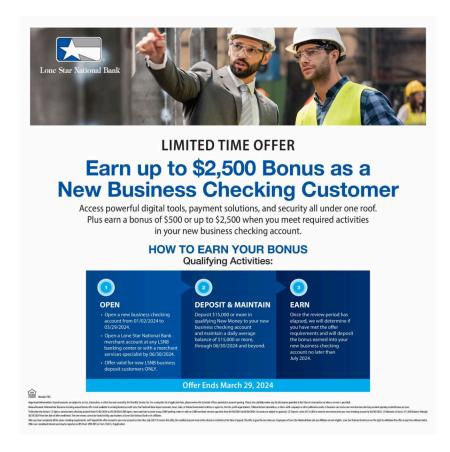

#### DEVELOPMENT

FRIENDships: Renewal notices were sent to those whose FRIENDships were due in March, past due from February and would be due in April 2024.

<u>Rentals:</u> There were two daytime rentals and two evening rentals in March.

<u>Heritage Associate Drive</u>: Since the report submitted for the March meeting of the Board of Trustees, two Heritage Associate Patron gifts have been received and one pledge at the Heritage Associate Patron level resulting in an additional \$7,500. We now are reporting a campaign total (paid & pledged) of \$411,858. Remember, we can continue throughout the year to identify prospects and secure new and renewed Heritage Associate support!

**Heritage Ranch Gala:** The 2024 HRG was held on Saturday, March 23, at La Morada del Viejo Ranch in Starr County with more than 400 guests, staff, and volunteers! Guests were greeted at the Horse Barn and offered a Prickly Pear cocktail and appetizers. The barn was filled with a framed invitations from the past galas to reinforce the 40<sup>th</sup> Anniversary of the Heritage Ranch Gala. Guests could take a turn spinning a wheel with the names of all the ranches where galas had been held. Once landing on a ranch name, the guest would then try and match the ranch to the ranch owner and year they hosted the event. If correct, the guest would win a drawing ticket. There were two prizes donated by the Museum Store. Guests were then shuttled to registration and invited to enter the Hunting Lodge and then out to the lakeside dining area. Ranch owners Joaquin and Lucia Spamer welcomed guests and were later presented with a framed gala invitation as a token of appreciation. Board Chairman Sam Garcia and CEO Francisco Guajardo spoke and were assisted by Development Committee Chairman Sabrina Walker-Hernandez.

Expenses for this event were higher due to the distance and rising costs. A breakdown of revenue and expenses is included in this report.

3. "Families and University Together as a Unit for Research and Education (FUTURE): Connecting Hispanic Families to Geosciences Through Community

Informal Learning Network": The goal of the proposed project, FUTURE (Families

and University Together as a Unit for Research and Education), is to test and examine an approach to stimulate Hispanic participation in geosciences by connecting families (parents and students/children) through an informal learning network (in geosciences). With the experience gained in a previous GEOPATHS project, the leadership team will expand and scale up the established platform and infrastructure of its existing program transforming the traditional Geoscience Learning Ecosystems (GLEs) while nurturing the Hispanic Geoscience workforce in a way that it can be expanded nationally. This project is for three years at \$2,500 per year. **\$2,500/0% (Per three years for a total of \$7,500)** 

4. Labeling History: A Look into the Ed Pease Collection of Packing Labels: \$5,130.00 This exhibition is a two-phase project. The first phase will produce an exhibit using archival materials that were donated by Carol Pease, the wife of the late creator Ed Pease. The exhibit will be on display at the museum as a Spotlight Exhibit, a term coined for temporary exhibits. The second phase will include contacting other museums, libraries, and businesses to offer the exhibit for display at their institution.

#### Grant Requests Not Awarded:

- Texas Travel Industry Recovery Grant Program Second Round: up to \$250,000 Businesses that previously applied for — and received — grants, can apply again to receive more funds if they qualify, minus the funds they received earlier. To qualify for the \$250,000 reimbursement, a business must document at least that amount in expenses, which may include payroll, rent, utilities and maintenance. (TTIR) was established by Senate Bill 8 during the 87th Legislature, Third Special Session, to administer \$180 million of funds received from the Coronavirus State Fiscal Recovery Fund, which was established under the American Rescue Plan Act of 2021. The purpose of TTIR is to provide grants for the recovery of Texas businesses in the tourism, travel, and hospitality industry that were negatively impacted due to COVID-19. TTIR will support the Texas tourism, travel, and hospitality industry by making grant funds available to businesses negatively impacted by COVID-19 to improve safety, customer service, and hospitality within their operations and further encourage travel and tourism industry recovery.
- 2. Lady Byrd Johnson Wildflower Center Seed Grant: \$500. Applied for a gift certificate to purchase native plant seeds from the Center. The seeds will be used to further sustain or expand the living collection of native plants in Legacy Park. The condition is that the museum would provide identification and interpretation of these plants for visitors.

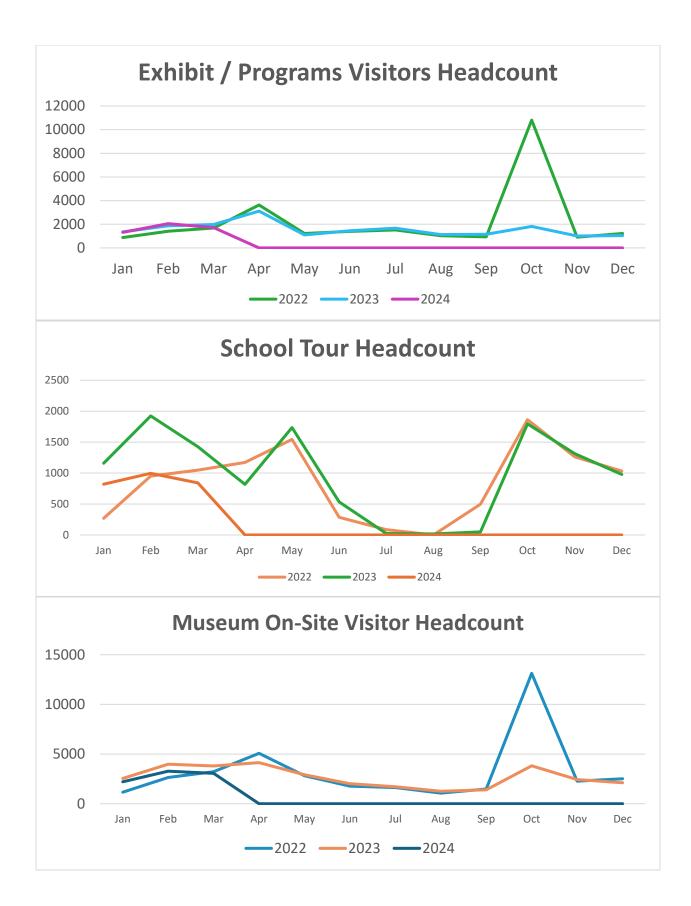

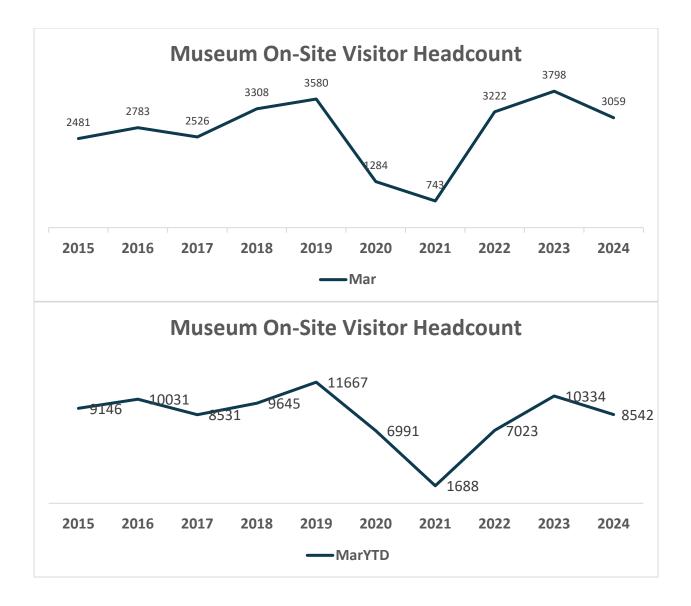
The museum's overall attendance for the month of March was 83% when compared to prior year attendance.

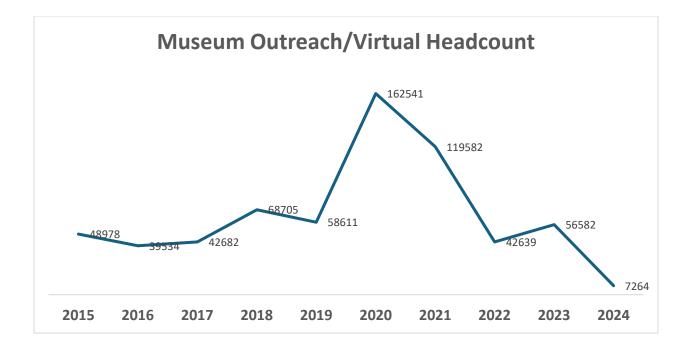
Museum store revenues for March were 74% versus 2022. Museum store revenue was 101% versus budget in March.

#### **Balance Sheet:**

Working capital (excluding operating reserves) was \$1,089K, a decrease of \$69K since 3/31/2024. More specifically, \$942K of the working capital assets were unrestricted cash-in-bank. The current liability as of 3/31 was \$152K. The quick ratio (excluding operating reserves) is 8:1.

Investments in the Museum's Operating Reserve market value increased in March by \$3K. The portfolio recognized actual realized gains/(losses) of \$0K in March. Investments in our Endowment Fund increased in market value by \$79K in March. There were 10 sales transactions in our Endowment's portfolio during March resulting in actual realized gains/(losses) of \$22K.

#### <u> P&L (YTD):</u>

The March P&L reflects a net surplus of \$154K, a \$39K favorable variance. Revenues, net of the non-cash in-kind contribution line item, are favorable by \$32K. Favorable line items are Fundraising revenues \$8K, HA FRIENDSHIPS \$27K, and Refunds & Reimbursements \$3K. Unfavorable line items are Student fees \$7K.

On the expense side of the equation, the favorable expense variance of \$5K consists of a mixed bag of line items. The most notable favorable variances are Advertising \$1K, Wages (and related costs) \$10K and Utilities \$2K. Unfavorable variances are Programming \$1K and Fundraising expenses \$3K.
