

Brennaaleen Cedar Drainage Proje Phase 2	The drainage project will increase additional detention volume and provide relief to Brennaaleen Park, Cedar Heights, and Greenbriar Subdivisions. The construction of the project will occur in two phases. Phase I consists of a 120-linear foot bore and a 48-inch storm sewer connection to the proposed detention pond. The detention pond will ultimately discharged into the drainage canal that runs parallel to Freddy Gonzalez Drive. A proposed 15-foot drainage easement will be acquired to allow for adequate conveyance of stormwater from the Greenbriar Subdivision. This will help mitigate the flooding within the Greenbriar Subdivision. Phase II consists of reclaiming the paving on Cedar Street from Freddy Gonzalez north to the cul-de-sac and Cynthia Drive from Freddy Gonzalez Drive to north to Cedar Street. The drainage infrastructure within the Cedar Heights and Greenbriar Subdivision will be replaced with new drainage infrastructure according to the latest City of Edinburg's Standards Manual to reduce street flooding.
