

Genesee County Senior Millage Telephone Intake and Screening Program: This service through Valley Area Agency on Aging provides screening for all seniors to mainstream and utilize all programs and services available to seniors in Genesee County. To start the process and see what services you or your loved one may be eligible for please call **(810) 249-6531**.

Adult Day Care: Adult day care is provided to senior citizens who are functionally and/or cognitively impaired. Social activities and specialized support services are offered. (Michigan Community Services, Inc.)

Case Management & Assessment Services: Each assessment is a comprehensive evaluation. The need for different types of services is assessed and a coordinated care plan is developed. (Valley Area Agency on Aging)

Confidential shredding and recycling events: Free, safe, and contact-free shredding and recycling drive-thru events throughout the year at local senior centers.

Elder Abuse & Exploitation Prevention: The EAP detectives investigate suspected abuse, neglect, or financial exploitation cases.

Guardianships/Conservatorships: Genesee County Probate Court appointed professional guardians to act as guardians/conservators for seniors. Services include managing the senior's personal needs, estates, and other assets for the individual's best interests. (Family Service Agency)

Home-Delivered Meals: Genesee County Community Action Resource Department (GCCARD) is providing home-delivered meals to senior citizens 60 years of age and older who have qualified through an assessment for this service.

In-Home Personal Care and Homemaking Services: Aids with activities that may include bathing, dressing, grooming, toileting,

transferring, and other assistance. In addition, domestic tasks such as housekeeping, laundry, and meal preparation are provided. Seniors must be assessed to demonstrate the need for these types of services. (Alternative Elderly Care and Family Service Agency)

In-Home Respite Services: These services are designed to provide care to seniors who have been assessed as requiring continual supervision within their homes. This enables their regular caregiver to have some reprieve. (Michigan Community Services, Inc.)

Legal Services: Elder law attorneys and paralegals provide legal advice and counseling at seniors' homes, senior centers, nursing homes, and/or other long-term care facilities. Legal Services of Eastern Michigan

Medical Transportation with Liaison: Providing transportation for Genesee County seniors aged 60 years or older to medical appointments and procedures with a liaison. Liaison services include help from the home to the car, transport to appointments and outpatient procedures, remaining present through the appointment/procedure, and post-appointment prescription pick-up/errands.

Lawn Care and Snow Removal: Residential lawn mowing and edging spring and fall clean up. Snow removal from residential driveways, front porches, and walkways during the winter season. (St. Luke's NEW life Center)

Senior Centers: There are 16 senior centers in Genesee County that are fully or partially funded by the Genesee County Senior Millage.

Senior Millage Ramp Program: Genesee County contracts with The Disability Network to provide temporary and permanent ramps to seniors in Genesee County. The Disability Network **(810) 742-1800 x315**

Senior Project Fresh: The Behavioral and Physical Health and Aging Services Administration (BPHASA) makes available for distribution the “Senior Project Fresh” coupons. Each year, coupons will be distributed by June 1st until September 30th. Coupons are redeemable between June 1st and October 31st of each year. Visual and Hearing Impairment Programs: Teaching skills to navigate deafness, blindness, hearing, and vision loss using adaptive techniques and devices. Providing individual and group therapy options for clients, family, and friends. Education and outreach in the community.

ASL Interpreter services: with CACHDD for Genesee County-Flint deaf senior citizens group.
