A RESOLUTION OF THE BOARD OF SELECTMEN FOR THE TOWN OF GEORGETOWN, COLORADO SUMMARIZING EXPENDITURES AND REVENUES FOR EACH FUND, AND ADOPTING A BUDGET FOR THE TOWN OF GEORGETOWN, COLORADO, FOR THE CALENDAR YEAR BEGINNING ON THE FIRST DAY OF JANUARY 2022 AND ENDING ON THE LAST DAY OF DECEMBER 2022

WHEREAS, the Town Treasurer and the Interim Town Administrator, after direction and input from the Board of Selectmen and public, have prepared a proposed Fiscal Year 2022 Budget for adoption by the Town; and

WHEREAS, the Town Treasurer submitted a proposed budget to this governing body on October 14, 2021 for its consideration; and

WHEREAS, upon due and proper notice, published and posted in accordance with applicable law, said proposed budget was open for inspection by the public at a public hearing held on November 23, 2021 and interested taxpayers were given the opportunity to file or register any objections to said budget; and

WHEREAS, whatever increases may have been made in expenditures, like increases were added to the revenues or planned to be expended from reserve/fund balances so that the budget remains in balance, as required by law; and

WHEREAS, the governing body considered any additional objections received at or before the hearing for adoption of the budget; and

WHEREAS, the Board of Selectmen wishes to adopt the proposed budget for the fiscal year 2022.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF SELECTMEN FOR GEORGETOWN, COLORADO, as follows:

Section One

That the 2022 Budget of the Town of Georgetown, as presented by the Interim Town Administrator and Town Treasurer and amended up to the date of this resolution, shall be and is hereby adopted as the official budget for the fiscal year of 2022;

Section Two

The adoption of the 2022 Budget, by this resolution, shall and does hereby constitute the basis for appropriation, by resolution, of the several sums specifies therein as expenditures from the various funds and of the total such expenditures;

Section Three

That the budget as submitted and thereafter amended is hereby approved and adopted as the budget of the Town of Georgetown for the year stated above; and

Section Four

That the budget is hereby approved and adopted, shall be signed by the Police Judge and made a part of the public records of the Town of Georgetown, Colorado.
