That the required monuments and lot markers have been located in the ground, as required by Section 125 of the Act.

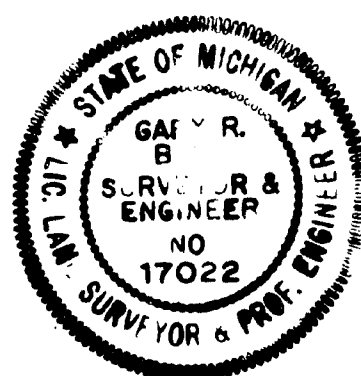
