### MOTION TO OPEN TO PUBLIC COMMENT:

<u>Dawn Santillo – 4 Glenn Court</u> – Wigwam Brook runs behind her house. There was a major flood in 2005 that caused deterioration to her property. Every time there is heavy rain her property deteriorates even more. Neighbors are throwing wood and debris into the brook. The town needs to take action. What are the towns plans?

Adam Bushman – 280 Gatzmer Avenue – Mr. Bushman is a past Councilmember. He never had flooding in his house until after the Costco warehouse was built. He has flooded 5 times since then. He can't use his pool cause fish from Costco's retention pond are floating in it. All the construction being done on Cranbury Road causes the water to go downhill to Gatzmer Avenue. What can the elected body do?

<u>Donald Kall – 16 Prospect Street</u> – In 2005 the damn behind Prospect Street collapsed and nothing has been done about it. The last 2 storms we had are eroding his property. Who is responsible for this property? The creek is full of debris and garbage. I would like help from the town.

<u>Daniel – 275 Gatzmer Avenue</u> – Lived in this town for over 40 years, never had a problem with flooding. Since the Costco warehouse was built 20 years ago, we flooded 3-5 times. The drainage ditches from Costco have never been cleaned. Who is responsible? Jamesburg or Monroe?

<u>Barbara Bushman – 280 Gatzmer Avenue</u> –Ms. Bushman asked "Why are we still building in Jamesburg?" Life Storage is putting up a 3-story building.

Councilmember Rutsky explained the Land Use Board originally voted down Life Storage. We were then threatened with a law suit.

Mayor Lowande explained she has been to meetings in other towns to address these drainage issues.

<u>Rodolfo Ptasnik – 3 Glenn Court</u> – Mr. Ptasnik asked "whose job is it to clean the brook? What are we going to do about it?" there is a lot of litter in the creek.

<u>John Santillo – 4 Glenn Court</u> – Garbsge and plywood are blocking the passage way. Where is all this coming from? Storm grate are blocked up.

Ripple Avenue is a paper road that the town owns, it needs to be cleaned up. What can Jamesburg do?

<u>Peter Becker – Owner of 4 Boys Ice Cream</u> – Henri was not declared a disaster; Ida made our situation worse. Is FEMA available for Ida?

Mayor Lowande explained you can apply for FEMA. There are rules to follow.

**WHEREAS**, the Mayor and Borough Council have determined that <u>further</u> revisions are necessary to the 2021 Salary Ordinance in order to effectuate certain staffing changes within the Borough's administrative offices.

**NOW, THEREFORE, BE IT ORDAINED**, by the Mayor and Council of the Borough of Jamesburg, in the County of Middlesex and State of New Jersey, that Ordinance #02-21, as adopted on February 17, 2021, and amended on August 18, 2021, is hereby <u>further</u> amended and revised in the following limited respects (additions are shown with <u>underline</u>; deletions are shown with <u>strikeout</u>):

WHEREAS, the Combined Land Use Board (the "Board") of the Borough of Jamesburg (the "Borough") adopted Resolution #08-17 (the "Resolution") on March 9, 2017, which granted preliminary and final major site plan approval with variances to permit the conversion of the existing post office building located at 13 East Railroad Avenue, more commonly known and designated as Block 28, Lot 2.05 on the Official Tax Map of the Borough (the "property"), to a mixed-use facility involving both post office and laundromat spaces (the "project"); and

WHEREAS, the Resolution (at Condition No. 9 thereof) requires the applicant/property owner (DTMT, LLC) to post performance and maintenance bonds or guarantees in amounts determined to be appropriate by the Borough Engineer; and

WHEREAS, on November 18, 2020, the Borough Engineer prepared and forwarded a Bond Estimate to the applicant/property owner; and

WHEREAS, the Bond Estimate requires the posting of a 90% surety guarantee in the amount of \$64,746.00, along with the posting of a 10% cash guarantee in the amount of \$7,194.00, representing the total performance guarantee required pursuant to the New Jersey Municipal Land Use Law (N.J.S.A. 40:55D-1, et seq.) (the "MLUL") and per municipal ordinance of the Borough; and

WHEREAS, the Bond Estimate also requires the posting of escrow funding in the amount of \$2,997.49 with the Borough, which is also required pursuant to the MLUL and per municipal ordinance; and

WHEREAS, the applicant/property owner has provided a proposed Performance Surety Bond issued by United States Fire Insurance Company (Bond No. 6213009024) in the amount of \$64,746.00 relating to the project; and

WHEREAS, the Borough Attorney has reviewed and approved the form and substance of the proposed Performance Surety Bond, confirming that the Bond is sufficient and adequately protects the interests of the Borough; and

WHEREAS, a copy of the Performance Surety Bond is attached hereto and made a part hereof.

NOW, THEREFORE, BE AND IT IS HEREBY RESOLVED, by the Borough Council of the Borough of Jamesburg, in the County of Middlesex and State of New Jersey, as follows:

• FINANCE COMMITTEE Council Member Rampacek

#### Finance Report:

First, I'd like to welcome Michael to our town and I am looking forward to working with you in the future. The chapter 159 we voted on tonight was the \$308,000 American rescue plan money that we got from the federal government. It came after the budget was adopted which is why we have to do a separate resolution. \$125,000 out of this has already been appropriated as anticipated revenue to support this year's budget, so our remaining balance is \$183,000, which may need to be used to support next year's budget.

### Library Report:

The library had some significant damage from our previous storms. They have some asbestos abatement and mold remediation procedures that need to be done. They are renting a storage pod, as well as a dumpster, to store the books and get rid of the damaged materials. If anyone is available sometime next week to help move books from the library basement to the storage pod, please contact myself or the library and your help would be greatly appreciated.

# • EDUCATION COMMITTEE Council Member Shaughnessy

Jamesburg Students are back in school. 100 percent of students, full time, five days a week. That's 460 students and 85 teachers between the two schools. There are 8 new teachers introduced, and many of those teachers are returning after being hired full time following long term substitute placements. This shows that they are getting their experience, and staying here. So, we've got these new teachers, but they're coming in with experience and providing consistency.

There have been several events since the start of school on September 8<sup>th</sup>. We had a tremendously successful Food Truck Event, and having all of the school administrators and so many teachers made it a great community event, one we needed after so much time apart. There was a Popsicles on the Playground event on the following night, and we look forward to the next events for our children and for residents of all ages, including the Fire Safety Event on October 9<sup>th</sup>, and Halloween, which will be a multi-day event, with collaboration between the school, the borough and the PTA. We look forward to that celebration.

Drop-off and pick-up procedures are the same as they have been, all students are masked, and visitors are limited, in continuing efforts to keep students and staff safe and healthy.

Further evidence that we are returning to some semblance of normal is that GMB middle school will be fielding a boys and girls soccer team. We look forward to seeing them out on the field, and we look forward to a great school year.

### • POLICE COMMITTEE

Council President Sussman

Welcome Michael I look forward to utilizing your extensive knowledge.

First, I would like to thank all the first responders, the Mayor and Council and all the other generous volunteer who helped all those e in need due to the 2 storms that flooded. Unfortunately, the police department took a big hit at headquarters with flooding, mold and loss of records. The Chief has been working diligently to have vendors prepare the First Aid building as the temporary police department, as well as getting an estimate for other police necessities.

I had the opportunity with Councilwoman Ludas to visit businesses affected by the flooding. We spoke about up-to-date information regarding local, county and state assistance, as well as FEMA information. We were impressed with many businesses and their resilience and commitment to re-open. Four Boys Ice Cream worked day and night to clean, replace and organize for a record re-opening. The Latin-American Grocery re-opened 3 days after being flooded. They lost inventory, generators and refrigeration equipment. We are currently getting the owner into used equipment and getting pricing for repairs. Unfortunately, a company charged her \$350 for an estimate but didn't provide her with documentation. In other police business, one of our full-time dispatchers resigned from her position. The department has interviewed 3 candidates. Chief decided on 1 full time and 1 part time dispatcher.

Last, but not least I want to congratulate Councilwoman Rutsky on the Food Truck Event. With the help of Sue Boulogne and others it was a real success. It was great to see the police department, fire department and DPW for participating and working the whole event.

# • PUBLIC WORKS COMMITTEE Council Member Rutsky

I'd like to begin my report by thanking all of our first responders along with our Mayor and Council and Borough employees for their response to both storms that descended on Jamesburg. Without their diligence and hard work things could have been even worse for our residents. As for residents that suffered damage and to the residents that lost everything, I am truly sorry. Our Mayor and Council have been and will continue to work to get the necessary assistance for Jamesburg.

As the DPW chair I would like to personally thank our supervisor Paul Intravartola, along with John, Jeff, and Guido. Their crew of four worked and responded for countless hours during the storm crisis. Their hard work has not gone unnoticed.

On another note, I would like to thank the Jamesburg Elks. They held a memorial event to honor the 20th Anniversary of 9/11. It was a moving ceremony and a beautiful tribute to our fallen fellow Americans. I along with Councilwoman Ludas was honored to attend.

I would also like to welcome our new BA, Michael. I look forward to working with you and I'm excited to see what's next for Jamesburg.

Lastly, I would like to thank the borough and all departments in Jamesburg including the Jamesburg Fire Department, Police Department, DPW along with my right-hand Clerk, Sue Boulogne for helping me put out, I think one of our most successful food truck events. Coupling it with the back-to-school season made it just that much better. I'd like to thank the Jamesburg Library the Teachers Association and the Jamesburg PTA for coming out in full force and supporting our event. The rain held off and the community came out. I've said it before, it takes a village and when we come together, good things happen.

I wish and easy fast for the Jewish members of our community.

### ENVIRONMENT/ GREEN COMMITTEE: Council Member Ludas

I want to begin my report by thanking everyone up here for their tireless work during storms Henri and Ida. I also want to thank Mr. Maresca who worked with utility companies in assisting businesses and residents in getting power restored in a timely fashion. Thank the Jamesburg Police, Fire, and OEM Departments for their work in coordinating rescue and evacuation efforts.

In August, 2011, Hurricane Irene hit Jamesburg which caused extensive flooding. 14 months later, Jamesburg DPW and the county Mosquito Control helped us clean out the Church Street Creek. Super Storm Sandy struck with 90-mile hour winds and rain which damaged power lines, and caused extensive power outages for several days. Once again, our waterways were cleared.

In 2015 we created the Jamesburg Environmental Commission and the Jamesburg Green Team. September 2015, the county had new ARGO vehicle, which is used to clear swampy areas, and cleared further debris from previous storms including dumpsters, outdoor grills, and various outdoor furniture. This was a huge concerted project with the county, Jamesburg DPW and Monroe DPW. All water projects the county assists us with must meet NJ DEP standards and regulations.

The Green Team and our DPW Team have worked continuously in maintaining clearings in the creek and brook areas. Mostly in the spring and fall. In 2019 Our Green Team, DPW, Monroe Green Team and the Watershed Institute cleared out the wooded area behind Green Acres Park, which connects to the Church Street Creek, as this will be utilized as a Nature Park. There were approximately 100 volunteers that day including Scout Troop 54. Over 2 tons of debris was removed from the area on that day.

In July 2020 a Rain Garden was installed at GMB School. Due to Covid restrictions we were limited to doing major projects, however, we did have creek clean ups.

In October 2020 Eagle Scout Devon Kennedy and his dad and crew cleared the Church Street Creek Entrance and constructed an entrance area, as well as lined a path along the creek.

In November 2020 logs were noticed falling into the Manalapan Brook behind the Buckelew House and was cleared by the county Mosquito Control and our DPW.

July 2021 was one of the wettest July's since 1975 with a rainfall record of 7.59. It is noted as the  $8^{th}$  wettest July's since weather records have been kept. Since 1958 the water runoff in Middlesex County has increased by 35%

In February 2021 Jamesburg Council passed a new storm water ordinance pertaining to new construction and home additions. I attended a Water Resource Authority Meeting on Monday. Several municipalities were affected with both Henri and Ida and the county is taking the flooding issues very seriously. I recommended the county re-establish the South County Flood Commission and they are looking into this. I spoke with Mosquito Control this afternoon for an update and they will be sending a drone from Thompson Park through Davoe Lake which will include all waterways in Monroe, Jamesburg, Helmetta and Spotswood. However, this must be done when leaves have fallen so there can be a clear view of blocked areas. They will inform us as to when this will be done.

Please refrain from sweeping or blowing grass cuttings in the street, as they get washed into the storm drains in our streets. Over time they build up and cause a damming effect in the drain which causes the drain to overflow. Storm drains should be clear of leaves, grass and debris. If there is a vacant lot behind your home and it is near a water way, please refrain from dumping there. We have an organized well maintained Recycling yard for this purpose. I have asked our lawn service to please blow the grass back onto the lawn as this acts as a mulch and reseeds itself.

### **Business Report**

Councilmember Sussman and I have been visiting businesses who were affected by the storms and providing them with information and updates on obtaining financial assistance. These business owners have done an amazing clean up on their stores. I would like to announce 4 Boys is now open daily regular hours, Senior Barber Shop will re-open by the end of September. Latina Americana is fully open; Johns Barber shop is open and Artisan Framers is open regular business hours. Ink Therapy is open for regular business hours and Iron Cycles reopened for this past Monday.

# • CHIEF OF POLICE Chief Craparotta

Headquarters was flooded with the recent storms. Thank you to DPW, OEM, Captain Ceras, Mayor and Council for all their assistance with shelters and food. There is mold and mildew in police headquarters. I am working with Michael on a temporary headquarters at the First Aid building.

Thank you for my appointment. It is my 5<sup>th</sup> day on the job.

# PUBLIC SAFETY COMMITTEE / RECREATION / COMMUNITY EVENTS: Mayor Marlene Lowande

Hurricane Info: Henri brought close to 9" of rain. The Dam at Thompson Park did its job. The county workers were there all night monitoring the situation and acted accordingly. We met that night with the County OEM and gave them a tour of the areas being effected by the water. We met again with the county OEM and they have agreed to help with identifying the problems we face and the mitigation of them. The areas will be Gatzmer Ave. area, Wigwam Pond area and the creek behind Church Street. They will use drone surveillance over the areas between Monroe, Jamesburg, Helmetta and Spotswood. The county mosquito control, DPW, OEM and the township DPW's will all be involved. It will take time and will be a huge undertaking but I am confident it will get done.

Unfortunately, IDA came soon after and the rest of the state experienced what we had just gone through and was making our situation worse. As soon as we can we will resume those talks and take action.

JPD HQ, Library and Basement at the Senior Center Flooded twice are among our many problems during the recent storms.

We had some water during Henri and more during IDA. We will be applying for help from FEMA.

HQ will be moving to the First Aid Building as a temporary fix. It will be Dispatch and the offices. All intakes will be done at other Police headquarters.

First Aid – At this time we are not able to meet the calls with just our volunteer squad. It was a slow progression of not having volunteers to fill 24 hours a day/7 days a week. It went to weeknight and weekends. Then, that was hard to cover. 2 years ago I asked some lifetime members to come back and try to get volunteers and keep the First Aid Squad going. A valiant effort has been made but like many towns with all volunteer squads we have found it hard to stay afloat. The squad still exists but it is time to have more than a mutual aid agreement and we will be pursuing a shared service agreement with Monroe Township for our EMS needs. They have been taking care of Jamesburg for a very long time and we appreciate every volunteer and EMT that has serviced our residents. There will be more to come and I will keep everyone informed as it is happening.
