

**CITY OF JOHNSON CITY**  
**FIREWORKS/PYROTECHNICS/FLAME EFFECTS PERMIT**  
*Information and Mandatory item Checklist*

The application must be fully completed and must include all secondary documents listed below in checklist with the non-refundable permit application fees **(\$10.00)**. By making this application, the applicant assumes personal responsibility for all information provided. It is the applicant's responsibility to see that the application is complete and correct. The proposed display must be considered and approved by the Johnson City Fire Department and Johnson City Police Department prior to application. The completed application must be submitted no less than twenty (20) days prior to the date of the event to the **Finance Department, Municipal and Safety Building, P.O. Box 2150, Johnson City, Tennessee 37605**.

A permit is valid only for a business(s) holding a current business license to perform displays or provide fireworks, pyrotechnical materials, or flame affects for displays. A permit approval is restricted to sites in compliance with current City of Johnson City building codes. The permit is valid for one (1) year from the date of issuance for one (1) outdoor firing location. Please note that such display shall be given under the joint supervision of the applicant and the Johnson City Police Department pursuant to Title 11, Section 139 of the Code of Johnson City, Tennessee. The operator must have a valid certification by the State of Tennessee pursuant to T.C.A. § 68-104-201, *et. seq.* Please be mindful that the City cannot provide legal advice, but we will do everything that we can to answer your questions to the extent possible.
