Motion was made by Council Member Arthurs and received a second by Council Member Stone to amend the agenda to add public forum and discussion on Artisan Out Post Building. **Motion carried unanimously.**

Motion was made by Council Member Stone received a second by Council Member Poston to approve the minutes from the April 5, April 20, April 26 and May 4 meetings. **Motion carried unanimously.**

PUBLIC COMMENTS:

Mr. Sammy Jones, 263 E Marion Street, asked what the status is on concerns with the drainage on his property, he asked Mayor Hanna if he showed the pictures to council, how much is it going to cost and the price that Mr. Smith got when he was here from the engineer that don't work for the city anymore, you got one from Columbia now. So, nothing has been done. Mayor Hanna stated that we don't have the funds allocated for this. Mr. Jones asked where is the money at.? Council Member Arthurs stated we are working on using the funds from the ARP funds, we haven't received yet from the Gov't., we have a second payment coming, we just don't have it yet. Mr. Jones asked if he got a lawyer if that might help. Council Member Arthurs asked to refresh his memory on, Mr. Jones stated William Kelley put a drain in between Wayne's house and Norman Edgeworth's, the drain works fine but the drain ain't low enough and Johnny talking about putting dirt in the back yard, that ain't going to do no good, water just stays there, I got that big building there that is going to rot the floor out. Council Member Arthurs states he went there in 2007 and looked at it and said he could fix it for \$60,000.00 but they never came to an agreement. He also stated that this needs to be a community issue not one house. Mr. Jones asked where is the money that the city is paying Mr. Smith coming from, council stated that comes from the CPST funds that is allocated for the Golf Course, and can't be spent anywhere else. William Kelley a former council member stated he and David Eaddy went over to Mr. Jones property and dug a drench from the back of Wayne's hose to the front of house going toward the school, there is a 2" line there old

cast iron from the 1939 and across the road is an 8" line that opens up into a big ditch, you can contact Lee Poston he does that kind of work and get a price and he can fix the problem.

Motion was made by Council Member Arthurs and a second by Council Member Poston to have the Artisan Outpost appraised for sale. **Motion carried unanimously.**

Motion was made by Council Member Arthurs and a second by Council Member Altman to accept First reading of the fiscal year 2022-2023 budget. **Motion carried unanimously.**

Motion was made by Council member Poston and received a second by Council member Arthurs to enter into executive session to discuss Personnel Matter Administrative matter 30-4-70(a)(1). **Motion carried unanimously.**

Motion was made by Council member Arthurs and received a second by Council member Khambhaita to enter back into open session. **Motion carried unanimously.**
