#### **RESOLUTION NO. 03 - 2023**

#### A RESOLUTION CREATING AN EIGHT MEMBER ADVISORY CITY SPIRIT COMMITTEE, DEFINING THE PURPOSE AND DUTIES OF THE COMMITTEE, AND PROVIDING FOR ITS ORGANIZATION AND PLAN OF OPERATION.

**WHEREAS,** Section 100.240 of the City's Code of Ordinances provides that, upon the Mayor's suggestion, the Board of Aldermen may establish an advisory committee;

WHEREAS, at the Mayor's suggestion, the Board of Aldermen has determined it to be in the best interest of the City of Kearney ("City") to establish a citizen body advisory committee to advise the Board of Aldermen regarding how the City may better encourage and nurture a safe, welcoming and supportive community atmosphere within the city limits of Kearney;

# BE IT RESOLVED BY THE BOARD OF ALDERMEN OF THE CITY OF KEARNEY, MISSOURI AS FOLLOWS:

Section 1. That there is hereby created a Spirit Committee to be comprised of eight individuals who reside or own a business within the boundaries of the City who are interested in encouraging and promoting a safe, welcoming and supportive community.

Section 2. That the Spirit Committee members will be appointed by the Mayor with the approval of the Board of Aldermen.

Section 3. That the terms of appointment of all Spirit Committee members shall be for three years, persons first appointed to the Committee shall serve staggered terms as follows:

Lauren Miller-Nelson	3 years
Harry Patel	3 years
Eduardo Garcia	3 years
Dale Sanson	2 years
Adam Mustoe	2 years
Terri Gulliott-Botts	2 years
Mary Kate Demers	1 year
Meredith Cole	1 year

Section 4. That the Spirit Committee shall meet at least quarterly to review to discuss strategy on encouraging and promoting a safe, welcoming and supportive community and review results from the City's community surveys, plan and facilitate community forums, identify barriers to safety in the City and recommend actions for the Board of Aldermen

to consider to support a safe, welcoming and supportive community for all residents, businesses and visitors in Kearney.

Section 5. The City Administrator shall designate appropriate City staff to serve as liaison between the Board of Aldermen and the Advisory Spirit Committee.

Section 6. The Kearney School District Superintendent may designate appropriate District staff to serve as liaison to the Advisory Spirit Committee.

Section 7. That the Advisory Spirit Committee is a public body and that is required to adhere to the requirements of Chapter 610 of the Missouri Revised Statutes, more commonly known as the "Sunshine Law".

Section 8. This resolution shall become effective February 6, 2023.


