- Commercial Umbrella Liability \$2,000,000 per occurrence/\$2,000,000 aggregate; All insurance coverage must be written by companies that have an A.M. Best's rating of "A-VII" or better, and are licensed or approved by the State of Missouri to do business in Missouri.

<u>Bid Guarantee</u>. Each bidder shall provide a bid guarantee equivalent to five percent of the bid price, for projects over \$50,000. The bid guarantee shall consist of a firm commitment such as a bid bond, certified check, or other negotiable instrument accompanying a bid as assurance that the bidder will, upon acceptance of the bid, execute such contractual documents as may be required within the time specified.

Payment of Labor and Materials Bonds. Pursuant to RSMo 107.170, the Contractor also agrees to obtain a Payment of Labor and Materials Bond for projects over \$50,000. The Payment Bond shall state that if the Contractor fails to pay prevailing wage the Surety will pay the deficiency and any penalty provided for by law which the contractor incurs by reason of their act or omission, in any amount not exceeding the amount of this obligation together with interest, as provided by law. Contractor further agrees to execute on or before the date of this agreement written verification of the bond in a form acceptable to the City of Kearney, Missouri. Said bonds shall be issued from an insurance or bonding company with A.M. Best's rating of "A-VII"

or better. Contractor agrees to obtain the signature of the surety providing bonds herein upon this agreement as additional verification of said bonds. A bank letter of credit covering these provisions will be accepted in lieu of the performance and payment bonds.

Prevailing Wage Provision. Not required for jobs where estimated cost or accepted bids are \$75,000, and not required for slurry seal, which is considered maintenance. If required wage rates for the project shall be not less than the prevailing wage rates per the current Clay County Wage Order Number 29, as determined by the Division of Labor Standards of the State of Missouri, pursuant to RSMo 290.250, or federal wage rates. The contractor will forfeit a penalty to the contracting public body \$100 per day, or portion thereof, for each worker that is paid less than the prevailing rate for any work done under the contract by the contractor or any subcontractor, pursuant to RSMo 290.250. The City is required to notify the Missouri Department of Labor that a prevailing wage project will be constructed, prior to beginning work.

OSHA Training Required. Pursuant to RSMo 292.675.4, any person signing a contract to work on the construction of public works for any public body shall provide a ten-hour Occupational Safety and Health Administration (OSHA) construction safety program for their on-site employees which includes a course in construction safety and health approved by OSHA or a similar program approved by the department which is at least as stringent as an approved OSHA program. All employees are required to complete the program within sixty days of beginning work on such construction project. The contractor shall forfeit as a penalty to the public body on whose behalf the contract is made or awarded, \$2,500.00 plus \$100.00 for each employee employed by the contractor or subcontractor, for each calendar day, or portion thereof, such employee is employed without the required training. The contractor shall provide a copy of proof of the OSHA training for any project employees prior to construction.

<u>Federal Work Authorization Program (E-Verify)</u>: Pursuant to RSMo 285.530, no business entity or employer shall knowingly employ, hire for employment, or continue to employ an unauthorized alien to perform work within the State of Missouri. <u>The contractor shall provide, as part of their bid, signed affidavits and documentation affirming said requirement</u>.

<u>Transient Employers</u>: Every transient employer, employers not domiciled in Missouri, pursuant to RSMo 285.230, must post in a prominent and easily accessible place at the work site a clearly legible copy of the following: 1)The notice of registration for employer withholding issued to such transient employer by the Director of Revenue, 2) Proof of coverage for workers' compensation insurance or self-insurance signed by the transient employer and verified by the Department of Revenue through the records of the division of workers' compensation; and 3) The notice of registration for unemployment insurance issued to such transient employer by the

Division of Employment Security. Any transient employer failing to comply with these requirements shall, under RSMo 285.234, be liable for a penalty of \$500.00 per day until the notices required by this section are posted as required by the statute.
