AN ORDINANCE AUTHORIZING THE CITY TO IMPOSE ITS USE TAX AND DECLARING THE RESULTS OF THE ELECTION HELD IN THE CITY ON NOVEMBER 2, 2021.

WHEREAS, the City of Kearney, Missouri (the "City"), is authorized under the provisions of Sections 144.600 to 144.761, RSMo (the "Act"), to impose a use tax at a rate equal to the rate of the total local sales taxes in effect in the City; and

WHEREAS, pursuant to an Ordinance of the City approved on August 16, 2021 (the "Authorizing Ordinance"), the Board of Aldermen ordered an election to be held in the City on November 2, 2021, for the purpose of submitting to the qualified voters of the City the following question:

Shall the City of Kearney impose a local use tax at the same rate as the total local sales tax rate, provided that if the local sales tax rate is reduced or raised by voter approval, the local use tax rate shall also be reduced or raised by the same action?

and the votes cast at said election were duly canvassed as provided by law, and it was found and declared that a majority of the qualified voters of City voting at said election on said question voted in favor of the imposition of a use tax.

THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF KEARNEY, MISSOURI, AS FOLLOWS:

Section 1. That it is hereby found and declared that the vote at the election held in the City of Kearney, Missouri, on Tuesday, November 2, 2021, on the following question:

Shall the City of Kearney impose a local use tax at the same rate as the total local sales tax rate, provided that if the local sales tax rate is reduced or raised by voter approval, the local use tax rate shall also be reduced or raised by the same action?

resulted as follows:

<u>YES</u> <u>NO</u> 490

- Section 2. That it is hereby found and declared that a majority of the qualified voters of the City voting on the question at said election voted in favor of said question and it thereby passed.
- Section 3. That attached hereto as Exhibit A is a full, true and correct copy of the ballot used at said election.
- Section 4. That attached hereto as Exhibit B is a full, true and correct copy of the certification of votes cast at said election received from the Clay County Board of Election Commissioners, that said certification of votes is the final and last certification of votes for said election, and that said certification of votes constitutes the official returns of the election pursuant to Section 115.507(2) of the Comprehensive Election Act, RSMo, as amended.

Section 5. That it is further found and declared that notice of said election was duly given by publication in the manner provided by law as evidenced by the affidavit of publication hereto as Exhibit C, and that said election was held and conducted in all respects in conformity with the Constitution and laws of the State of Missouri.

Section 6. With the approval on November 2, 2021 by a majority of the qualified voters voting thereon of the above-referenced question, the Board of Alderman hereby authorized the City to impose a use tax at a rate equal to the rate of the total local sales taxes in effect in the City, provided that if the local sales tax rate is subsequently reduced or raised by voter approval, the local use tax rate shall also be reduced or raised by the same action.

Section 7. The City Clerk is hereby ordered to forward to the Director of Revenue a certified copy of this Ordinance and the Authorizing Ordinance and the certification of the election results on the question at the November 2, 2021 election.

Section 8. Effective Date. This Ordinance shall take effect and be in full force from and after its passage by the Board of Aldermen.

AN ORDINANCE OF THE CITY OF KEARNEY, MISSOURI, IMPOSING A USE TAX FOR GENERAL REVENUE PURPOSES AT THE RATE EQUAL TO THE TOTAL LOCAL SALES TAXES IN EFFECT PURSUANT TO THE AUTHORITY GRANTED BY AND SUBJECT TO THE PROVISIONS OF SECTIONS 144.600 THROUGH 144.761 RSMO; PROVIDING FOR THE USE TAX TO BE REPEALED, REDUCED OR RAISED IN THE SAME AMOUNT AS ANY CITY SALES TAX IS REPEALED, REDUCED OR RAISED; AND PROVIDING FOR SUBMISSION OF THE PROPOSAL TO THE QUALIFIED VOTERS OF THE CITY FOR THEIR APPROVAL AT THE GENERAL ELECTION

WHEREAS, the City is authorized, under Section 144.757 RSMo, to impose a local use tax at a rate equal to the rate of the total local sales taxes in effect in the City; and

WHEREAS, the proposed City use tax cannot become effective until approved by the voters at a municipal, county or state general, primary, or special election;

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF KEARNEY, MISSOURI, AS FOLLOWS:

Section 1. Pursuant to the authority granted by, and subject to, the provisions of Sections 144.600 through 144.761 RSMo, a use tax for general revenue purposes is imposed for the privilege of storing, using or consuming within the City any article of tangible personal property. This tax does not apply with respect to the storage, use or consumption of any article of tangible personal property purchased, produced or manufactured outside this state until the transportation of the article has finally come to rest within this City or until the article has become commingled with the general mass of property of this City.

<u>Section 2</u>. The rate of the tax shall be equal to the total local sales tax in effect. If any city sales tax is repealed or the rate thereof is reduced or raised by voter approval, the city use tax rate also shall be deemed to be repealed, reduced or raised by the same action repealing, reducing or raising the city sales tax.

<u>Section 3</u>. This tax shall be submitted to the qualified voters of Kearney, Missouri, for their approval, as required by the provisions of Section 144.757 RSMo, at the General election hereby called and to be held in the City on <u>TUESDAY</u>, the 2nd day of November, 2021. The ballot of submission shall contain substantially the following language:

Shall the City of Kearney impose a local use tax at the same rate as the total local sales tax rate, provided that if the local sales tax rate is reduced or raised by voter approval, the local use tax rate shall also be reduced or raised by the same action?

<u>Section 4</u>. Within ten (10) days after the approval of this ordinance by the qualified voters of Kearney, Missouri, the City Clerk shall forward to the Director of Revenue of the State of Missouri by United States registered mail or certified mail, a certified copy of this ordinance together with certifications of the election returns and accompanied by a map of the City clearly showing the boundaries thereof.

<u>Section 5</u>. This Ordinance shall be in full force and effect from and after the date of its passage and approval.
