ORDINANCE NO. 22-08-18-01

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF LAGO VISTA, TEXAS, AMENDING THE CITY'S CODE OF ORDINANCES, CHAPTER 2 ANIMAL CONTROL, ARTICLE 2.200 ANIMAL CONTROL GENERALLY, SECTIONS 2.212, 2.214, 2.225 AND 2.236, PROVIDING CODIFICATION AND PUBLICATION, AN EFFECTIVE DATE, REMAINDER AND REPEALER, SEVERABILITY, PROPER NOTICE AND OPEN MEETINGS CLAUSE.

WHEREAS, the City of Lago Vista, Texas is a home rule city; and

WHEREAS, the Texas Health and Safety Code Chapters 822, 826, and Texas Local Government Code Chapter 217 allow for municipal regulation of animals and animal related nuisances; and

WHEREAS, Chapter 2 of the City's Code of Ordinances contains Animal Control regulations; and

WHEREAS, the City Council desires to amend Chapter 2 Animal Control, Article 2.200 Animal Control Generally, Sections 2.212, 2.214 and Section 2.225 as reflected in Exhibit "A" to remove the specific penalties listed in the respective sections and instead utilize the penalty clause in Section 2.235 referring to the general penalty clause in Section 1.109; and

WHEREAS, the City Council also desires to amend Chapter 2 Animal Control, Article 2.200 Animal Control Generally, Section 2.236 as reflected in Exhibit "A" to conform the requirements to Chapter 822 Texas Health and Safety Code; and

WHEREAS, the City Council finds that it is necessary and proper for the purpose of promoting effective and efficient government of the City to adopt the proposed amendments to Sections 2.212, 2.214, 2.225, and 2.236 of the Code of Ordinances.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LAGO VISTA, TEXAS, THAT:

<u>SECTION 1</u>. FINDINGS OF FACT. All of the above and foregoing recitals are hereby found to be true and correct legislative findings of the City and are incorporated herein as findings of fact.

SECTION 2. AMENDMENT. The City Council of the City of Lago Vista, Texas, does hereby amend Chapter 2 Animal Control, Article 2.200 Animal Control Generally, Sections 2.212, 2.214, 2.225, and 2.236 of the Code of Ordinances as shown in Exhibit "A." Underlined language shall be added and language to be deleted is signified by strike-through.

SECTION 3. REMAINDER AND REPEALER. The remainder of all portions of Article 2.200 not amended by this Ordinance continue in force and effect. All ordinances, orders or resolutions heretofore passed and adopted by the City Council of the City of Lago Vista, Texas, are hereby repealed to the extent said ordinances, orders or resolutions or parts thereof are in conflict herewith.

SECTION 4. SEVERABILITY CLAUSE. If any section, subsection, article, paragraph, sentence, clause, phrase or word in this Ordinance is for any reason held to be invalid or unconstitutional by a court of competent jurisdiction, such holding shall not affect the validity of the remaining portions of this Ordinance, and the City Council hereby declares it would have passed such remaining portions of this Ordinance despite such invalidity, which remaining portions shall remain in full force and effect.

<u>SECTION 5.</u> CODIFICATION AND PUBLICATION. The City Secretary is hereby directed to record and publish the attached amendments to the City's Code of Ordinances as authorized by Section 52.013 of the Texas Local Government Code.

<u>SECTION 6.</u> EFFECTIVE DATE. This Ordinance shall take effect immediately upon its passage and publication in accordance with the Texas Local Government Code.

SECTION 7. OPEN MEETINGS. It is hereby officially found and determined that the meeting at which this ordinance is passed was open to the public as required and that public notice of the time, place, and purpose of said meeting was given as required by the Open Meetings Act, Chapter 551 of the Texas Government Code.

Sec 2.212 Compliance With Registration, Permits And Tags Provision

If a dog or cat is picked up and the owner has registered and holds a current dog or cat city permit, but fails to have a current rabies tag worn by the dog or cat, a citation may be issued and a fine of ten dollars (\$10.00) per missing tag for the violation. It shall be a violation A citation for failure to register and possess a current city permit and rabies tag for any dog or cat. shall carry a fine of fifty dollars (\$50.00).

Sec 2.214 Dogs And Cats At Large (Violation Of Restraint Provision)

(a) It is a class C Misdemeanor for an No owner shall to allow any dog or cat to be at large in the city. Any dog or cat observed at large in the city may be impounded. Citations will be issued to owners, and shall be separate of any other penalties, fines and fees. Citations for violation of this provision shall be subject to the following fines:

1st Offense \$40.00
2nd Offense \$80.00
3rd Offense \$120.00

(b) Second and third offense fines apply to violations of this provision which have occurred cumulatively within the same calendar year.

Sec 2.225 Animal Control Nuisances

- (a) An animal control nuisance shall mean any animal problem which an owner causes or allows to be caused in the manner of keeping the animal, that disturbs the comfort, physical senses, health, or well-being of another person; or that interferes with another person's enjoyment or rightful use of his their own property.
- (b) A citation or warning may be issued for a violation of any of the nuisance problems in the amount of:

1st Offense \$25.00 2nd Offense \$50.00 3rd Offense \$75.00

Sec 2.236 Dog Bite Investigations And Dangerous Dog Information

- (a) Chapter 822 of the Texas Health and Safety Code relating to dangerous dogs was recently amended by the Texas State Legislature by House Bill 2065. The statute was amended to add Subchapter D which requires among other things that local animal control authorities annually register dangerous dogs for events that occur after September 1, 1991.
- (b) Dangerous dogs are dogs that:

- (1) Make an unprovoked attack on a person causing bodily injury and occurring in a place other than an enclosure in which the dog was being kept and that was reasonably certain to prevent the dog from leaving the enclosure on its own.
- (2) Make an unprovoked attack on a person in a place other than an enclosure in which the dog was being kept, which enclosure was reasonably certain to prevent the dog from leaving the enclosure on its own, causing the person to reasonably believe that the attack may have caused bodily injury.

(c) Owners of dangerous dogs must:

- (1) Register the dog annually as a dangerous dog with the local animal control authority and pay a registration fee as set forth in the fee schedule located in Appendix A of this code.
- (2) Restrain the dog at all times on a leash in the immediate control of a person or in a secure enclosure.
- (3) Obtain liability insurance coverage or show financial responsibility in an amount of at least One Hundred Thousand Dollars (\$100,000.00) to cover damages resulting from an attack by the dangerous dog against any person.
- (4) Submit proof of the dog's current rabies vaccination.
- (5) Attach the issued dangerous dog tag to the dog's collar or harness and insure that the tag is worn at all times.
- (6) Inform the local animal control authority, if the dangerous dog is sold or moved to a new address, within fourteen (14) days of the sale or move of the dog. The new owner of the dangerous dog shall register the dog by presenting the prior registration and remitting a fee as set forth in the fee schedule located in Appendix A of this code to the animal control authority.
- (7) Inform the local animal control authority office of any attacks on people by the dangerous dog.
- (d) A secure enclosure for a dangerous dog is one that:
 - (1) Is a fenced area or a structure that is:
 - (A) Locked;
 - (B) Capable of preventing the entry of the general public including children:
 - (C) Capable of preventing the escape or release of the dog; and
 - (D) Clearly marked as containing a dangerous dog.
 - (2) Has been inspected and approved by the representatives of the local animal control program.
- (e) Liability of owners of dangerous dogs.
 - (1) The owner or person in possession of a dangerous dog may be charged with a Class C misdemeanor if the dog makes an unprovoked attack on another person outside the dog's enclosure and causes bodily injury.
 - (2) The owner or person in possession of a dangerous dog may be charged with a 3rd Degree Felony Misdemeanor—if his dangerous dog makes an unprovoked attack on another person outside the dog's enclosure and causes serious bodily injury or death.

- (3) If the attack causes the death of a person, the owner or person may be charged with a 2nd Degree Felony. (If the owner of the dog is found guilty in either of the above cases, the court may order the destruction of the dangerous dog.)
- (4) In addition to criminal prosecution, a person who commits an offense as detailed in (1) and (2) above is liable for a civil penalty not to exceed ten thousand dollars (\$10,000.00). A city or county attorney may file a suit in a court of competent jurisdiction to collect this civil penalty.
- (f) Dog bite investigators should be familiar with this section and should inform the owners of dogs involved in a bite or injury, of the facts contained in this section. This section may be duplicated and given as a hand-out. A dog that was loose at the time of a bite resulting in bodily injury may be declared dangerous, required to be registered as a "dangerous dog," restrained in a secure enclosure, and insurance obtained, or proof of financial responsibility required.
- (g) For the purposes of this section, the following words or phrases shall have the meaning provided below:
 - (1) <u>Unprovoked Attack</u>. An attempt by a dog to bite and inflict bodily injury on a person when the dog was not hit, kicked, or struck by the person with an object or part of the person's body, nor was any part of the dog's body pulled, pinched, or squeezed by the person, nor was the dog taunted or teased by the person. Consideration will be given to whether the person was in the dog's territory and on property of the dog's owner at the time of the attack (e.g. when the dog is confined to owner's property by rope or chain, or when a dog is defending its young on the property of its owner.) If at the time of the unprovoked attack the person was in the dog's territory and the dog was confined, then any attack will not be deemed an unprovoked attack.
 - (2) <u>Bodily Injury</u>. Physical pain, illness, or any impairment of physical condition.
 - (3) Serious Bodily Injury. means an injury characterized by severe bite wounds or severe ripping and tearing of muscle that would cause a reasonably prudent person to seek treatment from a medical professional and would require hospitalization without regard to whether the person actually sought medical treatment.

EXECUTIVE SUMMARY:

The mandatory requirements for the Board of Adjustment to approve a zoning variance remain as enumerated in Section 11.20 of Chapter 14 of the Lago Vista Code of Ordinances, as amended by this Council in Ordinance Number 21-08-19-03. The purpose of that amendment was to maximize consistency with all applicable state statutes.

Effective, September 1, 2021 (shortly thereafter) HB 1475 provided authority for additional discretion that the Board of Adjustment might exercise in determining whether the basis of a specific variance application is an "unnecessary hardship" (the statutory requirement). As a result, the following five items are currently included in a new Section 211.009(b-1) of the Texas Local Government Code: 1) the financial cost of compliance is greater than 50 percent of the appraised value of the structure as shown on the most recent appraisal roll certified to the assessor for the municipality under Section 26.01, Tax Code; 2) compliance would result in a loss to the lot on which the structure is located of at least 25 percent of the area on which development may physically occur; 3) compliance would result in the structure not being in compliance with a requirement of a municipal ordinance, building code, or other requirement; 4) compliance would result in the unreasonable encroachment on an adjacent property or easement; or 5) the municipality considers the structure to be a nonconforming structure.

However, the second item on the list caused the staff some significant concern as it seems to allow the consideration of fairly normal setbacks on a relatively small lot (a size that is very common in Lago Vista) to contribute towards a determination of an "unnecessary hardship." As a result, the Development Services staff asked the City Attorney to spend guite a bit of time in an attempt to discern the intent behind that provision. Ultimately, she obtained consistent recommendations from a number of sources including the TML legal staff and presenters at a recent continuing legal education seminar. That recommendation was a reminder that these were discretionary factors that could be considered, but did not supersede the mandatory requirements or our ordinance that are now consistent with the balance of Section 211.009. The staff subsequently prepared this draft, unanimously recommended by the Planning and Zoning Commission at their July 14, 2022 regular meeting.

Impact if Denied: The exercise of that discretion would presumably be equally valid. ORDINANCE NO. 22-08-18-02

AN ORDINANCE OF THE CITY COUNCIL OF LAGO VISTA, TEXAS, AMENDING SECTION 11.30 OF CHAPTER 14 OF THE LAGO VISTA CODE OF ORDINANCES TO SPECIFICALLY RECOGNIZE THE ABILITY OF THE BOARD OF ADJUSTMENT TO CONSIDER ANY OF THE GROUNDS INCLUDED IN SECTION 211.009(B-1) OF THE TEXAS LOCAL GOVERNMENT CODE IN MAKING THE DETERMINATION WHETHER THE APPLICATION OF A ZONING ORDINANCE PROVISION WOULD RESUL IN AN UNNECESSARY HARDSHIP; AND PROVIDING FOR RELATED MATTERS.

WHEREAS, the City of Lago Vista, Texas is a Home Rule City; and

WHEREAS, the City Council of the City of Lago Vista has previously specified the findings required for the Board of Adjustment to approve a zoning variance in Section 11.20 of Chapter 14, the Zoning Ordinance; and

WHEREAS, the City Council of the City of Lago Vista has also previously provided guidance to the Board of Adjustment by including language in Section 11.30 of Chapter 14, the Zoning Ordinance, that specifies what is described as their "interpretive role" in making the required determinations; and

WHEREAS, Section 211.009(b-1) of the *Texas Local Government Code* now includes enumerated discretionary authority that the Board of Adjustment may exercise in the determination of whether the basis of a specific variance application is an "unnecessary hardship;" and

WHEREAS, the staff and members of the Planning and Zoning Commission believe that it is in the best interest of the residents and property owners of the City if local ordinances are as consistent as possible with state statutes so that the Board of Adjustment can more effectively rely on the guidance of Texas courts in making decisions involving zoning variance requests; and

WHEREAS, the Planning and Zoning Commission of the City of Lago Vista has undertaken a review of those regulations and conducted multiple public hearings concerning those regulations at their meetings between November 11, 2021 and July 14, 2022; and

WHEREAS, the proposed changes should also yield results that are more aligned with the expectations of the residents and property owners of Lago Vista; and

WHEREAS, the Planning and Zoning Commission of the City of Lago Vista has forwarded a recommendation to the City Council to amend those requirements contained within Sections 11.30 of Chapter 14 of the Lago Vista Code of Ordinances as described below; and

WHEREAS, the City Council at its public hearing to consider this ordinance amendment held on August 18, 2022, reviewed the recommendation, and found the changes to be warranted.

WHEREAS, the City Council desires to amend the Lago Vista Code of Ordinances as described below.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LAGO VISTA, TEXAS, THAT:

<u>SECTION 1</u>. FINDINGS OF FACT. All of the above and foregoing recitals are hereby found to be true and correct legislative findings of the City and are incorporated herein as findings of fact.

SECTION 2. AMENDMENT. The City Council of the City of Lago Vista, Texas, does hereby amend Section 11.30 of Chapter 14 of the Lago Vista Code of Ordinances as shown in **Exhibit "A."**

<u>SECTION 3.</u> REPEALER. All ordinances, orders or resolutions heretofore passed and adopted by the City Council of the City of Lago Vista, Texas, are hereby repealed to the extent said ordinances, orders or resolutions or parts thereof are in conflict herewith.

<u>SECTION 4.</u> SEVERABILITY CLAUSE. If any section, subsection, article, paragraph, sentence, clause, phrase or word in this Ordinance is for any reason held to be invalid or unconstitutional by a court of competent jurisdiction, such holding shall not affect the validity of the remaining portions of this Ordinance, and the City Council hereby declares it would have passed such remaining portions of this Ordinance despite such invalidity, which remaining portions shall remain in full force and effect.

SECTION 5. EFFECTIVE DATE. This Ordinance shall take effect immediately upon its passage and publication in accordance with the provisions of the *Tex. Loc. Gov't. Code*.

SECTION 6. OPEN MEETINGS. It is hereby officially found and determined that the meeting at which this ordinance is passed was open to the public as required and that public notice of the time, place, and purpose of said meeting was given as required by the Open Meetings Act, Chapter 551 of the Texas Government Code.

ORDINANCE NO. 22-08-18-03

AN ORDINANCE ORDERING AND ESTABLISHING PROCEDURES FOR THE 2022 GENERAL ELECTION IN THE CITY OF LAGO VISTA, TEXAS TO ELECT COUNCILMEMBERS FOR PLACE 2, PLACE 4 AND PLACE 6; PROVIDING FOR NOTICE OF THE ELECTION; PROVIDING ELECTION PRECINCT AND POLLING PLACES; PROVIDING FOR EARLY VOTING; PROVIDING AN EFFECTIVE DATE AND OPEN MEETINGS CLAUSE; AND PROVIDING FOR RELATED MATTERS.

WHEREAS, on November 8, 2022, there shall be elected the following officials for this City: Council Member Place 2; Council Member Place 4; and Council Member Place 6;

WHEREAS, the Texas Election Code is applicable to said election and this ordinance establishes procedures consistent with the Code, and designates the voting place for the election;

WHEREAS, the voters of the City will be adequately and conveniently served by the common early voting polling places specified herein, which are located outside the boundary of the City, and such polling places will facilitate the orderly conduct of the election;

WHEREAS, the City of Lago Vista, Texas (hereinafter the "City") has made provision to contract with Travis County to conduct the City's election, pursuant to *Chapter 31, Tex. Elec. Code, and Chapter 791, Tex. Gov't Code* (the "Election Agreement" or "contract"), and such contract provides for political subdivisions subject to the contract that hold elections on the same day in all or part of the same territory to hold a joint election as authorized in *Chapter 271, Tex. Elec. Code;*

NOW, THEREFORE, BE IT ORDAINED AND ORDERED BY THE CITY COUNCIL OF THE CITY OF LAGO VISTA, TEXAS:

SECTION 1. The General Election of the City shall be held on Tuesday, November 8, 2022, to elect Council Members for Place 2, Place 4, and Place 6, to serve a term of two (2) years each. Candidates at the election for the above offices shall file their applications to become candidates with the City Secretary of the City, at City Hall, 5803 Thunderbird Drive, Lago Vista, Texas 78645, between Saturday, July 23, 2022, and Monday, August 22, 2022, at 5:00 p.m. All applications for candidacy shall be on a form as prescribed by the *Tex. Elec. Code*. The order in which the names of the candidates for each office are to be printed on the ballot shall be determined by a drawing conducted by the City Secretary and will be held on Wednesday, August 24, 2022, at 10:00 a.m. at City Hall.

SECTION 2. Notice of the election shall be given and the election shall be held in compliance with the provisions of the *Tex. Elec. Code* in all respects. The ballots for the election shall comply with the *Tex. Elec. Code* and be in the form provided by the City to the Travis County Election Officer for use on the voting devices and ballots used by Travis County.

SECTION 3. The Travis County Election Officer and his/her employees and appointees, and the election judges, alternate judges and clerks properly appointed for the election, shall hold and conduct the election in the manner provided by contract with the City and the law governing the holding of

elections by home rule cities of the State of Texas; and the official ballots, together with such other election materials as are required by the *Tex. Elec. Code*, shall be prepared in both the English and Spanish languages and shall contain such provisions, markings and language as is required by law.

SECTION 4. Early Voting.

(a) Early voting for qualified voters of the City residing in Travis County shall be held at the dates, times, and locations authorized by the Travis County Elections Administrator. The main early voting location is the Austin Permitting and Development Center, 6310 Wilhelmina Delco Drive, Austin, TX 78752. Branch polling locations shall be authorized by the Travis County Elections Administrator. Any early voting polling place may be added or changed by the Administrator upon compliance with applicable law.

(b) Early voting for qualified voters of the City residing in Travis County shall commence as specified by the *Texas Election Code* and the respective Elections Administrator:

- (d) The period to apply for a federal postcard application (FPCA) is January 1, 2022, through October 28, 2022. An FPCA must be received by the Early Voting Clerk no later than the close of business on October 28, 2022.
- (e) Early Voting Conducted by the Travis County Elections Administrator:
 - 1) Early voting, both by personal appearance and by mail will be conducted by the Travis County Elections Administrator in accordance with the *Texas Election Code* for the qualified voters of the City residing in Travis County. Rebecca Guerrero, County Clerk, is hereby designated and appointed as an Early Voting Clerk for the special election for qualified voters of the City residing in Travis County.

3) Registered voters of the City of Lago Vista may vote at any designated Travis County early voting location.

SECTION 5. The election precincts for the election shall be the election precincts established by Travis County, provided that each shall contain and include geographic area that is within the City. The polling place for each such election precinct shall be the polling place established by Travis County for such election precincts in Travis County and voting by residents of the City. The polls shall remain open on the day of the election from 7:00 a.m. to 7:00 p.m. The returns for precincts in Travis County will be provided by precinct and the Travis County Election Officer shall tabulate and provide the election returns for the election.

SECTION 6. The City Secretary, or designee, is instructed to aid the Travis County Election Officer in the acquisition and furnishing of all election supplies and materials necessary to conduct the election as provided by the Election Agreement. The City Secretary is further authorized to give or cause to be given notices required for the election, and to take such other and further action as is required to conduct the election in compliance with the *Tex. Elec. Code* and *City Charter*; provided that, pursuant to the Election Agreement between Travis County and the City, the Travis County Election Officer shall have the duty and be responsible for organizing and conducting the election in compliance with the *Tex. Elec. Code*; and for providing all services specified to be provided in the Election Agreement. The Travis County Election Officer shall give the notices required by the *Tex. Elec. Code* to be given for the election not required to be given by the City under the Election Agreement.

SECTION 7. The presiding judges, alternate presiding judges and clerks for the election shall be selected and appointed by Travis County and its appointees in compliance with the requirements of state law, and such judges and clerks so selected by Travis County and its appointees are hereby designated and appointed by the city council as the election officers, judges and clerks, respectively, for the holding of said special election. The presiding judges, alternate presiding judges and clerks shall perform the functions and duties of their respective positions that are provided by state law. The city council will further confirm and appoint the election judges and alternate election judges that are appointed by Travis County for the election.

SECTION 8. Notice of the election shall be given by posting a notice containing a substantial copy of this Ordinance on the bulletin board used for posting notice of meetings of the governing body at the City Hall and at the aforesaid election day polling places not later than the twenty-first (21st) day before the election, and by publishing said Notice of Election at least one time, not earlier than thirty (30) days nor later than ten (10) days prior to said election, in a newspaper of general circulation in the City. The notice that is posted, and the notice that is published in a newspaper of general circulation within the city, will be written in both English and Spanish.

SECTION 9. The Mayor is authorized and directed to post an election order for this election that complies with the Texas Election Code by August 22, 2022.

SECTION 10. The election shall be held and conducted by the Travis County Election Officer in compliance with state law and the Election Agreement, and this Ordinance shall be in force and effect from and after its passage on the date shown below.

SECTION 11. It is hereby officially found and determined that this meeting was open to the public, and public notice of the time, place and purpose of said meeting was given, all as required by the Open Meetings Act, *Chapter 551, Texas Government Code*.

ORDINANCE NO. 22-08-18-04

AN ORDINANCE OF THE CITY OF LAGO VISTA, TEXAS, ORDERING A SPECIAL ELECTION TO BE HELD ON **NOVEMBER 8, 2022, ON A PROPOSITION TO INCREASE THE** CITY'S GENERAL REVENUE SALES AND USE TAX RATE PURSUANT TO CHAPTER 321 OF THE TEXAS TAX CODE, CONDITIONED ON A MAJORITY OF QUALIFIED VOTERS VOTING "NO" ON PROPOSITION "A", WHICH IS THE MEASURE ON THE OUESTION OF THE CONTINUATION OF CAPITAL **METROPOLITAN** TRANSPORTATION AUTHORITY IN THE CITY OF LAGO VISTA; PRESCRIBING THE FORM OF THE BALLOT; PROVIDING FOR ELECTION PROCEDURES; AND PROVIDING FOR AN EFFECTIVE DATE; PROVIDING AN OPEN MEETINGS CLAUSE; AND PROVIDING FOR RELATED MATTERS.

WHEREAS, the current general revenue sales and use tax rate within the City of Lago Vista, Texas (the "City") is one percent (1%);

WHEREAS, Chapter 321 of the Texas Tax Code authorizes the general revenue sales and use tax to be adopted in increments of one-eighth of one percent (1%);

WHEREAS, the maximum combined sales tax rate adopted by local taxing authorities may not exceed two percent (2%);

WHEREAS, the City is located within the Capital Metropolitan Transportation Authority (CapMetro), which collects a one percent (1%) sales tax within the City;

WHEREAS, the current combined sales tax rate for all local taxing authorities in the City is two percent (2%);

WHEREAS, the City Council called an election on the question of the continuation of CapMetro within the City of Lago Vista ("Proposition A");

WHEREAS, if a majority of qualified voters vote "No" on Proposition A, then CapMetro will calculate the net financial obligation of the City, pursuant to Subchapter M, Chapter 451, Texas Transportation Code, and will continue to collect the one percent (1%) sales tax within the City until the net financial obligation is collected;

WHEREAS, after the net financial obligation is collected, CapMetro will cease to collect the one percent (1%) sales tax within the City and there will be a one percent (1%) sales tax increment available for adoption by local taxing authorities (upon approval by a majority of qualified voters);

WHEREAS, the City Council has determined that an election should be held on the question of increasing the City's general revenue sales tax from one percent (1%) to two percent (2%) conditioned upon a majority of qualified voters voting "No" on Proposition A ("Proposition B');

WHEREAS, the ballot language will ask voters to approve a sales and use tax of two percent (2%), which is the total general revenue sales and use tax rate that will be in effect upon approval by a majority of the qualified voters and canvassing of the election;

WHEREAS, the two percent (2%) sales and use tax will not be implemented by the Comptroller unless Proposition A fails and Proposition B passes;

WHEREAS, if Proposition A fails and Proposition B passes, the total rate of all sales and use taxes levied within the City will not exceed two percent (2%);

WHEREAS, the City Council finds it appropriate to substitute the words "Yes" and "No" on the ballot for "For" and "Against" to be consistent with language used for other City propositions scheduled for the November 8, 2022 election;

WHEREAS, the City of Lago Vista lies within the boundaries of Travis County;

WHEREAS, the City of Lago Vista, Texas (hereinafter the "City") approves and agrees to conducting the election jointly with other political subdivisions in Travis County in accordance with *Tex. Elec. Code, Chapter 271*; and

WHEREAS, the City has contracted with the Travis County Elections Administrator to conduct the City's election for Travis County voters residing in the City, pursuant to *Chapter 31, Tex. Elec. Code*, and *Chapter 791, Tex. Gov't Code* (the "Election Services Contracts");

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LAGO VISTA, TEXAS:

Section 1. Special Election Ordered. The City Council of the City of Lago Vista hereby orders a special election to be held on November 8, 2022, between the hours of 7:00 a.m. and 7:00 p.m. to submit to the qualified voters of the City a proposition allowing such voters to vote for or against a one percent (1%) increase in the general revenue sales and use tax rate, pursuant to Chapter 321, Texas Tax Code, and upon approval of the increase, the City's general revenue sales and use tax rate shall be equal to two percent (2%), provided that the increase shall be conditional upon a majority of qualified voters voting "No" on Proposition A and will go into effect pursuant to applicable state law.

Section 2. Ballot and Proposition Language. The official ballots for said special election shall be prepared in accordance with the Texas Election Code so as to permit the electors to vote "YES" or "NO" as to the proposition, with the ballots to contain such provisions,

markings and language as required by law, and with such proposition to be expressed in a form substantially as follows:

City of Lago Vista Proposition B General Revenue Sales Tax Conditional Upon a Majority "NO" Vote on Proposition A

The adoption of a local sales and use tax in the City (2%)	of Lago Vista at the rate of two percent

Section 3. Printed Materials. The official ballots, together with such other election materials as are required by the *Texas Election Code*, as amended, shall be printed in both the English and Spanish languages and shall contain such provisions, markings and language as required by law.

Section 4. Notice of Election. Notice of the election shall be given in the manner as provided in the *Texas Election Code* and the *City Charter*. The notice of election shall be posted on the bulletin board used for posting notice of meetings of the governing body at City Hall and at other locations required by state law not later than the twenty-first (21st) day before the election, and by publishing said notice of election at least one time, not earlier than thirty (30) days nor later than ten (10) days prior to said election, in English and Spanish in a newspaper of general circulation in the City. The Travis County Elections Administrator is authorized and shall give all notices for their respective jurisdictions required for the election.

Section 5. Conduct of Election. The Travis County Elections Administrator and his/her employees and appointees, and the election judges, alternate judges and clerks properly appointed for the election, shall hold and conduct the election for that part of the City located in Travis County pursuant to the Election Services Contract between the City of Lago Vista and Travis County. The election shall be held and conducted in compliance with the City Charter, state law, and the Election Services Contract.

Section 6. Joint Election. The City agrees to conduct a joint election with other political subdivisions within Travis County, provided that such political subdivisions hold an election on November 8, 2022, in all or part of the same territory as the City (the "Political Subdivisions"). The joint election for Political Subdivisions will be conducted m accordance with state law, this ordinance, and the Election Services Contract.

Section 7. Election Precincts and Election Day Polling Places.

- (a) The election precincts for the election shall be the election precincts established for Travis County.
- (b) The polling place for each election precinct located in Travis County shall be the polling place established by Travis County. The returns will be provided by precinct and the Travis County Elections Administrator shall tabulate and provide the election returns for votes cast by Travis County voters.

Section 8. Early Voting.

- (a) Early voting for qualified voters of the City residing in Travis County shall be held at the dates, times, and locations authorized by the Travis County Elections Administrator. The main early voting location is the Austin Permitting and Development Center, 6310 Wilhelmina Delco Drive, Austin, TX 78752. Branch polling locations shall be authorized by the Travis County Elections Administrator. Any early voting polling place may be added or changed by the Administrator upon compliance with applicable law.
- (b) Early voting for qualified voters of the City residing in Travis County shall commence as specified by the *Texas Election Code* and the respective Elections Administrator:

Travis County Elections Administrator in accordance with the *Texas Election Code* for the qualified voters of the City residing in Travis County. 3) Registered voters of the City of Lago Vista may vote at any designated Travis County early voting location.

Section 9. Election Judges and Clerks. The presiding judges, alternate presiding judges and clerks for the election shall be selected and appointed by Travis County, in compliance with the requirements of state law, and are hereby designated and appointed election officers for the holding of said election and such appointments are approved. The presiding judges, alternate presiding judges and clerks shall perform the functions and duties of their respective positions that are provided by state law.

Section 10. City Secretary Assistance. The City Secretary is hereby authorized and instructed to aid the Travis County Elections Administrator in the acquisition and furnishing of all election supplies and materials necessary to conduct the election. The City Secretary is further authorized to assist with the giving of notices required for the election, and to take such other and further action as is required to conduct the election in compliance with the *Texas Election Code;* provided that, pursuant to the Election Services Contract between the City and the Travis County Elections Administrator, the Travis County Elections Administrator shall have the duty and be responsible for organizing and conducting the election in compliance with the *Texas Election Code;* and for providing all services specified to be provided in the Election Services Contract.

Section 11. Necessary Actions. The Mayor and the City Secretary of the City, in consultation with the City's Attorney, are hereby authorized and directed to take any and all actions necessary to comply with the provisions of the Code and the Federal Voting Rights Act in

carrying out and conducting the Election, whether or not expressly authorized herein, including but not limited to making changes or additions to polling places, ballot language, or procedures to the extent required or desirable or as may become necessary due to circumstances arising after the date of this Ordinance. The City Manager is further authorized to give notice of the election as provided in Section 451.607, Texas Election Code.

Section 12. General. The general election shall be held and conducted by the Travis County Elections Administrator in compliance with the *Tex. Elec. Code* and, to the extent not inconsistent therewith, the *City Charter*, and only resident qualified voters of the City shall be eligible to vote at the election. The Election Officers are hereby authorized and instructed to provide and furnish all necessary election supplies, materials, and equipment to conduct said election. Returns of the election shall be made known as soon as possible after the closing of the polls; and the election returns shall be canvassed by the City Council not earlier than November 11, 2022, nor later than November 22, 2022.

Section 13. Authorization to Execute. The Mayor is authorized to execute and the City Secretary is authorized to attest this Ordinance on behalf of the Council; and the Mayor is authorized to do all other things legal and necessary in connection with the holding and consummation of the Election.

Section 14. Effective Date; Election Code; Preamble. This ordinance shall be in full force and effect from and after its passage on the date shown below; provided that if any term or provision of this Ordinance conflicts with, or is inconsistent with, the Texas Elections Code, the Texas Election Code shall govern and control, and the Travis County Elections Administrator shall comply with the Texas Elections Code. The recitals contained in the preamble hereof are hereby found to be true, and such recitals are hereby made a part of this Ordinance for all purposes as part of the findings of Council.

Section 15. Severability. If any provision, section of this ordinance or the application of any provision to any person or circumstance is held invalid, the invalidity shall not affect other provisions or applications of the ordinance which can be given effect without the invalid provision or application, and to this end the provisions of this ordinance are declared to be severable.

Section 16. Open Meetings. It is officially found and determined that the meeting at which this Ordinance is passed was open to the public as required and that public notice of the time, place, and purpose of said meeting was given as required *Chapter. 551, Tex. Gov't. Code.*

ORDINANCE NO. 22-08-18-05

AN ORDINANCE OF THE CITY OF LAGO VISTA, TEXAS, AMENDING ORDINANCE 22-08-04-01 THAT ORDERED A SPECIAL ELECTION TO BE HELD ON THE QUESTION OF THE CITY OF LAGO VISTA'S CONTINUED PARTICIPATION IN THE CAPITAL METROPOLITAN TRANSPORTATION AUTHORITY; PROVIDING FOR IDENTIFICATION OF THE MAIN EARLY VOTING POLLING PLACE; PROVIDING FOR THE DATES AND TIMES EARLY VOTING WILL BE CONDUCTED; PROVIDING AN EFFECTIVE DATE AND OPEN MEETINGS CLAUSE; AND PROVIDING FOR RELATED.

WHEREAS, On August 4, 2022, the City Council of the City of Lago Vista, Texas ordered a Special Election via Ordinance No. 22-08-04-01 for the citizens of Lago Vista to be given an opportunity to vote on Lago Vista's continued participation in the Capital Metropolitan Transportation Authority, pursuant to Section 451.601, et seq., Texas Transportation Code; and

WHEREAS, the City of Lago has contracted with Travis County to conduct its elections to be held on November 8, 2022; and

WHEREAS, Section 85.004, Texas Election Code, provides that the election order must designate and state the location of the main early voting polling place; and

WHEREAS, when Ordinance No. 22-08-04-01 was adopted, the early voting polling place had not been identified by Travis County; and

WHEREAS, Section 85.007, Texas Election Code, provides that the election order must state the dates and hours that voting on Saturday or Sunday is to be conducted; and

WHEREAS, when Ordinance No. 22-08-04-01 was adopted, the hours that voting on Sunday had not been identified by Travis County; and

WHEREAS, the City Council finds that it is necessary and proper for the purpose of promoting effective and efficient government of the City to adopt the proposed amendments to Ordinance No. 22-08-04-01 to reflect the location of the main early voting polling place and the dates and hours that voting on Saturday or Sunday will be conducted.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LAGO VISTA, TEXAS:

SECTION 1. FINDINGS OF FACT. All of the above and foregoing recitals are hereby found to be true and correct legislative findings of the City and are incorporated herein as findings of fact.

SECTION 2. AMENDMENT. The City Council of the City of Lago Vista, Texas, hereby amends Ordinance No. 22-08-04-01 as follows:

SECTION 5. EFFECTIVE DATE. This Ordinance shall take effect immediately upon its passage and publication in accordance with the Texas Local Government Code.

SECTION 6. OPEN MEETINGS. It is officially found and determined that the meeting at which this Ordinance is passed was open to the public as required and that public notice of the time, place, and purpose of said meeting was given as required *Chapter 551*, *Tex. Gov't. Code*.
