Concrete Washout

Every site is required to have a poly lined and appropriate sized concrete washout. The available washout may be located on another property owned by the applicant but must be located within a reasonable distance from the property addressed above. Washout basins must be properly maintained located inside the applicant's property and not within the right of way or in a location where it disturbs neighboring residences. If the washout basin is located on another property the address must be provided.

Toilet Facility

A Portable Toilet must be placed on each property. .

Erosion Control

Erosion Control barriers "Silt Fencing" must be in place on all downhill sides of construction and bordering neighboring properties within the development area.

Dumpster

Every Site requires a 40 yard roll off dumpster. If the applicant feels the property cannot fit a 40 yard dumpster the following exceptions may be allowed if approved by the Building Official. If a the Building Official determines a 40 yard dumpster is appropriate and the applicant chooses an alternate dumpster the Plan Review will be returned and the applicant must agree to use a 40 yard dumpster.

Approved alternatives:

- A. A six yard or larger metal dumpster with a hinged lid is the minimum size or submit photos and dimensions of alternative.
- B. A 40 yard dumpster located on an adjacent property owned by the applicant. In addition permitted site must have a trash receptacle on site for smaller items and all trash must be removed from the site at the end of every day.
- C. A site built 8'x8'x4' trash receptacle with lid.

Regardless the type of receptacle used in the event of trash spilling over onto the property the permit holder will be ticketed by the City of Lago Vista Code Enforcement. Dumpsters may not be located in the right of way or areas that spillage will occur on neighboring properties.
