- III. **ACCEPTANCE OF AGENDA/ URGENCY ITEMS:** Move to accept agenda as posted, or move to add or delete items.
To add item, Council is required to make a majority decision that an urgency exists (as defined in the Brown Act) and a 2/3rds determination that the need to take action arose subsequent to the Agenda being posted.

Any Council Member may request that any item be removed from the Consent Agenda for discussion under the regular Agenda. Removed items will be considered following the Consent Calendar portion of this agenda.*
 - A. Ordinances: Waive reading except by title, of any ordinances under consideration at this meeting for either introduction or passage per *Government Code* Section 36934.
 - B. Minutes: Approve minutes of the City Council regular meeting of September 6, 2022.
 - C. AB 361: Adopt a resolution authorizing continued remote teleconference meetings of the Lakeport City Council and its legislative bodies pursuant to *Government Code* section 54953(e).
 - D. Renew Emergency Resolution: COVID-19: Confirm the continuing existence of a local emergency for the COVID-19 Public Health Emergency.

 - A. Consideration of Approval of various entitlements for the Parkside Residential Project, including a General Plan amendment, Zoning Code amendment, and approval of a Mitigated Negative Declaration under the California Environmental Quality Act: Hold a public hearing and
 1. Adopt the proposed resolution making findings to approve a Mitigated Negative Declaration for the Parkside Residential Project General Plan Amendment and Zone Change (APP 2021-31) project based on the information and findings contained in the Initial Study/Environmental Review and dated July 1, 2022."
 2. Approve the proposed General Plan Amendment revising realigning the existing *Residential* general plan land use designation boundaries for a portion of the 15.16± acre property to reflect 5.97± acres to *High Density Residential* with the findings contained in the draft Resolution

3. Approve the proposed Zone Change request to realign the existing *R-1, Low Density Residential* base zoning districts to reflect the aforementioned 5.97± acres to *R-3, High Density Residential* with the remaining 9.19± acres to continue as *R-1, Low Density Residential* with a *Planned Development Combining District* overlay with the findings contained in the draft Ordinance.
