## AFFIDAVIT FOR CONDITIONAL APPROVAL OF ALCOHOLIC BEVERAGE SALES PURSUANT TO CITY OF LARGO CODE OF ORDINANCES SECTION 4.1-(b)(5)

(address), received alcoholic beverage license approval from the City of Largo, Florida pursuant to Section 4.1-(b)(5) of the Largo Code of Ordinances based on the restaurant's representation and acknowledgment that the establishment will and is required to maintain a greater than fifty percent (50%) ratio of food and nonalcoholic beverage sales relative to total food and beverage sales as measured on an annual basis for consumption on the premises. The City of Largo may require that I provide verification by a certified public accountant of such sales ratio. I understand that the City of Largo may pursue any legal remedy available to it, which may include but is not limited to, prohibition of continued sale of alcoholic beverages for consumption on premises at/from the above location, in the event I fail to comply with the aforementioned conditions.

I further understand and attest that in the event I choose to sell or otherwise transfer the alcoholic beverage license obtained for/by the aforementioned business, I shall notify the future license holder of his/her/its obligation to execute a new Affidavit for Conditional Approval with the City of Largo and shall further notify said future license holder of the restrictions stated herein and in Section 4.1-(b)(5) of the Largo Code of Ordinances. Failure to comply with the provisions stated herein or in Section 4.1-(b)(5) may result in the City's rescinding of approval for the sale of alcohol at the above location.
