6. **OLD BUSINESS.**

- a. Tree Plantings at Pebble Beach Apartments/Stoney Lakeside Park. Rich LaBombard noted this project had been postponed until the weather is more appropriate for planting trees. A couple trees that are planted in the right of way along Bowes Road will be relocated at Pebble Beach Apartments.
- b. Tree for Jim Hall. The Arbor Board will donate \$500 in memory of a tree for Jim Hall. A location along the Riverwalk has been chosen. Don DeJong will choose the tree.
- c. M21 Project – Placement of Two New Trees. MDOT had to remove two trees at the corner of Main and Hudson. Replacement trees will be planted in the 200 block along Main Street.
- d. Tree Removal – City Hall. LaBombard requested the removal of six trees in front of City Hall along N. Monroe. The berries create a mess. Beachum suggested the idea of possibly transplanting

7. **NEW BUSINESS.**

- a. Fall Plantings. The board discussed possible fall plantings. The area behind Walgreens was considered, S. Monroe parking lot and a dedication tree for Jim Hall. Perry Beachum mentioned planting trees at Creekside Park to help block the noise created by Litehouse, Inc.

Lawarre stated she was in favor of removing the three trees near the S. Monroe parking lot.
