**5. REVIEW OF FINANCIAL STATEMENT**

City Treasurer Olin provided an updated report noting there are new governmental accounting standard boards indicating that the Grand Rapids can no longer be included in the City's audit. Olin noted there is \$2,298 available on the city books and \$42,129.61 from the Grand Rapids Foundation.

8. **NEW BUSINESS.**

Lorain Smalligan, on behalf of the Greater Lowell Chamber Foundation and John Wenger, discussed the grant request. They wish to purchase wireless microphones (upgrades and repairs), lighting upgrades and dimmers for the gallery in the theater and purchase four computer upgrades.

City Manager Mike Burns explained the grant request from the City of Lowell/Police for digital speed signs. He noted the signs would be placed on Foreman (near the schools) and Bowes Road. He indicated there is significant data proving the speed signs on Main and Hudson are effective.

The board discussed the grant request from the City of Lowell for a fence at the cemetery. It was noted Perry Beachum is also seeking private donations.
