The Customer Shall:

1. Place all refuse inside containers. There should be no accumulation on top of lids or around containers. Lids and doors should be kept closed at all times, except when being filled.
2. Nothing should be placed in the container that would extend from any opening.
3. Have the container accessible for collection when scheduled for service.
4. Provide a site for container that is readily accessible by collection vehicle on customer property. Maintenance of this site, together with the approach, shall be the responsibility of the owner.

* The City of Lufkin is not responsible for damage to drives, parking lots, sites or vehicles.*

Collection Charges (Pursuant to City Ordinance 50.50.2):

- a. Single open-top container customers. The monthly rate charged to a single commercial customer for a single container at one location shall be based on the container size and frequency of pickup. The rate to be charged is as stated in the table below.

- b. Additional pickup fee. A commercial customer requiring an additional container pickup at his/her location may so request of the driver during the regular route pickup. The charge for this additional pick will be the cubic yardage of the container multiplied by \$6.53 per cubic yard.
- c. Call in pickup fee. A commercial customer requiring garbage pickup other than his/her regularly scheduled route pickup may call the Solid Waste Department for an unscheduled pickup.

The charge for this service shall be \$55 transportation charge plus \$6.53 per cubic yard.

Items Prohibited from Containers:

(Pursuant City Ordinance 50.28)

- (A) It shall be considered an offense for any item to be placed in dumpsters that, because of size, weight, or any other physical property, could cause damage to the collection vehicle. These items include, but are not limited to, any one item over three feet in any dimension, or any one item in excess of 50 pounds, any concrete, bricks, dirt, blocks, pallets, wood or other earthen material. These items shall be placed in a roll-off container for disposal.
- (B) Tires will not be accepted. If tires are collected undetected, the customer will be charged \$5.50 per small tire and \$8.80 per large tire.
- (C) Persons, business, or other entities placing such items in containers for collection will be required to remove these items before collection can take place.
