Medical Insurance (includes vision and prescription drugs)	<p>Blue Cross Blue Shield PPO plan including health, dental, vision and prescription coverage. Prescription drug co-payment of \$20/\$60/50%/20%/25%. City funds 80% of premium.</p> <p>Any employee electing to waive health/vision coverage will receive payment each bi-weekly period that results in a monthly amount equal to the following:</p> <ul style="list-style-type: none"> • Single: 50% of Monthly Premium • 2-Person: 50% of Monthly Premium • Family: 50% of Monthly Premium <ul style="list-style-type: none"> • Any Employee retiring on or after November 16, 2020 at age 55 or over and having 25 years or more years of continuous and credited service with MERS, the City will pay 50% of the cost of the retiree’s group hospitalization coverage and the retiree will pay the balance of the single subscriber rate as well as the cost of coverage for his/her dependents. Coverage will continue until the retiree is age sixty-five (65). • Any Employee retiring on or after November 16, 2020 at age 55 or over and having 30 years or more of continuous and credited service with MERS, the City will pay 100% of the cost of the retiree’s group hospitalization coverage for the retiree only. Retiree will pay the cost of coverage for his/her dependents. Upon reaching the age of sixty-five (65) a retiree will no longer receive any retiree healthcare from the City but will, instead receive a monthly stipend of two hundred seventy-five dollars (\$275.00) per month. • Any employee hired on or after November 16, 2020 who retires with the requisite years of service shall be ineligible for any retiree healthcare from the City but will instead, receive a monthly stipend in the amount of two hundred seventy-five dollars (\$275.00) until the retiree reaches age sixty-five (65). • At age sixty-five (65) this stipend will no longer be paid. <p>Any Employee who hires on after July 1, 2023, will not be eligible for any payment towards hospitalization coverage when they retire.</p>	Date of Hire

Residency Bonus	<p>A Residency Bonus will be paid to all Union Represented employees with a current Memorandum of Understanding Accepting this benefit.</p> <ul style="list-style-type: none">• Employees who reside within the City’s limits will receive a Residency Bonus equal to three percent (3%) of their salary.• Residency Bonus payments will be made in bi-weekly increments as long as an employee’s primary residence is within the City’s limits.• Employees are required to sign an acknowledgment statement of the Residency Bonus policy <p>Employees are required to notify the City immediately if their residency status changes.</p>	Date of Hire
