CITY OF MASON ELECTION COMMISSION RESOLUTION 2018-01

July 9, 2018

RESOLUTION ESTABLISHING A RECEIVING BOARD FOR ELECTIONS HELD IN THE CITY OF MASON

WHEREAS, the City Clerk, is responsible for conducting elections in The City of Mason; and

WHEREAS, MCL 168-679(a) provides the Election Commission of a city, township, or village shall, by resolution, provide that at an election at which the ballots are counted and certified at the precinct, 1 or more additional boards of election inspectors be appointed to serve as Receiving Boards; and

WHEREAS, the City of Mason Receiving Board is responsible for the duties as outlined in Section 168-679(a) of the Michigan Election Law (Article 116 of 1954); and

WHEREAS, the board of election commissioners shall appoint two or more election inspectors, with an equal number from each major political party to the Receiving Board prior to each election;

NOW, THEREFORE, BE IT RESOLVED, the Election Commission authorizes the establishment of a Receiving Board and the appointment of two or more election inspectors, with an equal number from each major political party, for all future elections beginning August 7, 2018.
