"Red light Red light cameras do not capture the speed **enforcement cameras** of a vehicle. A red light camera (or red light and speed cameras enforcement camera) is a type of traffic enforcement camera that captures an image of a vehicle if it has entered an intersection in spite of the traffic signal indicating red/ stop. By automatically photographing vehicles that run red lights (or fail to make a complete stop before making a right turn), the municipality secures evidence that assists authorities in their enforcement of traffic laws.

Red light camera violations are considered "moving violations" that will affect a person's driving record.

Violations are considered "non-moving violations" and do not affect a person's driving record.

- **01** Red light cameras save lives.
- Red light camera programs cost ONLY those who BREAK THE LAW
- Motorists are more likely to be injured in urban crashes involving red light running than in any other type of motor vehicle accident.
- The goal of a red light camera enforcement system is to improve public safety for drivers and pedestrians.
- Red light cameras help reduce fatalities and injury-related car crashes at intersections.
- Red light cameras help reinforce safe driver behavior.
- Red light cameras allow police officers more time for community policing.
- Red light camera violations do not affect a person's driving record.
- Red light camera violations are considered "non-moving" violations and are issued to the registered owner of the vehicle, regardless of who committed the violation.
- Before a violation is issued and mailed out, video of the possible violation has been reviewed by municipal law enforcement personnel and support technicians at least four times.

The red light camera safety program at our intersections will help reduce the high number of traffic incidents in those areas. This will also help to reduce resources needed in those areas, allowing those resources to be reallocated to other needed areas.

In 2014, there were 73 crashes alone at Lincoln Hwy and Cicero Ave. In 11 of those accidents, there were serious personal injuries including one fatality. We know that by taking this precaution, we will reduce the number of vehicle collisions while increasing driver and pedestrian safety in Matteson. Even one crash is one too many.
