ORDINANCE NO. 2023-02

AN ORDINANCE TO AMEND ORDINANCE NO. 2022-06 WHICH PROVIDED FOR THE APPLICATION, LICENSING, AND REGULATION OF MEDICAL-USE MARIHUANA ESTABLISHMENTS AND PENALTIES FOR THE SUSPENSION AND REVOCATION THEREOF, TO AMEND ARTICLE II, SECTION 5(C) TO CORRECT A CROSS REFERENCE TO ANOTHER CITY ORDINANCE.

THE CITY OF MILAN HEREBY ORDAINS:

Section 1. Amendment to Ordinance 2022-06, Article II, Licensing of Medical-Use Marihuana Establishments, Section 5(C) Limitation on Permits. That the Milan City Code of Ordinances, Ordinance 2022-06, Article II, “Licensing of Medical-Use Marihuana Establishments”, Section 5(C) “Limitation on Permits”, is hereby amended to read as follows:

Section 5. Limitation on Permits.

(C) The total number of Provisioning Centers, when combined with the total number of Retailers under City ordinance **No. 2022-07**, shall not exceed two, unless a Person is operating both a Retailer and Provisioning Center in the same Premises, in which case up to two each of Retailer and Provisioning Centers may operate, so long as both the Retailer and Provisioning Center are operating out of the same Premises.

Section 2. Public Health and Safety. This Ordinance is declared necessary for the preservation of the public peace, health, safety, and welfare of the people of the City of Milan.

Section 3. Repealer. All Ordinances or parts of ordinances in conflict herewith are hereby repealed only to the extent necessary to give this Ordinance full force and effect.

Section 4. Severability. Should any word, phrase, sentence, paragraph or section of this Ordinance be held invalid or unconstitutional, the remaining provisions of this ordinance shall remain in full force and effect. It is hereby declared to be the legislative intent of this body that the Ordinance would have been adopted had such invalid or unconstitutional provisions not have been included in this Ordinance.

Section 5. Savings Clause. The balance of the Code of Ordinances, City of Milan, Michigan, except as herein or heretofore amended, shall remain in full force and effect. The repeal provided herein will not abrogate or affect any offense or act committed or done, or any penalty or forfeiture incurred, or any pending fee, assessments, litigation, or prosecution of any right established, occurring prior to the effective date hereof.

Section 6. Copies to be available. Copies of the Ordinance are available at the office of the City Clerk for inspection by, and distribution to, the public during normal office hours.

Section 7. Effective Date. As provided by Section 7-3 of the Milan City Charter, the effective date of this ordinance shall be ten (10) days after its adoption and publication of a summary thereof as required by Subsection 7-4(b) of the Milan City Charter, which summary shall read as follows:

The Milan City Council has approved Ordinance No. 2023-02, which ordinance amends the Milan City Code of Ordinances to amend Ordinance 2022-06, Article II “Licensing of Medical-Use Marihuana Establishments”, Section 5(C) “Limitations on Permits”, to correct a cross reference to another city ordinance. Printed copies of the full text of Ordinance No. 2023-02 are available for inspection and purchase by the public at the office of the City Clerk during regular business hours, 8:00 a.m. to 4:00 p.m., Monday through Friday. Ordinance No. 2023-02 is effective ten (10) days after adoption and publication of this summary notice.
