Mount Laurel Form of Government Q&A

WHAT FORM OF GOVERNMENT OPERATES IN MOUNT LAUREL?

The Township of Mount Laurel operates under a Council-Manager Plan E of Chapter 210 of New Jersey Laws of 1950. The Township Council consists of 5 members elected at large with staggered terms.

WHY IS THERE A MAYOR CHANGE EVERY YEAR?

The Council appoints one of its members to serve as Mayor for a term of one year. They also appoint a Deputy Mayor to serve in the absence of the Mayor. The day-to-day operation of the Township is handled by a full time Township Manager, who is the chief executive and administrative officer appointed by the Township Council.

On Saturday, January 1, 2022 U.S. Senator Cory Booker administered the oath of office to Mount Laurel Mayor Kareem Pritchett. Mayor Pritchett served as Deputy Mayor in the 2021 calendar year.

Assemblywoman Carol Murphy administered the oath of office to Mount Laurel Deputy Mayor Stephen Steglik.



A Message from Mayor Kareem Pritchett

As I begin my term as Mayor, I understand the responsibility that comes with the milestone of being Mount Laurel's first Black Mayor. I will continue to ensure that every voice has a seat at the table.

With the challenges that 2021 presented us, our council was able to fulfill a tremendous list of accomplishments that my colleagues should all take great pride in.

During my remarks last year as Deputy Mayor I stated that this council will turn your voices into actions. We've done just that.

We completed a communications overhaul, with a new transparent website, updated social media channels, and quarterly newsletters for our residents. We established the Environmental Commission, who will provide guidance regarding environmental considerations for local projects. We passed a budget of no tax increases.



I've stated that the rich diversity of our Township is what makes Mount Laurel strong. Our creation of the Diversity and Inclusion Board is one our council is truly proud of. The board will serve the community by hearing and learning about the experiences of our residents.

I hold a background in law enforcement and have had a long career as a correctional police officer, focusing on creating stronger ties between law enforcement and the communities they serve. Facilitating positive community policing not only strengthens law enforcement knowledge of a community's need, it creates transparency and trust.

I strongly believe community policing has and will continue to improve communication between law enforcement and diverse communities. Through a continuing series of discussions, myself, community leaders, and law enforcement outlined details of what steps are taken when an issue arises in a community. While a select few threaten to tear apart the thread that holds us together, our diversity is what strengthens that thread.

I encourage Mount Laurel residents to attend meetings, come to Township events, and make your voices heard. Let's continue to make great progress.

Township of Mount Laurel Introduces New Boards and Commissions

Boards and Commissions have the power to make a substantial difference in our community, whether it's developing new environmentally friendly initiatives or implementing programs to showcase Mount Laurel's diversity. The Township currently has seven boards and commissions.

Mount Laurel Township is proud to present the establishment of the Environmental Commission and the Diversity and Inclusion Board. These boards stand to highlight issues facing our community and showcase positive solutions.

The Environmental Commission is a seven-member commission comprised of 6 citizen appointees of the Township Council. The Commission will provide guidance regarding environmental considerations for local projects. The board will make recommendations and provide advice concerning open space preservation, storm water management, sustainability practices, recycling and landscape protection, and the protection and improvement of recreation sites.

The Diversity and Inclusion Board is comprised of six members of the general public appointed by the Mayor with the advice and consent of the Township Council. The board advises the Mayor, Township Administration, the Town

Council, and residents of the Mount Laurel community on exploring their differences, embracing and understanding challenges, and capitalizing on the true strength of Mount Laurel's diverse community. The board will develop public education programs, hold community discussions, and provide trainings designed to develop mutual respect and inclusion.

Township Council members serve on the Township's boards and commissions through appointments that are changed every year.

Mayor Kareem Pritchett will serve on the Township Planning board and the Diversity and Inclusion board. The Planning Board is responsible for overseeing development applications for subdivision, site plans and for the preparation of the Township's Master Plan.

Councilwoman Fozia Janjua will serve on the Library Board of Trustees. This nine-member board is in charge of oversight, management, and policy directives of the Library.

Councilwoman Karen Cohen serves on the Township planning board and will be a non-voting council liaison to the environmental commission.

Tax Assessor's Office

- Resident homeowners who are currently receiving a \$250 deduction for Senior Citizen, Disabled Person or Surviving Spouse will be receiving the Annual Post-Tax Year Income Statement along with the Supplemental Income Form in the mail. These forms will reflect your 2021 income information. Please remember to return both forms completed and signed to the Tax Collectors office **no later than March 1, 2022**. Please be advised that failure to return the completed forms by the deadline will result in you being disallowed the deduction of \$250 that you have already received for the 2021 tax year.
 - ◆ For information about State Property Tax Relief Programs, including eligibility criterion and potential deduction or credit amounts, please visit the Division of Taxation's website at: <https://www.state.nj.us/treasury/taxation/relief.shtml>.
- **Please note the 2022 1st quarter property taxes are due on February 1, 2022.** All tax payments received after Thursday, February 10, 2022 will accrue interest back to February 1, 2022.
- The township offers an ACH Direct Debit program for property taxes. If you are interested in participating, please check our township website for more information, including the application.
- Taxes are due February 1, May 1, August 1, and November 1. Your current tax bill covers the last half of the current year and the first half of the following year. New tax bills are mailed in August of every year.

HOW DO I PAY MY TAX BILL?

Please note all options to pay your tax bill:

- Mail a check or money order made payable to: Mount Laurel Township, 100 Mount Laurel Road, Mount Laurel NJ 08054
- There is a walk up window dedicated specifically to the Tax Collector and Assessors office at the Municipal building. Residents are able to drop off their bill Monday-Friday from 8AM-4PM.
- Drop off your check or money order to the Municipal building. There is a security drop box located at the main entrance of the building on the right attached to the wall. It is marked in red "Tax Collector's Office."
- You can also make payment online through our website at www.mountlaurel.com. Look on the quick links tab on the homepage "Pay Taxes Online."
- Please note that we will not be accepting any cash payments at this time.

Veterans, Senior Citizens, Disabled Persons Property Tax Deductions

Any resident property owner who qualifies can receive an annual deduction from their property taxes if you are a Senior Citizen, Disabled Person or Veteran. For approved applicants a \$250.00 per year deduction is applied to the property tax bill. Property Taxes and Fire Damage

Tragically, throughout the year, there are homes that suffer fire damage. Such an event starts a process of insurance adjustors, fire department reports, contractors, permitting and inspections. With all of the activity one thing often gets overlooked – property taxes. As soon as practical it is important that the property owner contact the Township Assessor. New Jersey statutes strictly regulate when an assessment can be adjusted for "material depreciation" from fires, storms, and demolition. The sooner the Assessor knows about the incident the better. Notice of damage starts a process in the Assessor's Office which entails collecting fire department reports and Construction Office information. An on-site inspection also will help determine the extent of damage. Once the data collection is complete the Assessor will reduce the building assessment, which is usually reflected on the following year's tax bill.

Snow Removal

Our Public Works Department and contractors work hard to make driving safer and easier in snowy weather. The type of snow storm we receive affects the type of snow clearing operation that takes place and with heavy amounts of snow fall, the Township and contractors may plow your street several times. As snow rolls off the plows, it sometimes accumulates in driveway aprons. Please understand that this is unavoidable and it is the homeowner's responsibility to clear it. Here are some helpful tips to make the snow removal process easier for residents and the Township:

Please remove the following items from the street in front of your home:

- Trash/recyclable containers. Place on the grassy planter strip between curb and sidewalk where possible.
- Portable basketball systems, hockey nets, or any other movable sporting equipment.
- Do not park cars on the street during the storm and at least for 12 hours after the storm. This speeds the removal process, prevents cars from being plowed in, and allows us to clear the entire street curb to curb.
- Please don't shovel or blow snow back on the street. If we already completed plowing this will create a hazard for residents.
- Shovel snow to the right side of your driveway (facing the street) to minimize the amount of snow entering your driveway.

Plastic Pollution Reduction Act

Starting in May 2022 the Plastic Pollution Reduction Act will go into effect. The act prohibits provision or sale of single-use plastic carry out bags and polystyrene foam food service products. The Act also limits provision of single-use plastic straws. This bill is a significant step to reduce harm and pollution that these products cause to our environment.

The Green Team would like to remind residents of environmentally friendly alternatives:

- Bring a reusable bag to the grocery store to hold items. This can be made from nylon, cloth, hemp product, or other machine washable fabric.
- Reusable metal straws can be used at restaurants and when ordering single use iced drinks to-go at establishments.
- Pack your lunch in reusable containers and bags.
- Buy fresh fruits and veggies and bulk items instead of products that come in single serving containers.

To report an outage by phone call 1-800-436-PSEG (7734) or text "OUT" to 4PSEG (47734) - Register your phone first by texting "REG" to 4PSEG.

To report a gas leak, downed wires, or other hazardous condition, LEAVE the area and get to a safe location. Then call PSE&G at 1-800-436-PSEG (7734) or call the Emergency Line at 1-800-880-PSEG (7734).

FINE FREE!

The library has recently joined the growing number of libraries across the country that are eliminating overdue fines. The library has been fine free since March 2020 but now that change is permanent.

This is happening as libraries have realized that overdue fines can discourage use of the library by those who need it most. Overdue fines have been an economic barrier for the most vulnerable in our community. Libraries that have already made the change have found that use of the library has increased without any significant impact on the timely return of checked out items.

There will still be accountability since borrowing privileges will be suspended when an item is more than 14 days overdue, and after 30 days a bill for the replacement cost will be sent. Once overdue items are returned or paid for, borrowing privileges will be restored. There will also still be an overdue fee for Museum Passes since they are in high demand and their scheduled use by others can be impacted.

Additional Walk Up Windows at Municipal Building

RANCOCAS WOODS VILLAGE AND SHOPS

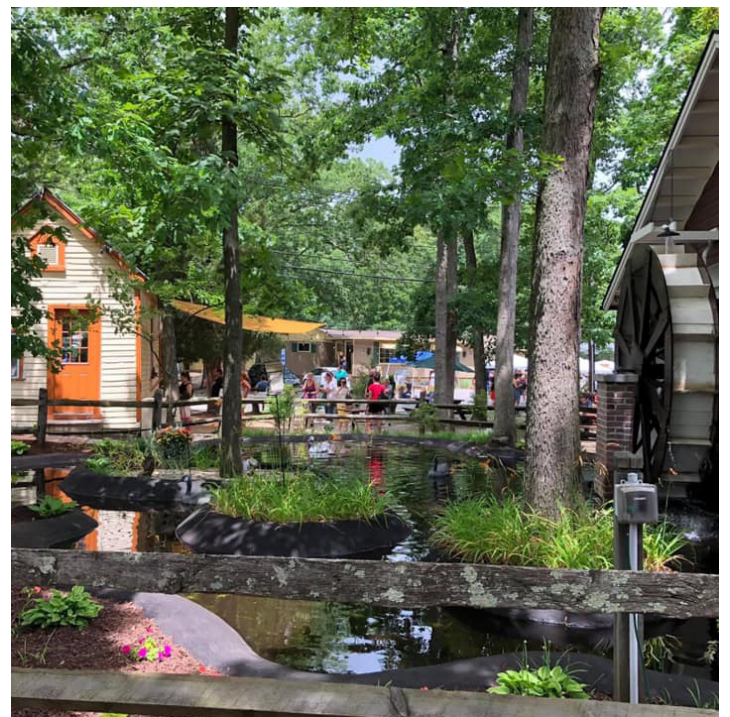
Rancocas Woods Village and Shops, located at 118 Creek Road, offers residents a variety of specialty stores in a relaxed cozy setting.

WHAT'S HOT?

After 20 years of front-line service, Engine 3621, which used to be housed at Station 362 (Church Road Firehouse) has been donated to the Burlington County Emergency Services Training Center. The Engine will be used to train firefighters from all over the county for many years to come.



End of the Year Training: Escape System Refresher

Our firefighters are equipped with mission-specific exterior body harnesses to aid them in completing their job tasks at emergencies. Each firefighter wears a personal escape system that is attached to their harness. This piece of equipment allows firefighters to escape from life threatening situations, especially from elevated floors if their means of egress is obstructed by fire or debris. All members train with this gear biannually, using our self-constructed window prop located at headquarters. This ensures that our techniques are always sharp if we ever need them on the fireground.



Winter Fire Safety Reminder

HOME FIRE SAFETY TIPS:

- Consider having it inspected by a professional and keep all combustibles at least 3 feet away.
- Test your smoke and carbon monoxide detectors monthly

- Keep candles away from anything that can burn
- Always have a plan to escape!

Mount Laurel Township EMS Training

Mount Laurel Township EMS Training Division will again be holding its Initial EMT Course starting on January 3rd, 2022. This course is open to all individuals who are interested in obtaining their NJ EMT Certification. Educating future EMT's is an integral part of maintaining quality pre hospital providers in the State of NJ.

Over the course of 2021 Mount Laurel Township EMS Training Division has trained a total of over 200 people in classes such as: EMT Initial Training, EMT Refresher Classes, BLS CPR classes, Human Trafficking education, Domestic Violence Awareness education and Overdose and Addiction education to pre hospital providers.
