### Tax Assessor

### TOTALLY DISABLED VETERANS (100% PERMANENT AND TOTAL)

If you are a 100% permanently and totally disabled veteran (or surviving spouse) and have a 100% rating issued by the Office of Veteran's Affairs (VA), you may be eligible for property tax exemption. The basic requirements are honorable discharge, a 100% permanent and total disability rating certification from the VA, and the property you seek exemption for must be your primary residence. Along with the application form, applicants must supply a copy of the DD Form 214 or discharge papers, a deed to the property showing the applicant as owner, proof of residency in the home, and a copy of a current NJ Driver's License. ### **VETERAN TAX DEDUCTION**

Veterans can apply for a yearly tax deduction of \$250.00. To qualify, you must be a NJ resident, be on the deed as an owner of the property, have an honorable discharge, and be able to provide a DD Form 214 or discharge papers. Applications are available online at www.mountlaurel.com or at the Township Tax Assessor's Office.

### SENIOR CITIZEN OR DISABLED PERSON TAX DEDUCTION

Any resident property owner who qualifies can receive an annual deduction from their property taxes if they are a Senior Citizen (65 or over) or Disabled Person. A \$250.00 per year deduction is applied to the property tax bill for approved applicants. NJ State guidelines limit household income to qualify. Social Security or government pensions can be excluded, but any income outside of that is capped at \$10,000.00 per year. Applications are available online at www. mountlaurel.com or at the Township Tax Assessor's Office.

### TAX ASSESSMENTS AND IMPROVEMENTS

If you have a construction permit for a new home or improvement to your existing home, the Tax Assessor's Office is required to inspect the work to determine whether or not an added assessment is in order. Each new home or completed taxable improvement is added to the township tax system by an added assessment. Added assessments are issued in October and are retroactive to the completion date. Tax bills for that period are issued in October as well. Before billing, the Assessor's Office will send an Added Assessment notice informing you of the additional property value, description of work, number of months, and estimated supplemental tax. Added assessment inspections commence the first week in May and will continue through September. The inspector will speak to you at the time of your inspection or will leave a contact number to verify the work.

### TAX BILLS COMING SOON!

- Property Taxes are billed once a year. The 2023 Final / 2024 Preliminary bills are scheduled to be mailed around July/August of 2023. The due date for 3rd quarter taxes is normally August 1st. However, bills cannot be mailed out until the new 2023 tax rate is struck by Burlington County. If bills are mailed late, the new due date will be printed on the 2023 3rd quarter stub, which will be 25 days from the date the bill was mailed.
- If you receive an "Advice Only" tax bill but do not have a mortgage company, please notify the tax office and use this bill you received to pay your taxes.
- \*\*We will update our website with any information as soon as it becomes available.

### **DIRECT DEBIT PROGRAM**

The Township offers an ACH Direct Debit program for property taxes. If you are interested in participating, please check our Township website, www.mountlaurel. com, for more information.

### SENIOR FREEZE APPLICATIONS

Residents currently enrolled in the "Senior Freeze" Property Tax Reimbursement program who received their booklet in the mail may stop by our office during business hours to complete their application. They are due to be returned to the State of New Jersey no later than October 31st, 2023. We will be completing the booklets in the Mount Laurel Community Center on Thursday, October 19 from 10:00 AM to 12:00 PM. ### **Township of Mount Laurel Board Positions**

### TOWNSHIP OF MOUNT LAUREL BOARD POSITIONS

Boards and Commissions have the power to make a substantial difference in our community, whether it's developing new environmentally friendly initiatives or implementing programs to showcase Mount Laurel's diversity. The Township currently has seven boards and commissions.

To apply for a board position please visit www.mountlaurel. com and click on "Board Positions" under the Government tab on the website. Board positions are appointed at reorganization unless a vacancy occurs during the year.

### **PLANNING BOARD**

The Planning Board is a nine member board with six citizen members who are appointed to staggered four year terms. There are also two alternate members appointed to staggered two year terms. The Planning Board is responsible for overseeing development applications for subdivision, site plans and for the preparation of the Township's Master Plan. Meetings are held on the 2nd Thursday of the month at 7:00 PM.

#### ZONING BOARD OF ADJUSTMENT

The Zoning Board of Adjustment is a seven member board comprised of all citizen appointees of the Township Council. They are appointed to staggered four year terms. There are also two alternate positions appointed to staggered two year terms. The Zoning Board is responsible for development applications that do not conform to the Township Zoning standard as it exists in Chapter 154 of the Municipal Code. The Board has the authority to grant a variance from the strict application of the zoning ordinance. Meetings are held on the 1st Wednesday of every month at 7:00 PM.

### LIBRARY BOARD

The Library Board of Trustees is a nine member board with seven citizen members who are appointed to staggered five year terms. The Trustees are charged with the long term oversight, management and policy directives of the Library. Meetings are held on the 3rd Wednesday of the month at 6:00 PM.

### **ENVIRONMENTAL COMMISSION**

The Environmental Commission is a seven member commission comprised of 6 citizen appointees of the Township Council. The Commission will provide guidance regarding environmental considerations for local projects. The board will make recommendations and provide advice concerning open space preservation, storm water management, sustainability practices, recycling and landscape protection, and the protection and improvement of recreation sites. The Environmental Commission meets on the second Tuesday of each month at 7pm.

### **MUNICIPAL UTILITIES AUTHORITY BOARD OF TRUSTEES**

The Municipal Utilities Authority Board of Trustees is a five member board comprised of all citizen appointees of the Township Council. Members are appointed to staggered five year terms. The MUA Board of Trustees oversees all management and oversight of the township water and sewer infrastructures. This includes long term policy and planning development, water purchasing and allocation, water and sewer rate determination, infrastructure repair and replacement and system expansion. Meetings are held on the 3rd Thursday of the month at 7:00 PM.

### **DIVERSITY AND INCLUSION BOARD**

The Diversity and Inclusion Board is comprised of six members of the general public appointed by the Mayor with the advice and consent of the Township Council. The board advises the Mayor, Township Administration, the Town Council, and residents of the Mount Laurel community on exploring their differences, embracing and understanding challenges, and capitalizing on the true strength of Mount Laurel's diverse community. The board will develop public education programs, hold community discussions, and provide trainings designed to develop mutual respect and inclusion. The Diversity & Inclusion Board meets on the first Tuesday of each month at 7:00 PM.

### **GREEN TEAM BOARD**

The Green Team Board is a four member board comprised of citizen appointees of the Township Council and five standing members from various Township interest groups. They are appointed to a one year term. There is also one alternate position appointed to one year term. The Green Team Board is responsible for development of policies and procedure recommendations to Council to improve and foster a community that is sustainable economically, environmentally and socially.

### Former NBA Player Jason Thompson Gives Back To The Mount Laurel Community

The market will take place every Sunday from June 4th - October 15th . Hours are 10 AM - 2 PM. The market is located at 200 Creek Road Unit C.


### **Rancocas Woods Boos & Brews**

### **Public Works**

#### HAZARDOUS WASTE DROP-OFF

The Township holds a hazardous material drop-off on **the first and third Saturday of every month (unless it's a holiday weekend, then it will be moved to the following weekend).** Drop-off is at the Recycling Center on Midlantic Drive. Hours of operation for the drop-off are **8:00 AM to 12:00 PM.** Residents are required to show proof of residency at the drop-off. Allowable items: Paint(latex and oil-based 10 cans per resident), solvents, driveway sealers, aerosols, antifreeze, oil, batteries, fluorescent tubes and ballasts, pesticides, pool chemicals, and gasoline (which should be brought in a clearly marked container).

\*Paint that is dried out can go out with your regular trash.

\*Oil must be dropped off in standard oil containers only. It will not be taken in buckets or other chemical containers.

#### **APPLIANCES**

Any appliance or air conditioner will be picked up Wednesdays. Residents must call or email Public Works at info@mountlaurel. com to schedule the pick-up. We also pick up basketball hoops, certain sized equipment, and grills.

#### **TELEVISIONS AND COMPUTERS**

These will be picked up on Wednesdays. Residents must call to schedule a pick-up or email info@mountlaurel.com

#### **TIRE COLLECTION**

Car and truck tires (excluding tractor-trailer tires) must be removed from the rims. Tires are picked up on the third Friday of each month except for the months between Memorial Day and Labor Day, where they will be picked up on the 3rd Thursday of the month. Residents must call Public Works to schedule the pick-up. Burlington County residents can also take tires, on or off the rim, to the Burlington County Resource Recovery Complex.





### **EXTREME RISK PROTECTION ORDER/RED FLAG LAWS**

When a person is in crisis and considering harming themselves or others, they often exhibit clear warning signs. Family members and law enforcement are usually the first people to see these signs.

But there is one thing you can do: you can request an extreme risk protective order to temporarily remove guns from the situation and help keep your loved one safe.

NJ is fortunate to be one of 19 states nationwide with an Extreme Risk Protective Order law in place. This law empowers loved ones or law enforcement to intervene and temporarily prevent someone in crisis from accessing firearms. These laws, sometimes referred to as "red flag" laws, can help de-escalate emergency situations. They are a proven way to intervene before an incident of gun violence—such as a firearm suicide or mass shooting—occurs and takes more lives.

To seek an extreme risk protective order, a family or household member can fill out and file the application directly with the court. Family or household members can also contact a member of law enforcement, such as a police officer or District Attorney to discuss any concerns. Law enforcement can then investigate these concerns and request the extreme risk protective order from the court. Please contact the Mount Laurel Police Department at (856) 234-8300 with any questions.

The federal government offers 24/7 call, text, and chat access to trained crisis counselors who can help people experiencing suicidal, substance use, and/or mental health crisis, or any other kind of emotional distress. Dial 988 to receive immediate support. People can also dial 988 if they are worried about a loved one who may need crisis support.

### OUTSIDE FIRES (BARBEQUES AND FIRE PITS)

With summer soon upon us, many residents choose to have different types of outdoor fires for warmth, cooking, or other uses. Please see the rules governing outdoor fires from the township fire prevention ordinance below.

you can reference Chapter 81,

Fire Prevention of the Township

- **1.** Fuel for outdoor fires shall be limited to seasoned firewood, natural gas or propane. Do not use accelerants, such as flammable fuels.
- **2.** Fire pits shall not exceed three feet in diameter and two feet in height total fuel area.
  - **a.** Fire pits shall not be located within 25 feet of a structure, combustible materials, combustible vegetation and/or property lines.
- **3.** Fire in approved containers is defined as chimineas and/or other commercially manufactured containers designed and built for its specific use for seasoned firewood, natural gas, or propane.
  - **a.** Approved containers shall not be located within 15 feet of a structure, combustible materials, combustible vegetation and property lines.
  - **b.** Approved containers shall not be located in or on any residential/apartment unit; porch, balcony, covered patio area or any other private area of an apartment or multifamily dwelling unit.

### Mount Laurel Emergency Medical Services EMS System and Mutual Aid - How it Works

Recently, we have had several residents ask why an ambulance from another township may be responding in Mount Laurel. The following will provide you with an overview of how our emergency medical services (EMS) system is staffed and how mutual aid works. This pertains to basic life support (BLS) services. Advanced life support (ALS) is hospital based, managed by the Virtua Hospital System in coordination with the Burlington County Communication Center.



- Current demands on EMS for our community require two 24/7/365 ambulances, with an additional ambulance staffed during peak hours Monday through Friday, 9am to 7pm.
- This standard of coverage model has evolved over the years and is continually monitored to ensure that our call data continues to support this model.
- While the standard of coverage is modeled off historical call data, there are times when we are confronted with several calls simultaneously that exceed our capabilities, also known as a surge. Surge activity is difficult to forecast or handle. This presents a unique challenge where calls are triaged, with life threatening calls placed at a higher priority. During these instances, Mount Laurel


Duty), rank of Major, with 12 years of service. He is currently assigned to the 305th Air Mobility Wing (Joint Base McGuire-Dix-Lakehurst) as an airfield operations flight commander. We thank EMT Parent for his service, dedication, and leadership and we wish him well on his new assignment in July 2023 in Madrid, Spain. EMS (MLEMS) has "Mutual Aid Agreements" in place with surrounding EMS agencies to respond. As a participant in the mutual aid system, we receive support and we also provide support to other towns who may be in a similar situation.

□ In March of 2023, for example, Mount Laurel Township received mutual aid assistance 25 times and provided mutual aid assistance 20 times.

While we prefer to respond to 100% of our incidents, we know that this is not realistic. Another tier built into our EMS system is the Mount Laurel Fire Department's (MLFD) first responder program. The majority of MLFD's firefighters are cross trained as emergency medical technicians. The MLFD is dispatched along with MLEMS to all serious life threatening calls, e.g. cardiac arrest, unconscious persons, etc. In addition, the MLFD is dispatched to any medical calls when an MLEMS ambulance is not available to respond in town and where a mutual aid ambulance has been dispatched. This provides our community with timely access to emergency medical care, while waiting for an ambulance to become available. This service delivery model provides for timely access and the highest level of quality care offered to those in need in our community.

On June 19, 1865, Union soldiers arrived in Galveston Bay Texas with news that the Civil War had ended. A federal order was issued to abolish slavery in accordance with the Emancipation Proclamation, and this day became known as Juneteenth. The day serves to commemorate the freedom of those who had been enslaved in the United States.

Juneteenth officially became a federal holiday in 2021 and marks the United States' second Independence Day.

The Township held our first Juneteenth Event on Saturday June 17, 2023. Mount Laurel Township and Township Council are committed to our diverse communities and encourage all residents to recognize the significance of Juneteenth in our nation's history.
