

Update on PAWS Farm

On Wednesday, September 13th, Mount Laurel Township, Volunteers for PAWS Farm, and the Shreiber School of Veterinary Medicine of Rowan University announced that PAWS Farm will be run by the new state veterinary school starting in January 2024. As the current organization running the 10-acre property concludes its time there, Katherine Tweedy of Volunteers for PAWS Farm said, "The Board of Volunteers For Paws Farm, Inc. has diligently and tirelessly repaired and restored all the buildings and grounds of the Paws Farmstead and opened it to the public for the last two summers and is now prepared to turn over this historic and now beautiful Mount Laurel Township property to the new Shreiber School of Veterinary Medicine of the outstanding and exemplary Rowan University to preserve and to enhance our beloved Paws Farm."

Dr. Matthew Edson, Founding Dean of the veterinary school, stated, "Part of our school's mission is to collaborate with partners in the community to broaden the impact of education in veterinary medicine, and this fits perfectly with that. We see PAWS Farm as an important component of how we want to connect with people in our area to increase understanding of the importance of animals in our lives. This facility will advance our mission of introducing people of all ages and backgrounds to opportunities in veterinary medicine they may have never considered before." The school is expected to welcome its first class in 2025, pending accreditation approval from the American Veterinary Medical Association Council on Education.

State Assemblywoman, Carol Murphy, said, "As an advocate for animals, both on the farm and in our homes, the funding and programs for PAWS Nature Center and now the Shreiber School of Veterinary Medicine are essential in keeping our friends healthy and educating our future animal care providers. I will always do what I can to fight for our community and continue the success and growth of PAWS' original mission."

"The PAWS Farm Nature Center has long been a beloved, community recreational and educational space that offers hands-on learning experiences for families and their children. It is especially fitting that the Shreiber School of Veterinary Medicine of Rowan University will be running this site, as it is uniquely positioned to foster such programming which will continue to open the eyes of children of all backgrounds to the career possibilities in the veterinary industry. We knew that there would be great value in South Jersey being home to a vet school and partnerships like this underscore the benefits it brings to our communities," said Senator Troy Singleton who advocated for state funding for the vet school, and represents Mount Laurel as part of the 7th Legislative District.

The school seeks to maintain the spirit of this historical property while creating new opportunities to educate people about animals and veterinary medicine. "As the first veterinary school in New Jersey, we are honored to commence stewardship of PAWS Farm and hope to inspire young people to consider veterinary medicine as a future career path," said Dr. Suzie Kovacs, Associate Dean for Student Success at the Shreiber School of Veterinary Medicine. Dr. Kovacs will oversee the team running programming at PAWS Farm once it is in place.

There will be a transition period before new programming takes place on site. Dr. Kovacs commented, "We are being very thoughtful about how we proceed. We are currently in the process of hiring the on-site team, developing curriculum, and making plans for the community. We will let the public know about upcoming events and educational opportunities as things come to fruition in the new year. We want to make this a place where people who remember it from their childhood will enjoy bringing their own children and grandchildren here. There will be many new memories made at PAWS Farm." The school plans to keep the traditional experience alive and well through public access and plenty of programs for youth and families.

Mount Laurel Mayor, Stephen Steglik, commented, "This is great news for our township, which places community first. As a Green Acres location, PAWS Farm is an important part of our town's history, and with the active participation of Rowan University, will remain an important part of its future. When Paws closed right before Covid we made a commitment to the residents that we would continue to work to find a long term solution. We know there was skepticism based upon everything that was happening around the world. After much hard work, today, we are pleased to announce we have kept this promise." Fozia Janjua, Deputy Mayor for Mount Laurel Township, said, "The people of Mount Laurel are passionate about building their town into a strong community, and I am pleased to see Rowan University putting real effort into the same."

4TH QUARTER PROPERTY TAXES DUE

Please note that all 4th quarter property tax payments are due Wednesday, November 1, 2023. The statutory grace period is Friday, November 10, 2023. However, due to the 10th falling on a holiday and the Township building being closed, the extended grace period will be Monday, November 13, 2023. All payments received after Monday, November 13th will accrue interest back to November 1st.

SENIOR FREEZE BLUE BOOKLETS- PTR FORMS

If you are currently enrolled in the New Jersey Senior Freeze (Property Tax Reimbursement) Program, the last day to file your application is October 31, 2023. We will be completing the booklets in the Mount Laurel Community Center on Thursday, October 19th from 10:00 AM to 12:00 PM. TOTALLY DISABLED VETERANS (100% PERMANENT AND TOTAL)

If you are a 100% permanently and totally disabled veteran (or surviving spouse) and have a 100% rating issued by the Office of Veteran's Affairs (VA), you may be eligible for property tax exemption. The basic requirements are honorable discharge, a 100% permanent and total disability rating certification from the VA, and the property you seek exemption for must be your primary residence. Along with the application form, applicants must supply a copy of the DD Form 214 or discharge papers, a deed to the property showing the applicant as owner, proof of residency in the home, and a copy of a current NJ Driver's License. The application is available online at www. mountlaurel. com or you may contact Dennis DeKlerk, Tax Assessor, at ddeklerk@mountlaurel.com or 856- 234-0001 x1256 or x1257.

VETERAN TAX DEDUCTION

Veterans can apply for a yearly tax deduction of \$250.00. To qualify, you must be a NJ resident, be on the deed as an owner of the property, have an honorable discharge, and be able to provide a DD Form 214 or discharge papers. Applications are available online at www.mountlaurel.com or at the Township Tax Assessor's Office.

SENIOR CITIZEN OR DISABLED PERSON TAX DEDUCTION

Any resident property owner who qualifies can receive an annual deduction from their property taxes if they are a Senior Citizen (65 or over) or Disabled Person. A \$250.00 per year deduction is applied to the property tax bill for approved applicants. NJ State guidelines limit household income to qualify. Social Security or government pensions can be excluded, but any income outside of that is capped at \$10,000.00 per year. ANNUAL NOTICE OF ASSESSMENT

During the first week of November property owners will receive the annual Notice of Assessment card. Please note that the notice is sent to inform property owners about the 2024 assessed value, and the amount of property taxes billed in 2023. If you have any questions, or do not receive the card by December 1, please contact the Assessor's Office at 856-234-6272.

Duties and Responsibilities of the Planning and Zoning Boards

PLANNING BOARD

The Planning Board, comprised of 9 regular members and 2 alternate members, dedicate hours of their time monthly to ensure applicants coming to Mount Laurel are following local ordinances and the Municipal Land Use Law. The members include 6 regular resident appointees, 2 resident alternate appointees, the Township Manager, the Mayor, and a member of Township Council.

Applicants coming to the board come with experts, including lawyers, architects, engineers, and industry professionals ready to testify in favor of their application. The Planning Board, comprised of volunteer residents, have paid professionals to advise and assist in making important decisions in tandem with the Township's appointed employee member and elected officials.

Legal notice requirements must be sent out prior to an application being heard, and before an application is heard at an official meeting, officials review the applications to ensure those applications are complying with all relevant ordinances and laws.

The Planning Board ensures applications are consistent with the Township Master Plan, which is a blueprint for how a municipality can be developed – i.e. where parks should be, how much housing is appropriate, and where businesses and warehouses can be built.

Governed by the Municipal Land Use Law, the Planning Board cannot deny an application if it is consistent with the master plan. Regardless of a board member's personal feelings about a project, they are legally required to enforce the master plan, Township ordinances, and municipal land use law in an unbiased manner.

The Planning Board has jurisdiction over most site plan applications, however when an application also involves a use variance, the Zoning Board of Adjustments makes the ultimate decision.

ZONING BOARD OF ADJUSTMENT

The Zoning Board of Adjustment "ZBA" is made up of 7 regular members and 2 alternate members. All ZBA members are volunteer residents of Mount Laurel and are appointed by Township Council.

The greatest distinction between the Planning Board and the Zoning Board of Adjustment is the Zoning Board's jurisdiction over "d" variances. While the Planning Board hears only "by-right" applications, the Zoning Board hears only applications that are not permitted "by-right".

In the simplest terms, the ZBA has jurisdiction over use, or "d" variances, and bulk or "c" variances, as well as appeals of the Zoning Officers decision and interpretations of Zoning Ordinances. The most common use variances are d(1) variances and (d)3 variances. A d(1) variance is a variance to permit a parcel of land to be used for a use prohibited in that zone. For example, a doctor's office on a parcel zoned residential would require a (d)1 use variance. A (d)3 variance is a variance to permit a deviation from a specific condition of a conditionally permitted use. Bulk or "c" variances are variances to allow a deviation from size and height standards of a particular zone. For example, a resident may apply for a bulk variance to allow a deck 10 feet from a property line where 25 feet is required.

The Zoning Board of Adjustment has a great deal of discretion when it comes to its decisions. The Board may approve or deny an application in its entirety or in part. They may also approve an application with conditions. These conditions can vary greatly from landscaping and stormwater management requirements, to aesthetics and business hours. If approved, the applicant is required to submit a series of resolution compliance plans to ensure that the development is carried out as approved by the board. Once the final resolution compliance plans are approved and signed by the board professionals, the applicant moves from the ZBA to the construction department for permitting.

olutions to Stormwater Pollution

Easy Things You Can Do Every Day To Protect Our Water

A Guide to Healthy Habits for Cleaner Water

Pollution on streets, parking lots and lawns is washed by rain into storm drains, then directly to our drinking water supplies and the ocean and lakes our children play in. Fertilizer, oil, pesticides, detergents, pet waste, grass clippings: You name it and it ends up in our water.

Stormwater pollution is one of New Jersey's greatest threats to clean and plentiful water, and that's why we're all doing something about it.

By sharing the responsibility and making small, easy changes in our daily lives, we can keep common pollutants out of stormwater. It all adds up to cleaner water, and it saves the high cost of cleaning up once it's dirty.

As part of New Jersey's initiative to keep our water clean and plentiful and to meet federal requirements, many municipalities and other public agencies including

colleges and military bases must adopt ordinances or other rules prohibiting various activities that contribute to stormwater pollution. Breaking these rules can result in fines or other penalties.



As a resident, business, or other member of the New Jersey community, it is important to know these easy things you can do every day to protect our water.

Limit your use of fertilizers and pesticides

• Do a soil test to see if you need a fertilizer.

• Do not apply fertilizers if heavy rain is predicted.

• Look into alternatives for pesticides.

Maintain a small lawn and keep the rest of your property or yard in a natural state with trees and other native vegetation that requires little or no fertilizer.

• If you use fertilizers and pesticides, follow the instructions on the label on how to correctly apply it.



Make sure you properly store or discard any unused portions.

Properly use and dispose of hazardous products


 Hazardous products include some household or commercial cleaning products, lawn and garden care products, motor oil, antifreeze, and paints.

 Do not pour any hazardous products down a storm drain because storm drains are usually connected to local waterbodies and the water is not treated.

LEAF COLLECTION

Scheduled leaf collection is done between October and January. Below is a map of the section dates. If you visit www.mountlaurel.com and click on the Leaf Collection page, there is a street index as well listing the section you are in along with a bagged leaf schedule.

If you see a leaf truck in your section before your scheduled week, Public Works will often start in the next section when finished the current section early. We will be back in the scheduled section during the scheduled timeframe. We will also go back over sections from the beginning of the leaf season as well. Please keep the leaf pile clear of cars, portable basketball nets, and trash cans. Do not put branches, brush, or anything other than leaves in the leaf pile.




Standards of Cover



FIRE EXTINGUISHER TRAINING

A portable fire extinguisher can save lives and property by putting out a small fire or containing it until the fire department arrives. Portable extinguishers, however, have limitations. Because fire grows and spreads so rapidly, the #1 priority for residents is to get out safely. MLFD personnel will review and provide practical instruction on the proper use of a fire extinguisher.

HOUSE NUMBER VISIBLE AND WELL LIT

Fire, EMS, and Police Departments are in agreement...**visible house numbers save lives!** Your house numbers should be clearly visible from the street, and well lit at night. They should not be blocked by any trees or bushes. They should be either light numbers on a dark background, or dark numbers on a light background.

50 YEARS OF SERVICE

Bruce Herbst joined Mount Laurel EMS in 1999 as a volunteer emergency medical technician (EMT) and would later become a part-time EMT. This year EMT Herbst hit a major milestone by completing 50 years of service in emergency medical services (EMS). The following provides a glimpse of his EMS history: served as past deputy rescue chief; received several awards from EMS agencies; responded to assist FDNY during 9/11; life member of the Delanco Fire Co. and Emergency Squad; life member of the Endeavor Emergency Squad; past member and officer of the Beverly and Delran Emergency Squads; served as the Burlington County EMS Coordinator during 9/11 to provide resources to New York City, along with ensuring preparedness of maintaining local resources to meet the needs of communities throughout Burlington County. He served through the Avian flu, Swine flu, Ebola, and the Covid-19 pandemic. Bruce also retired from a career in law enforcement, where he served 33 years.

He received the Meritorious Service Award from the Burlington County Advisory Board for being Chief EMS Coordinator in May 2015, received a lifesaving award from New Jersey Transit Police Department, along with several life saving awards from the Burlington County Bridge Police.



Tom Orr joined Mount Laurel EMS in 1989 as a volunteer emergency medical technician (EMT). For years, Tom has been a part of the MLEMS' volunteer duty crew program and consistently has become a top contributor by volunteering hundreds of hours annually. This year, EMT Orr hit a major milestone by completing 50 years of service in emergency medical services. The following provides his history: 1973-1980 Secaucus VFAS - Vice President; 1975-1978 Rutgers University FAS - Founder and Captain; 1976-1978 New Brunswick EMS; 1978-1981 Magnolia Ambulance Corps - Corresponding Secretary; 1981-present Endeavor Emergency Squad - Chief and Dive-Team Leader; 1983-1989 Palmyra Ambulance Association - Captain; 1989-Present Mount Laurel EMS; 1992 & 1995 Squad Member of the Year.

Tom has almost always been an active member of 2 EMS organizations. The calls he will remember include: his very first call in Secaucus, the town where he grew up; 7 childbirths, particularly a call on Marter Avenue that he delivered alone; and arriving at Battery Park on 9/11 and seeing FDNY members sitting on a bench covered in soot, silent and motionless, as if they were statues.


Mount Laurel Historical Society
