• Dunn Building outparcel (city bathrooms): Construction nearing completion. Anticipated completion date 10/14

#### <u>Community and Economic Development</u>:

- Real Estate Development and Reuse: Seeking potential funding source for Brownfield clean up in Gateway district. CDFA assisting.
- **First Street Corridor:** Completed Grant application to EDA under review \$1,285,250. Notification in October.
- Duke Energy-possible EV charging station location. ECC assisting with site selection process.
- **Habitat for Humanity:** Ten lots under environmental review for funding. Thirty-day comment period underway. HUD review (15 days). Release of funds in November.
- The Entrepreneur Center: Received grants from The Bate Foundation and Z. Smith Reynolds for implementation. Water/flooding issues being resolved prior to construction.
- CNI (Choice Neighborhood Initiative): Working with resident councils to develop and implement branding/marketing campaign for the Five Point/Duffy Field community. Grant received from The Bate Foundation-CNI reimaging \$10,000. Craven CC \$20,000 marketing/assistance grant.
  - Revive 5 grassroots Leadership Academy began August 20<sup>th</sup>
- Paint Your Heart Out New Bern: 2017 event will be July 23-29. Partnered with NRCDC, Greater Duffyfield Residents Council, East Carolina Council and CNI to leverage funding opportunities. Applications are being accepted and reviewed.

### **Development Services**

- **Site Development:** Received technical assistance grant from Electricities for shovel ready program (S2) 25.3 acre Craven Regional Airport property expansion. Marketing materials being developed. Second site under review.
- **CDBG:** 2016-2017 \$250,955 allocated. Parks & Rec: Shade structure complete

#### Other:

- Twenty-nine land-use approvals were issued during the month.
- Staff issued a final C/O for 2032 Building A & B Waterscape Way-Cert of Occupancy.
- <u>Subdivisions</u> Final Plat for J&J Gardner Holdings/Raines Properties, LLC approved by Board of Aldermen.
- <u>HPC</u> Met with several Downtown Historic District residents regarding major and minor COA's.
   Met with John Wood of the State Historic Preservation on site at 513 Middle Street to assess the pending COA for demolition of a contributing accessory building.
- Provided staff support for Historical Preservation Commission's regular meeting on September
   21<sup>st</sup> for the following projects:
  - 309 Bern St. (Melissa Himes, Alexis Cardelli) to include installation of additional masonry in order to elevate the structure approximately 3 feet above existing elevation in the primary AVC.
  - 711 New St. (Mark & Jill Maxwell) to install a new wooden door and landing with a covered stoop to the left of the home in the secondary AVC; to replace the existing rear window with French doors and install a deck in the tertiary AVC.
  - 712 Pollock St. (Paul & Debra Mills) to include relocating the existing door and an existing window, removal of side lights and existing stairs/bannister, and installation of a deck in the tertiary AVC.
  - 607 Pollock St. (Paul & Debra Mills) to include replacement of existing concrete walkway with brick basket weave pattern and replacement of existing handrail with white ornate handrail and balustrades to match porch handrail and balustrades in the primary AVC.
  - 219 Middle St. (GO Architecture; MDA, LLC) to include removal of existing commercial windows and wood on front façade of building and extend the commercial structure to the replace with operable windows and install new, painted wooden panels and a wooden door. \*this is a modification to an existing COA
  - 513 Middle St. (GO Architecture; Alan & Arlissa Vaughn) to remove the existing singlestory garage and shed, and replace with a story and half accessory building in the tertiary AVC.
  - 411 George St. (Christie Decker-Frazier) to include replacement of concrete driveway and replace with bricks, installation of two wooden accent fence panels on corners of property in the primary AVC; installation of wooden fence to conceal HVAC units in the tertiary AVC.
  - 238 Middle St. (Christine Mele Bear Plaza Condos) to install an access ladder to the roof in the secondary AVC.
  - 310 Metcalf St. (Jay & Leslie Manning) to include placement of an accessory structure in the tertiary AVC. \*This is an after-the-fact permit.

### **Development Services**

- **Planning & Zoning Board:** Conducted Regular Meeting on September 7<sup>th</sup> for the following projects:
  - Consideration of a rezoning request submitted by "Tried By Fire, Inc." to rezone a property totaling .23+/- acres from R-10 Residential District to C-5 Office and Institutional District. The property is located at 823 Clark Avenue. The property is further identified by Craven County as Tax Parcel 8-022-028.
  - Consideration of a request by the City of New Bern to amend the City Land Use Ordinance articles:
    - o Article IV: Permits and Final Plat Approval; deletion of 4/5th voting requirement, per revision of N.C.G.S. 160A-388.
    - o Article XI: Supplementary Use Regulations; 15-170 "Telecommunications towers".
- NBAMPO: Planning is underway to host the annual NCAMPO 2017 Conference.
- **GIS**: Created maps and analysis for fire service districts by drive time. Working on engineering setup for field collection using ArcGIS Online apps. Working to update the structure layer for all buildings in New Bern related to condition and use.

## Significant Issues (not noted above): None to report.

### **High-Profile Projects:**

Advanced Metering Infrastructure Project - This project involves installing a network of electric and water meters. We are currently reading 3,955 water meters and 8,986 electric meters with 1,999 disconnect meters; 2,165 two-way load management switches have been installed. Phase II of the project is about 98% complete. We are establishing communication points around the City as required for communications back to the operations center. Brices Creek gateway waiting on configuration from contractor. An additional gateway for Taberna is waiting on crew availability.

### • Overhead Line Rebuild

- -Dogwood and Laurel Drive. *Replace and relocate back property, overhead distribution to road frontage.* The tree work is complete and we have begun setting poles.
- -Racetrack Road. We are working on upgrading the existing overhead line to feeder capacity. This work has a planned start date of November 2016.

### • New Underground Developments

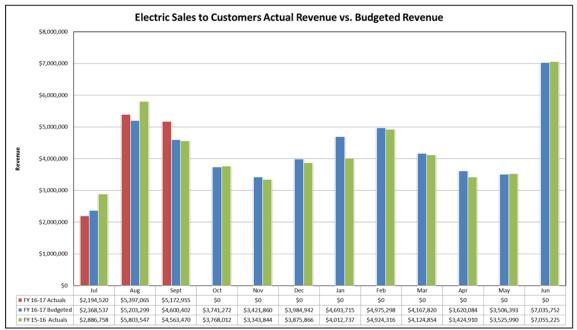
- -Pine Valley Apartments. Underground Subdivision Extension. *Install underground primary, secondary, and area lights as needed to provide power within this new apartment complex.* All of the pipe for phase one has been installed. The contractor requested we stop until he finished his grading.
- -Craven Animal Hospital. *Install underground primary and transformer needed to provide power to a new commercial service*. Estimated completion date for permanent service is October 2016. A pole has been set and three-phase underground primary and conduit has been installed under Old Cherry Point Road. A temporary transformer and conductors have been installed for their construction service.
- -Craeberne Forest. New underground primary extension for subdivision expansion. We have a design to ad power to 36 new lots. We have provided the plans to the developer and are waiting for his approval to start the installation.
- -Crimson Walk at Bayberry Park in Carolina Colours. *Install underground primary and secondary cable, transformers, stands and street lighting for development addition.* Start date of October 12, 2016.

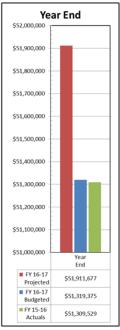
#### Downtown Improvements

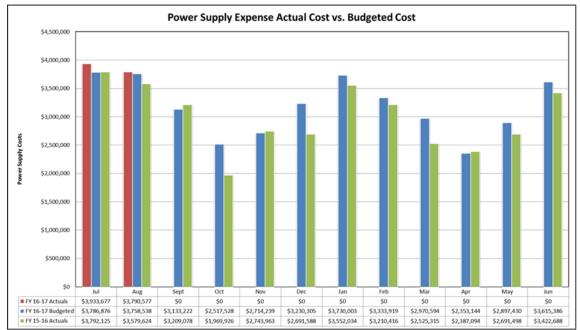
- -E. Front Street Light Project. New installation of decorative street lights. Along bulkhead across from the Sudan Temple to the marina.
- -Hancock Street and 400 Block of Pollock Street. *Overhead to underground conversion.* We will be working with the CATV and TELCO to convert all of the overhead utilities to underground. We will also be installing the green decorative street light fixtures in this area. Estimated start date of December 1, 2016 for the Pollock Street conversion.
- Township No. 7 Sewer Improvements Phase III. Sewer system infrastructure improvements for increasing transmission capacity. Aerial and ground survey work for the project are complete and staff is working with the engineering consultant to finalize the force main alignment and design plans required for permitting.

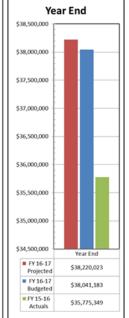

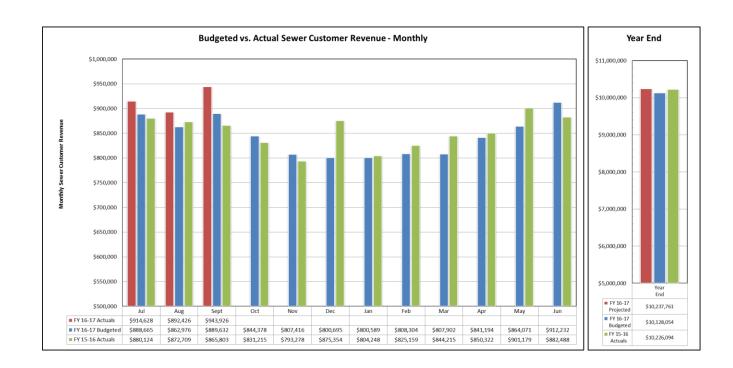

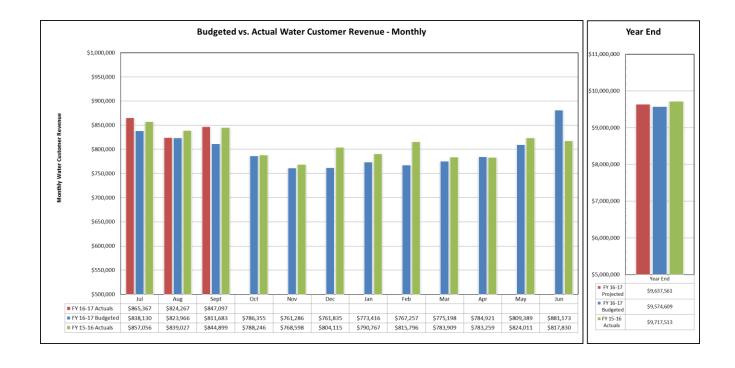
