FAST FACTS

There were a total of 313 hearings held in Court in August 2023.

248 hearings were held in-person, a 79% attendance success rate.

65 defendants did not appear for Court.

There were a total of 34 Stay of Execution cases pending with the Court for failure to pay.



Defendants made their payment.

Defendants had an extension granted.

The Top-3 most common citations in Municipal Court for July were Speeding 10-19 over (213), Speeding 20-39 over (48), and Careless Driving (47)

In August, there were 807 text messages sent by the Court. Only 145 text messages failed, creating an 82.0% successful delivery rate.

There were 19 victim impact statements sent out during the month, with 5 being returned successfully. There were 6 restitution hearings in total held.



CUSTOMER SERVICE SURVEY

In April 2022, the Municipal Court created a 12-question customer service survey in limited distribution. Starting in March 2023, the Court began sending post-court text notifications referencing the survey. To date, there have been 51 responses in total. Here are some highlights from the results:

82% of respondents said when they first received their ticket, they understood what they needed to do.

68% of respondents said the Municipal Court reminder gave them the information needed to prepare for Court.

67% of respondents felt the Court Clerks paid attention to the defendant's needs, treated them fairly, and was courteous.

83% of respondents were clear on their rights as a defendant when attending Court.

89% of respondents felt when appearing before the Judge, they felt understood, could tell their side of the story, and everything was explained clearly




