Leighty Elected New Mayor

► Gender-Neutral Charter Ballot Item Does Not Pass

Nov. 5 was our local election, and Northglenn will welcome a new mayor and two new City Council members, and welcome back two current council members for a second term. (Please note, at the time of printing the election was not yet certified.) If the final election results do not change, the following candidates will be sworn in:

- **Meredith Leighty**, Ward 1 City Council member and current mayor

pro tem, will be the new City of Northglenn mayor.

- **Ashley Witkovich** will be the new Ward 1 City Council member.
- **Becky Brown** will serve a second term as the Ward 2 City Council member.
- **Katherine E. Goff** will be the new Ward 3 City Council member.
- **Antonio B. Esquibel** will be the Ward 4 City Council member. He was elected the Ward 4 representative in 2015, then appointed mayor in June 2019.

Additionally, there was a ballot issue this year that did not pass: Question 3F: Shall the City of Northglenn Home

The community is welcome to attend as we swear-in newly-elected council members from the Nov. 5 election. Afterward, we will honor and celebrate outgoing council members for their service to the community.

7,671 residents voted in the election.

City Staff Minimum Wage Increased

► \$15 Hourly Rate by '21

In August, council expressed interest in exploring a pay structure that set the lowest wage for City of Northglenn positions at \$15 per hour. The state minimum wage is now \$11.10 per hour, and is set to increase to \$12 per hour in 2020. On Oct. 7, Council reviewed three options:

- Raise the City of Northglenn minimum wage to \$12.26 per hour in 2020. This amount was determined by a market comparison and would be a \$90,000 increase to the 2020 Budget.
- Raise the City of Northglenn minimum wage to \$15 per hour in 2020. The cost to implement this level of pay would be \$286,718 in 2020.
- Phase in an increase over two years. In 2020, the City of Northglenn minimum wage would raise to \$13.65 per hour, then increase to \$15 per hour in 2021. The cost to implement this would be \$185,357 in 2020.

City Council decided to move forward with option three, and the Oct. 28 unanimous vote to adopt the 2020 Budget and 2020 Pay Plan confirms

the City of Northglenn will increase the minimum wage paid to employees to \$13.65 per hour as of Jan. 1, 2020.

City Council members expressed several reasons for the increase, including: to help attract new employees, increase retention of hourly employees, move towards paying a "livable wage," and the increased cost of living in our area.

NO TRASH PICKUP ON CHRISTMAS, NEW YEAR'S

The city will NOT pick up trash on Christmas – Wednesday, Dec. 25 or New Year's Day – Wednesday, Jan. 1.

If your trash is normally picked up on Wednesday by the city, it will instead be collected the next day, Thursday.

Households that normally have Thursday pickup will still have their garbage and recyclables taken on Thursday. Residents are urged to have their trash and recycling carts out on the curb by 7 a.m. that morning.

The trash schedule for the rest of the week will not be affected.

Council Covers Marijuana Laws, Homelessness in Study Sessions

Here is a recap of recent votes, a glance into the most discussed topics, and a look ahead for City Council. Council votes on two types of items: An ordinance (CB) is an enforceable law or regulation that requires two majority votes by council to pass; a resolution (CR), is a decision, opinion, policy or directive and only requires one majority vote to pass.

OCT. 28 MEETING

- **Stewart Appointed to Liquor Licensing Authority** (CR-115) – *unanimous approval*
- **Amendments to Northglenn’s Zoning and Development Standards** (CB-1936) – *unanimous final approval*: The Unified Development Ordinance (UDO) contains the zoning and development standards for Northglenn and helps regulate and guide future growth and redevelopment.
- **Update to Fireworks Laws** (CB-1938) – *unanimous final approval*: Establishes minimum fines for fireworks usage and now property owners may be cited for fireworks use on their land.
- **New Oil and Gas Regulations** (CB-1937) – *unanimous initial approval*: Would adopt new oil and gas regulations for the city.
- **Update for Definition of “Open and Publicly”** (CB-1939) – *unanimous initial approval*: Would change the definition of “Open and Publicly” in the Municipal Code for the possession of marijuana in order to match state statutes.
- **Strategic Plan Adopted** (CR-116) – *unanimous approval*: The 2019-2023 City Council Strategic Plan serves as a roadmap to guide the city’s efforts moving forward, including development of the budget. ▶ *See more on Page 6.*
- **2020 Budget Adopted** (CR-117) – *unanimous approval*: The \$121.5 million budget includes \$51 million for construction of the new rec center.
- **2020 Pay Plan Adopted** (CR-118) – *unanimous approval*: The plan establishes salary ranges for each position in the city that are competitive in the labor market.
- **Mill Levy Certified** (CR-119) – *unanimous approval*: The city has an 11.597 mill levy on property in the city; 7.597 mills are used for general operating activities and the other 4 mills is dedicated to street projects.
- **Policy Set for Electronic Participation by Council in Meetings** (CR-120) – *unanimous approval*
- **Certification of Delinquent Nuisance Abatement and Water and Sewer Charges** (CR-121, CR-122) – *unanimous approval*
- **Amendment to Standley Lake Agreement Between Northglenn, Thornton and Westminster** (CR-123) – *unanimous approval*

Homelessness Strategic Plan Initiative

Council had an in-depth discussion regarding those experiencing homelessness in our area. Council listened to several speakers from other public agencies and non-profit organizations. The speakers explained the current homelessness situations, what resources are available and the efforts underway to support those in need in our community, the county and the state.

Though municipalities do not provide social services (human services are handled by the county), many of the Northglenn Strategic Plan priorities have ties to this issue. What can we do to address this issue in our community? Council decided to move forward with creating a task force to answer that question. Stay tuned for news on this topic.

Marijuana Hospitality Establishments & Delivery

Two new state laws prompted this council study session topic. In 2020, on-site marijuana consumption at licensed facilities and home delivery of marijuana products will be legal in Colorado. Municipalities will need to determine if these options are appropriate for their community, and if so, to what degree.

Owners of local marijuana businesses conversed with City Council members on Nov. 4 about these new options. All marijuana businesses are highly regulated by the state, plus the City of Northglenn has additional regulations. There are many details that would need to be clarified before taking any action on these two options, and City Council wanted to start the discussion early to have time to properly consider the different aspects. Would on-site consumption be like a “tasting room” at current businesses or a “bring your own” gathering place? Could on-site consumption deter marijuana use in prohibited/inappropriate locations? Would delivery only apply to medical marijuana? Would deliveries be made to Northglenn from businesses outside city boundaries, and could Northglenn businesses deliver?

Council requested draft local ordinance options to review, and indicated more study sessions and public input would take place before any final decisions would occur.

- **Other Topics on the Horizon:** Onboarding for new council members, Police Department level of service, snow and ice control, pavement condition assessment, traffic calming policy and water rights 101.

COUNCIL MEETINGS & STUDY SESSIONS

City Council is required to have two meetings a month. They also typically have two study sessions monthly to learn about and discuss topics in-depth. Finally, special meetings are scheduled if more time is needed to complete city business.

Time/Date: Council meetings are on the second and fourth Monday of the month at 7 p.m.

Study sessions are on the first and third Monday of each month at 6 p.m. as needed.

Location: Study sessions and council meetings are held at Council Chambers in City Hall, 11701 Community Center Dr.



SPECIAL EVENTS A HIT

Several years ago City Council expressed interest in establishing more engaging community and regional events.

The Food Truck Carnival, Pirate Fest, Magic Fest and other endeavors were launched in response to council direction.

On Nov. 18, special events staff updated council on the status of these

efforts, how the current construction might impact events in the next 18 months and plans for the future.

The new Northglenn special events have been very successful. The construction for the new recreation center may cause issues with parking in the short term, but the completion of the project will offer new opportunities for festivals and events.

WARD 1 VACANCY DISCUSSION

As of Dec. 9 there will be a vacant city council seat in Ward 1. On Nov. 18, City Council discussed how to address the issue. The City Charter has specific guidelines on council action pertaining to appointing a new council member and/or holding a special election, including strict time constraints.

Council members’ discussion on this topic reflected a variety of perspectives: Will people apply during the busy holiday season? Would the short timeline allow for proper

communication of the vacancy? Could the interview process be refined to help with the appointment process? And though a decision about a special election cannot take place until January, that topic was also discussed.

At the close of the meeting, City Council decided to move forward with advertising the application process prior to an official vacancy date to help mitigate the short timeline and holiday impact.



applications for the vacancy from Nov. 28 through Dec. 12.

LICENSES NOW REQUIRED FOR SHORT-TERM RENTALS



Do you operate a short-term rental on your Northglenn property? The city now requires licenses for property owners who rent or lease all or part of a residential property for 30 consecutive days or less.

Examples of short-term rentals include those advertised on Airbnb and Vrbo, though they may be arranged by any means. The fee for an initial license is \$175. Yearly renewal is \$150. To apply for a license, go to www.northglenn.org/shorttermrental or call the City Clerk’s Office at 303.450.8755.





Keep Your Packages Safe

► Porch Pirates on Prowl During the Holidays

Much like the Grinch, Porch Pirates are out to get their hands on your holiday gifts!

But instead of dressing like Santa Claus and crawling down the chimney, they simply walk up to your front door and take the packages that have been delivered to your doorstep.

Here are few tips to help secure your deliveries:

Free

- Require signatures.
- If you know a delivery is

coming, ask a friend or neighbor to pick them up for you.

- If available, have the package delivered to a store. Amazon has its own lockers where you can pick up your orders.
- If allowed, have your packages delivered to your workplace – or to a friend or family member who you know will be home.

Costs Money

- Rent a post office box.
- Purchase a door camera. Even if the thieves are brazen enough

to steal your package, they'll be caught on camera. (And Northglenn Police will be very interested in the recording!)

If you believe your package has been stolen, start by contacting the shipping company and/or seller to confirm the package shipped. You may also be able to track your delivery online. Next, report the theft to the Police Department at 303.288.1535 or www.northglenn.org/reportonline.

Police may respond with an increased presence in your area and alert our community.

Testing Continues on N Line

The Regional Transportation District (RTD) and project contractor Regional Rail Partners (RRP) continue to work on civil and systems elements to move toward completion of the first 13 miles of the proposed 18.5-mile commuter rail N Line (known as the North Metro Rail Line during construction).

The project has begun advance testing of grade crossings and Positive Train Control (PTC) technology, including data review and making adjustments to optimize grade crossing warning times. Results from the testing will require approval from regulatory agencies to demonstrate the line is safe and operating as intended. Following approval, we will progress to the next phase, which will include testing multiple trains on the line.

Progress on civil work continues, including completion of station parking lots and plaza areas, installation of station site furnishings (benches, signage and landscaping) and testing of safety and security equipment (CCTV cameras and emergency

FLAT FARE IN 2020

Thanks in part to City Council advocates, RTD will charge a flat fare for the 2020 launch of the N Line train to Denver's north suburbs. The pilot program will eliminate the more expensive regional fare for the first six months of the commuter rail's operation.

telephones). Once RRP reaches substantial completion of construction on the N Line, RTD will review and validate the work and identify any final punch list items to be addressed in preparation to turn over to RTD Commuter Rail Operations Department. RTD is training operators and will proceed with revenue service demonstration testing of the line upon substantial completion.

RTD will fully operate the N Line when it is open. The agency is reviewing possibilities for opening the N Line to coincide with service changes in May or August of 2020. For more details, visit the N Line web page at www.rtd-denver.com/fastracks/n-line.

N LINE SAFETY TIPS:

RTD would like to remind the public that prior to opening for revenue service, the entire project is an active construction zone. Please abide by all safety signage and do not attempt to view testing by accessing construction areas at stations or locations along the tracks.

- Do not try to touch or throw objects at the overhead power lines or climb on the power poles – the wires are live with 25,000 volts of electricity.
- Never trespass on any train track – it is illegal and dangerous.
- Cross the tracks only at designated crossings – always follow safety signage and obey warning devices like flashing red lights and gate arms.
- Stay alert and look both ways for trains – you may not hear them coming.
- Stay off platforms until the line is open to the public.





Strategic Plan Guiding Northglenn into the Future

What is a strategic plan? It is a guide to how the City of Northglenn operates, a roadmap to our envisioned future. The 2019-2023 Strategic Plan identifies the city's priorities and guides decision making by the mayor and City Council. Our strategic plan provides the foundation upon which to align resources and measure organizational performance.

How did we develop the strategic plan? First, we looked forward – what kind of community do we want to be? What types of services do we want to offer

our residents? Then we examined our current status. We conducted resident and employee surveys, evaluated our infrastructure and analyzed our financial outlook. We also looked at other cities, best practices and trends in our region. Over the course of three City Council strategic planning workshops, council's vision for the city came to life. Council crafted a vision statement, identified core values, and set eight strategic priority areas to focus on in the next five years.

Our strategic plan identifies points of pride, areas in need of attention, and our hopes for the future. As you can see from the graphic below, the plan encompasses many areas. The full document is over 30 pages long (located at www.northglenn.org/council), and includes action steps in each area with a set of corresponding performance measures. For example, strategic goal #8, Infrastructure, has nine action sections with a total of 26 action items in those sections. One of the action areas is Traffic Calming, with three action

items associated with efforts to slowing traffic in neighborhoods. To support the actions, there is a corresponding performance measure of budget amount allotted to projects related to traffic calming.









The plan will be updated annually. I invite you to take a look at the full strategic plan online to see our planned route, as well as the concrete actions we will take, to ensure our future Northglenn meets our expectations. Of course, like all roadmaps, we may face some unexpected obstacles that lead to route detours where we may need to shift priorities. However, I feel like this trip is well worth the time and investment to continue moving our great city forward.





50th Anniversary ornaments will be available at Noel Northglenn and the Olde Fashion Christmas.


