



### HISTORIC SIGNING

The historic Stonehocker Farmhouse hosted two bill signings by Gov. John Hickenlooper on May 21. City Council members, state legislators and other local and Colorado government officials were all on hand for the joint ceremony. But before the actual signings, the governor surprised the crowd with a quick tune on the farmhouse's antique piano. The first bill Hickenlooper signed, HB-1360, expanded the number of directors on the State Historical Society board from nine to 13 and limits the number of members on the board from one political party to seven. The second, HB-1291, extended the repeal date of the Sunset Conservation Easement Oversight Commission to 2025 and implements other recommendations for the commission. The farmhouse, located at 10950 Fox Run Parkway, is the oldest standing structure in Northglenn, and is listed on the National Register of Historic Places.

# City to Update Zoning Codes

## ► Unified Development Ordinance Will Contain All Development Processes and Regulations in One Place

As a response to the changing needs of the community, the city is drafting a new code that will combine elements of traditional zoning and subdivision regulations into a modern, user-friendly document called a Unified Development Ordinance (UDO).

The UDO will consolidate all zoning and development standards, processes and regulations into one place. This will streamline the development process, and make it easier for the public and the development community to use and understand the requirements.

The project will also update zoning districts and land uses, and improve the city's development standards.

### 1959

The year Northglenn's oldest zoning codes and regulations were adopted, before the area was incorporated and was still under the jurisdiction of Adams County.

### What is Zoning – And Why Do Communities Zone?

Zoning helps you determine what and where you can build, and how the land can be used. Some standards commonly contained in zoning include setbacks from property lines, height of structures and standards for parking and landscaping. This helps the community by preserving

property values and ensures that different land uses, such as public spaces, commercial zones and residential areas, are compatible with each other for a more efficient community; for example, separating houses and neighborhoods from areas of manufacturing when necessary.

### Zoning History

Original development of the Northglenn Perl-Mack subdivisions started in 1959, and developed under Adams County's Zoning Codes & Regulations. A few other locations predated this, such as the Deza Estates subdivision, and the "turn of the century" Stonehocker Farm.

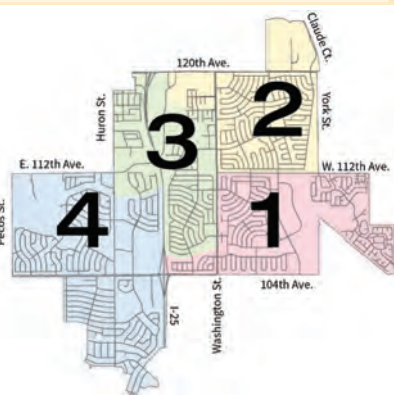

In 1969, Northglenn became an official city, adopting its current codes and regulations in 1973. Ever since then, the code has been updated on an as-needed basis. This has created inconsistencies and awkward organization in some cases.

Process

This UDO will update the city’s zoning districts, processes, land uses and regulations. It will also look at current developmental trends of the community that focus on infill and redevelopment as opposed to developing large vacant and undeveloped land.

Public input is important for this project.

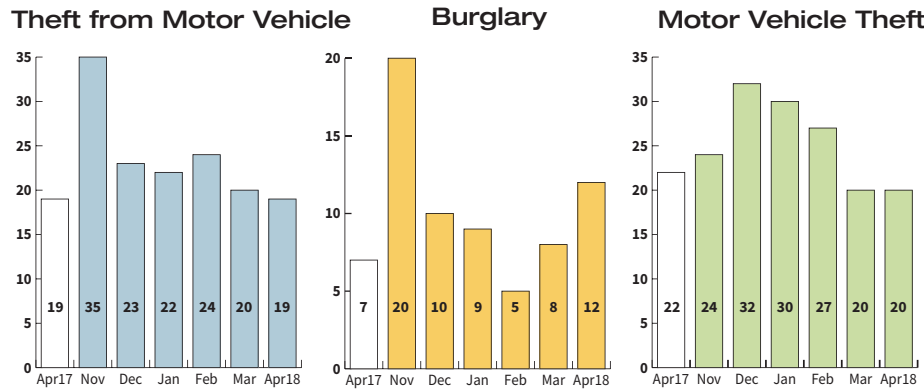

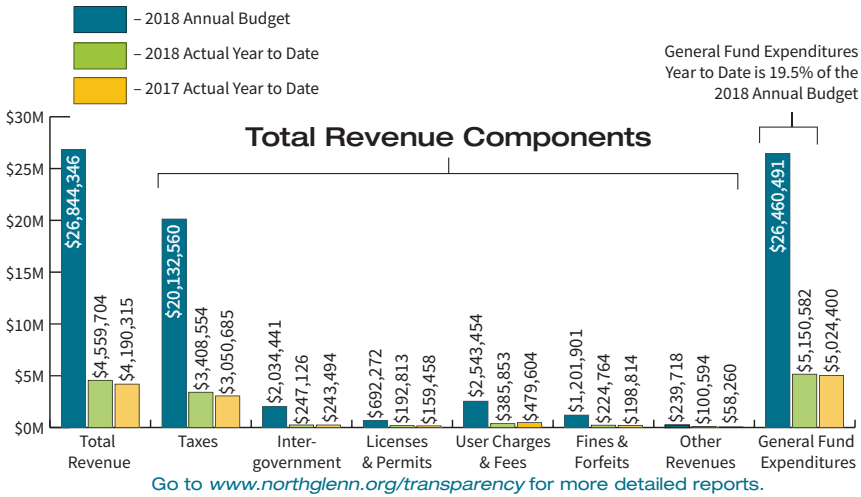
April 2018 Crime Statistics

Rhodes advocated for water infrastructure investment and source water protection funding. The message was well received by the members of Congress and

their staff.

Rhodes also discussed the challenges Northglenn faces with limited and competing budgets, aging infrastructure, population growth and changing regulations.

A record 160 water utility leaders from 48 states attended the event.

"AWWA Fly-In delegates bring a consistent, credible voice on water issues to our elected leaders in Washington," said AWWA CEO David LaFrance.

# The Arts Mean Business

## ► Culture Impacts Economy Locally and Nationally



The nonprofit arts and culture industry is an economic driver for communities. It continues to be a growth industry that supports jobs, generates government revenue and is a cornerstone of tourism. The arts provide both cultural and economic benefits and elevate local attractiveness and quality of life.

### National Impact

The U.S. Bureau of Economic Analysis (BEA) reports a sizable financial impact from the arts. The BEA found that the arts contributed \$763.6 billion to the U.S. economy in 2015 – more than agriculture, transportation or warehousing. The arts' contribution represented 4.2 percent of the country's gross domestic product.

### Local Impact

What makes the economic impact of arts and cultural organizations unique is that, unlike most other industries, they generate large amounts of event-related spending by their audiences.

"On any given week, over a thousand people see a Northglenn Arts production or experience our community through the public art program," said Northglenn Arts Supervisor Michael Stricker.

For example, when patrons attend a performing arts event, they may buy dinner at a restaurant, eat dessert after the show and return home and pay the babysitter. These expenditures have a positive and measurable impact on the economy.

"When there is a sold-out show at the D.L. Parsons Theatre, it's not just supporting the performers on the stage – it's supporting our local businesses and city services," said Economic Development Manager Debbie Tuttle.

Amount the Northglenn Arts & Humanities Foundation has received from the SCFD since 1990. SCFD distributes funds from a 1/10 of 1 percent sales and use tax to cultural facilities in the seven-county Denver metro area.

### BIZ BRIEFS

**RESILIENT ATLAS:** Atlas Roofing lived up to its name, as the Northglenn company received the 2017 Resilience Award from Adams County Economic Development.

A torrential rainstorm in the summer collapsed a 50-foot by 80-foot section of the company's concrete roof deck, forcing it to shut down for over a month during its busiest season. Still, Atlas had zero loss in sales by shifting production to sister facilities.

**NORTHGLENN GREENS BUILDING SOLD:** Ramos Law, LLC, an injury law firm, purchased the 47,957-square-foot building at 10190 Bannock St. for \$4.94 million. Ramos will occupy 12,768 square feet of the top floor, where it will employ 50 people. Extensive interior and exterior improvements are planned for the building. Ramos Law expects to open in the fall.

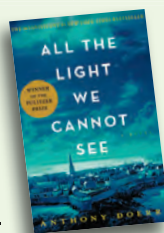
