

Rodriguez Named Ward 4 Council Member

► Term Runs Until Meeting Following Confirmation of Nov. 5 Election Results

At their regular meeting on July 22, City Council appointed Lauren Rodriguez to fill the vacant Ward 4 City Council seat. Rodriguez will serve as council member for Ward 4 until a new council member is sworn in following the municipal election later this year.

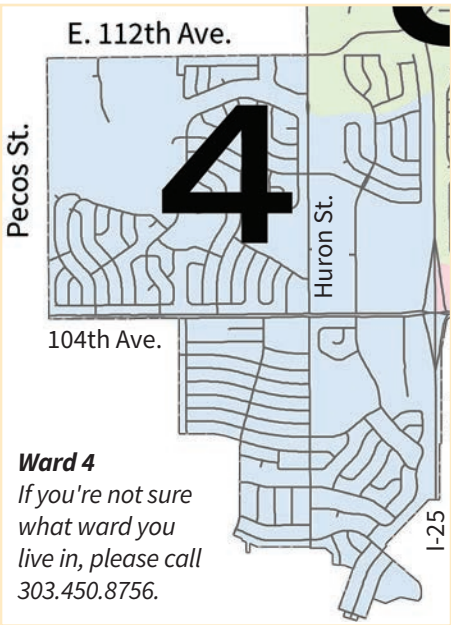
This appointment follows an application and interview process that drew 15 who wanted to represent their fellow residents. This seat, as well as the positions of mayor and one council

member in each of the other three wards, will be up for election in the Nov. 5 general election. Rodriguez is eligible to run for the seat in November.

After Rodriguez's swearing in, council selected Meredith Leighty as the new Mayor Pro Tem. Her term in this position will also run through the November election. Antonio B. Esquibel previously served as Mayor Pro Tem before being appointed mayor.

Election Season Starting for November

Northglenn voters will elect a mayor and one council member from each of the city's four wards at the regular municipal election on Nov. 5, 2019. The mayor and council member seats are for four-year terms. Residents interested in running for City Council are encouraged to stop by the City Clerk's Office, located inside City Hall, to pick up a candidate information packet.

There are also filing requirements that must be met throughout

the election process. A Candidate Affidavit must be filed within 10 days of becoming a candidate. A Committee Registration Form must be filed with the city clerk before accepting any contributions for a candidate's campaign.

WHO IS ELIGIBLE?

By Nov. 5, a candidate must:

- Be a U.S. citizen & registered voter
- Be a resident of Northglenn for at least one year immediately preceding the election
- For council seats, be a resident of your ward for at least 32 days immediately preceding nomination
- Not have a felony conviction

GET YOUR NAME ON THE BALLOT

- Candidates must be nominated by petition.
- Petition process takes place in August.
- Only petitions obtained from the City Clerk's Office may be circulated.
- Petitions must be signed by at least 25 registered voters residing in the candidate's ward for council member spots or at least 25 living in the city at-large for mayoral candidates.

KEY DATES

- **Aug. 5** – Nomination petitions will be available in the City Clerk's Office.
- **Aug. 6** – First day a nomination petition may be circulated for signatures.
- **Aug. 26** – Deadline to file signed nomination petitions with the City Clerk. Petitions must be received by 5 p.m.

CLOSURES

- **City Hall, the Northglenn Recreation Center, the Northglenn Senior Center and Municipal Court** will be closed Monday, Sept. 2, in observance of Labor Day. Administration, Building Division and the City Clerk's Office will be closed.
- Trash will be picked up as normal.
- The Sept. 2 study session has been canceled.
- The **Northglenn Recreation Center and Senior Center** will be closed Aug. 26 through Sept. 2 for annual cleaning and maintenance. Call 303.450.8800 for more information.

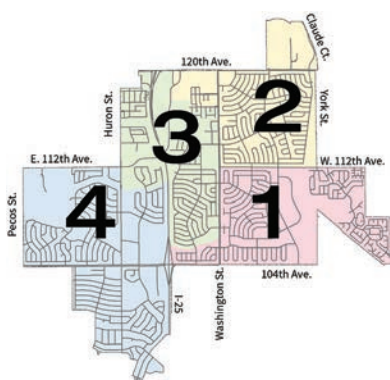

Ordinances: 2nd Reading

Licensing for Short-Term Rental Properties Approved

CB-1923 – Council unanimously approved on second reading an ordinance that establishes licensing regulations for short-term rental properties. This ordinance sets regulations for administering the properties, including licensing, application, review, permitting and an appeals process.

Change to Drainage and Stormwater Ordinance OK'd

CB-1928 – Council unanimously approved on second reading an ordinance that amends the City Urban Runoff Drainage Ordinance and Stormwater Quality Ordinance of the Municipal Code. This brings the city's Stormwater Program in line with state and federal stormwater regulations.

Definition of Beer Amended

CB-1929 – Council unanimously approved on second reading an ordinance that amends Municipal Code¹ sections 9-8-1 and 18-2-10. The maximum alcohol content limit in the definitions of “fermented malt beverage” and “malt liquor” are removed, making them consistent with state liquor and beer codes.

Esquibel Appointed Mayor

CR-63 – Council unanimously appointed Antonio B. Esquibel as mayor. His term runs June 24, 2019, to the organizational meeting following certification of results of the Nov. 5, 2019 election. Esquibel fills the term of Carol Dodge, who resigned as mayor in June. ► For more information, go to www.northglenn.org/councilvacancy.

City to Apply for Grant for Blender Bikes

CR-64 – Council unanimously supported a grant application for \$5,000 to be submitted to Adams County Open Space² for funding of the Blender Bikes Project. These bikes would be used at public events to engage attendees and encourage an active, healthy lifestyle. When the bike is pedaled, it powers an attached blender, which would be filled with healthy

XCEL ORDINANCE MOVED

At the June 24 meeting, council voted 7-1 to move the vote on 2nd Reading for CB-1930 to July 8. Then on July 8, they voted 7-0 to move the vote to July 22.

The ordinance would renew the franchise agreement with Public Service Company of Colorado, aka Xcel Energy, for 20 years. The current franchise agreement for Xcel Energy to provide natural gas and electricity service to the city expires on Aug. 17, 2019.

Grant Application for Civic Center Rec Improvements

CR-65 – Council unanimously supported a grant application for \$1.3 million for additional amenities and enhancements to the festival lawn and inclusion of a senior center patio and aquatics patio at the new Recreation Center/Senior Center/Theatre. The project is in the design phase, with construction set to begin in 2019. ► For more information on the project, go to www.northglenn.org/newreccenter.

Amended Employee Guidelines Approved

CR-67 – Council unanimously approved changes to the city's employee guidelines. A social media policy was added.

Program to Cover Access to Rec Center for Certain Medicare Participants

CR-68 – Council unanimously approved the Fitness Passport Service Agreement with OptumHealth Care Solutions. The city will be a “Participating Network Facility,” which will allow qualified Medicare Advantage or Medicare Supplemental United Healthcare policy holders to participate in fitness classes and use the facilities at the Northglenn Recreation

Center at no cost to the individual. The city will receive \$20 per member who visits the rec center at least one time during the month. The program is expected to be implemented on Jan. 1, 2020.

City Approves Short-Term Rental Property License Fees

CR-69 – Council unanimously approved short-term rental property license fees. These include \$175 for the annual license, \$150 for the renewal and \$25 if the renewal application is turned in late. This comes after passing CB-1923, in which council approved the licensing of short-term rental properties.

Company Hired for 120th Project Administration Duties

CR-70 – Council unanimously approved an agreement between the city and Stanley Consultants to provide administration services for the 120th Avenue Corridor Improvements Project. The cost shall not exceed \$96,950. Stanley Consultants will provide technical services in project management, inter-governmental coordination, request for proposal³ creation and design-related services. Construction on 120th Avenue will stretch from Washington Street to Claude Court. Work will include widening the street to three thru lanes, more turn lanes, a pedestrian/bike trail, signal enhancements and storm drainage improvements.

Resolutions:

Adams County to Provide Animal Services to City

CR-71 – Council unanimously approved an intergovernmental agreement with Adams County for animal shelter and adoption services for 2019 through 2020. The cost for 2019 will be \$33,672 and will increase to \$34,591 for 2020.

New Data Management System for Water Facilities

CR-72 – Council unanimously approved a professional services agreement with Hach Company for the Laboratory and Operations Data Management System. This will allow the city's Wastewater

Definitions to some terms used in this month's Local Legislative Recap that you may not be familiar with:

Ordinance: This is an enforceable law, statute or regulation that applies to everyone.

Resolution: This is a decision, opinion, policy or directive by council.

1. Municipal Code: This contains the regulations and laws of Northglenn.

2. Adams County Open Space Funds: These funds are used for parks, recreation and open space projects in Adams County. They come from a voter-approved, 1/4 of one percent county-wide sales tax.

3. Request for proposal: Commonly referred to as an RFP, this is a formal request for outside entities to submit proposals for providing goods or services to the city.

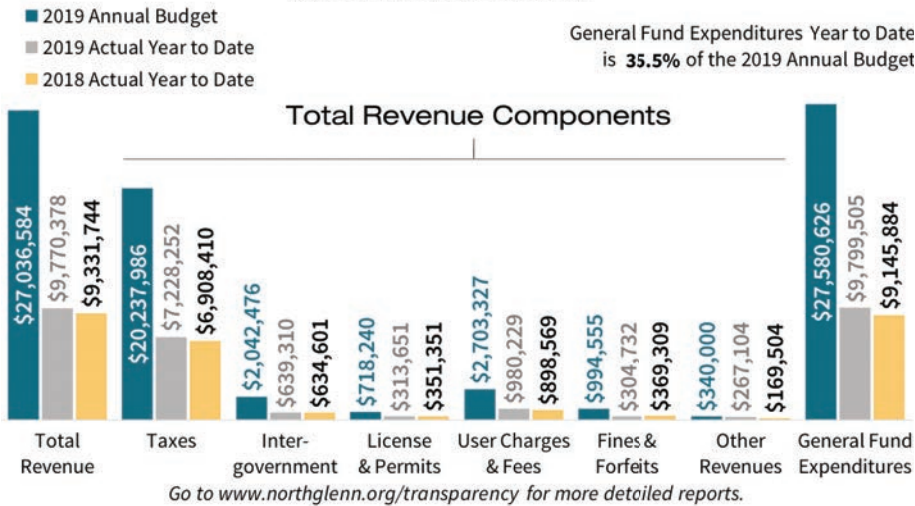

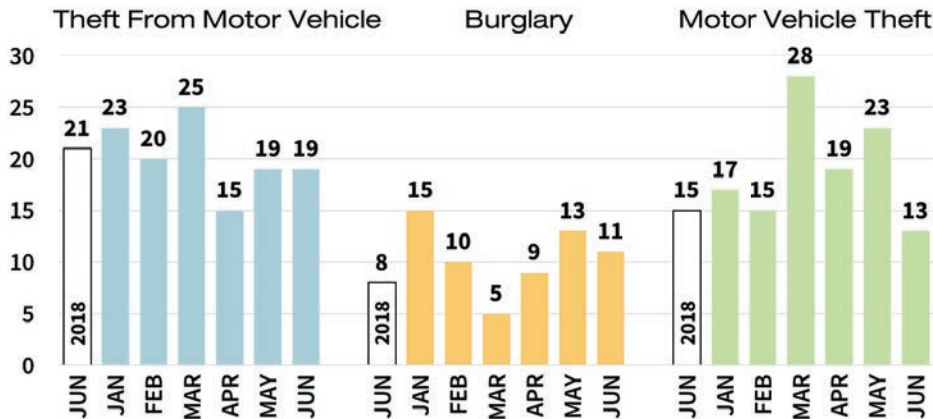
May 2019 General Fund Financial Report

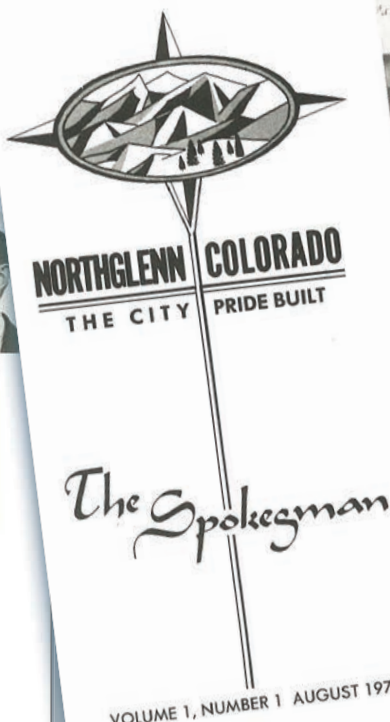
WORD AROUND TOWN

To The Residents Of Northglenn...

We, the Mayor and City Council, would like to take this opportunity on the occasion of publication of the first issue of The Spokesman, to dedicate this newsletter to the establishment of a successful communications program by which the residents of Northglenn can be informed of the policies, programs and problems encountered in the process of making Northglenn a better place in which to live. It will be the policy of The Spokesman to accurately and completely report those items of direct interest to the general public resulting from City programs and activities approved by City Council. We expect that The Spokesman will fill the need for personal, individual communications between the City Council and the citizens of Northglenn that has been so vitally needed in the past. Your comments about the success of the newsletter and about improvements that can be made in its presentation are solicited. Thank you.



City Starts Publication Of 'The Spokesman'

This, the August 1971 issue of The Spokesman, is the first in a continuing series of monthly newsletters to be published by the City of Northglenn, for the City of Northglenn, and about the City of Northglenn. The purpose of The Spokesman is to let you know what is happening in your local government. Not everyone has the time to attend City Council meetings and even the local newspapers are unable to cover all of the events of the City and report them fully to the public. Supplying citizens with important information about this City government requires a concerted effort in order to communicate the information to the people. Like any other form of communication media, The Spokesman is designed to relate information to concerned citizens. As a resident of Northglenn, you will want to be kept fully aware of the actions of your City Council and the activities of the various departments of City Hall.

One of the hardest tasks your elected officials face is keeping you informed about "what" is going on and "why". You need to know what and why and you are entitled to know, yet, all too often rumor instead of facts governs opinions. To circulate factual material and help you gain a better understanding of City activities is the real objective of The Spokesman. In this way, a big step will be taken toward closing the "information gap" and an even better Northglenn will result.

The Spokesman will be distributed free of charge to every residential family in the City once each month. The cost to the City will be only about 6 1/2 cents per family per month, a very small amount considering the value received. The Spokesman will concentrate on items of importance in the life of our new City. Your comments would like to see in

The Spokesman are earnestly solicited and will receive our prompt attention. Some articles that you can expect in each issue are a monthly chapter on a different phase of City government; such as, Finance, Police, Engineering, and Administration; actions and proceedings of the City Council; a calendar of coming events in City activities; a report on the activities of each City department; an open forum where citizens can ask questions and receive an answer the following month; (may we hear from YOU?) news from the City's service clubs; editorials; and miscellaneous news and articles of interest about City activities.

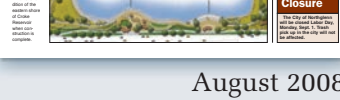
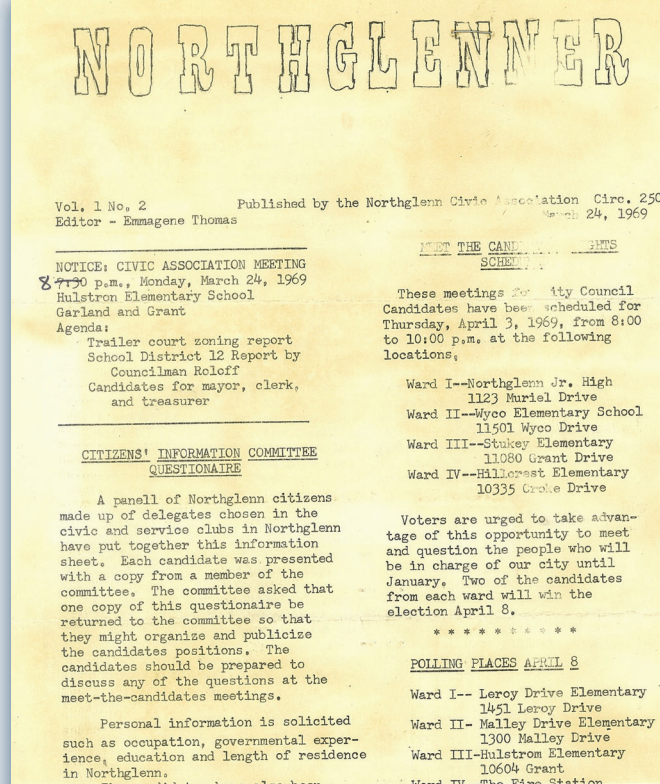

PAY ATTENTION

When School's Back in Session, Slow Down and Watch for Bikes and Pedestrians!

As the lazy days of summer come to an end and students are heading back to school, we all need to slow down and safely share the road with our student pedestrians. The inherent congestion of buses, vehicles, bikes and people in school zones make it especially important to follow a few precautions to help keep our students safe:

- Slow down and obey all traffic laws and speed limits.
- Don't drive distracted. Put your cell phone away.
- Watch out for school crossing guards and obey their signals.
- Don't pass a vehicle stopped for pedestrians.
- Don't stop in the middle of the street to load or unload children.



City Neighborhood Service officers will be placing signs like these throughout the city and especially in school zones to remind motorists to slow down.

- Don't block the crosswalk when stopped at a red light or waiting to make a turn, forcing pedestrians to go around you. This could put them in the path of moving traffic.
- Stop for a school bus with its red overhead lights flashing. The area 10 feet around a school bus is the most dangerous for children. Stay far enough back to allow them space to safely enter and exit the bus.
- Use extreme caution when passing a bicycle or turning when a bicycle is present. Children riding bicycles often are not able to determine traffic

conditions and have a tendency to turn without looking or signaling.

Also, please be courteous to our school neighbors and avoid blocking private driveways.

To help navigate traffic and improve safety, each school has drop-off and pick-up procedures on their website. Please make yourself aware of them.

By exercising a little extra caution, we can all help make our school zones safer for students.

Testing Revving Up on FasTracks

The Regional Transportation District's North Metro Rail Line from Denver Union Station to the Eastlake • 124th Station continues to make steady progress toward completion in 2020.

Construction, systems and signal work is taking place along the line. Crews have begun testing trains on the system during the week, and occasionally on Saturdays, between 7 a.m. and 7 p.m. In the coming weeks, testing will expand to include additional trains traveling in both directions at speeds up to 79 mph, so please be extra cautious near at-grade crossings.

As part of the testing process, crossing attendants will be standing by all at-grade crossings (Steele St., Thornton Pkwy., 100th, 112th, and 124th) as the train passes across the intersection. Train horns are required to sound at these at-grade intersections during testing of the N Line.

Until quiet zones are established, the use of train horns and other safety measures are important to make drivers and pedestrians aware of the presence of trains. Should you encounter any issues such as crossing arms remaining down for an extended period of time, please call RTD's Construction Information Line at 720.456.5279.

RAIL LINE SAFETY TIPS

- Do not try to touch or throw objects at the overhead power lines or climb on the power poles – the wires are up, and live with 25,000 volts of electricity!
- Never trespass on any train track – it is illegal and dangerous.
- Cross the tracks only at designated crossings – always follow safety signage and obey warning devices like flashing red lights and gate arms
- Stay alert and look both ways for trains – you may not hear them coming.
- Stay off station platforms until the line is open to the public.

Safety remains RTD's top priority at all times. RTD and RRP would like to remind the public that prior to opening for revenue service, the entire project is an active

construction zone. Please abide by all safety signage and do not attempt to view testing by accessing construction areas at stations and various locations along the tracks.

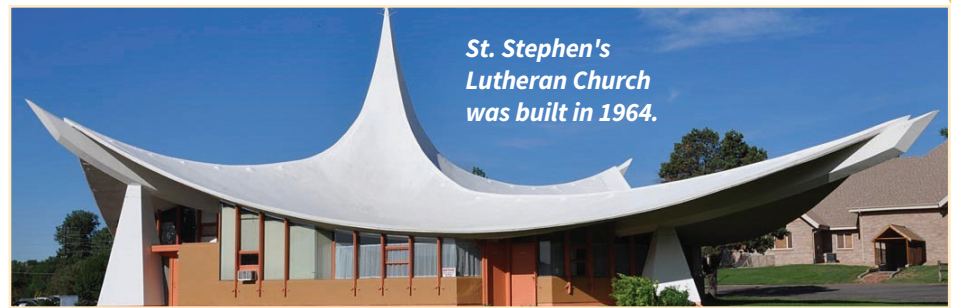

PUBLIC WORKS UPDATE

Project updates and activities from the city's Public Works Department:

Berthoud Pass Ditch Opening

The city's Water Resources Division, assisted by staff from Public Works Operations, Parks and Recreation and the Church Ditch Water Authority, opened the Berthoud Pass Ditch on July 3. The system provides Northglenn with water from the Colorado River Basin. The crew had to climb up to 11,000 feet, which required snowshoeing, shoveling snow and a three-mile round trip hike.

Grant Street Medians

Construction modifications to the median on Grant Street, between 120th Avenue and Community Center Drive, will start in early August. Work should be complete by mid-September.

Wastewater Treatment Plant

- Staff reconfigured piping at the Wastewater Treatment Plant to help reduce odors. The city purchased a SolarBee, which generates oxygen and further reduces odor. It will be installed this fall.
- The city upgraded the Ultraviolet Disinfection System at the Wastewater

Treatment Plant. The existing UV channel was upgraded and a second, redundant channel was installed. Cost: \$835,000

112th Avenue Project

Contractor T&M will install signal poles and complete paving and the widening of York Street in August.

Street Work

- The city completed all white and yellow striping in June and July.
- Striping on Grant Street from 104th Avenue to Muriel Drive will be re-done by the contractor. The street was originally striped last year, but it is coming up in various places. Since the work is still under warranty, the city has no additional costs.

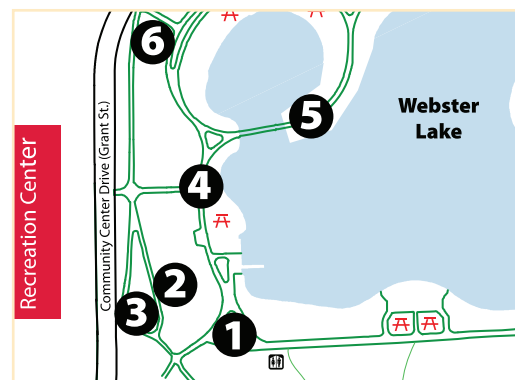
2019/20 ART ON PARADE

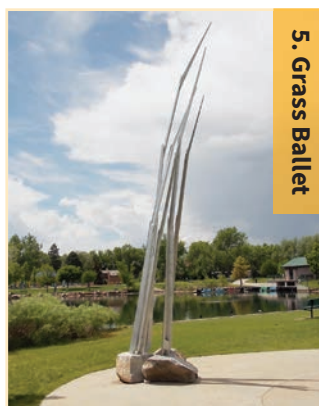

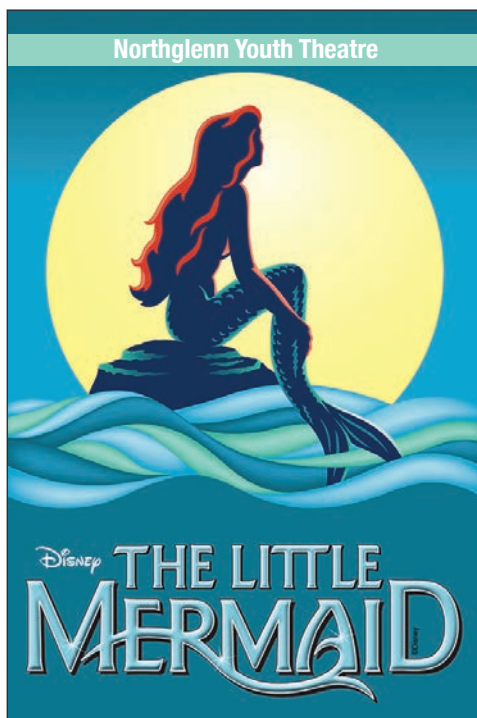
