



#### Parks and Rec Board Members Appointed

CR-50 and 51 – Council unanimously approved the appointments of Andy Hall as a Ward 1 member and Karen Knuepfer as a Ward 4 member to the Parks and Recreation Advisory Board. Their terms run May 24, 2019, to May 24, 2022. The board advises council and staff about parks and rec plans, facilities and programs.

#### Changes to Grant Median

CR-52 – Council unanimously approved a contract with Technology Constructors for the Grant Street Median Modifications Project. The median on Grant Street between 120th Avenue and Community Center Drive will be modified to improve visibility and traffic flow. The cost shall not exceed \$119,514.

#### Filing on Karl's Farm OK'd

CR-53 – Council unanimously approved the revised Karl's Farm Filing No. 1 as a final plat for conveyance only. This will help facilitate development of the Karl's Farm property, located north of 120th Avenue between Race Street and Irma Drive.

# Contingency Funds Approved for Kiwanis Pool Project

CR-54 – Council unanimously approved contingency funds for the agreement with Krische Construction in the amount of \$49,069 for the Kiwanis Bath House Replacement and Splash Pad Addition Project. Unpreventable delays in permitting and construction resulted in additional project costs. The expenditure limit is now \$769,229 for the project.

#### Bailhache Appointed Judge

CR-55 − Council voted 6-2 to appoint Amanda Bailhache as the Municipal Court judge for the city. Her term expires on Jan. 31, 2021, at which time she can be re-appointed by council. Her first day was June 17, 2019. Yes: Esquibel, Sauers, Leighty, Duran Mullica, Willford and Downing. No: Dodge, Whitman.

#### Kurtz Named Deputy Judge

CR-56 – Council unanimously appointed Kathryn Kurtz as deputy municipal judge for the city.

#### **Resolutions:**

#### Update for City's Water Supply and Demand Plan

CR-57 – Council unanimously approved a professional services agreement with ELEMENT Water Consulting to update and revise the Integrated Water Resources Plan. ELEMENT will evaluate the city's water supply, demand and water use trends, and recommend ways to reduce water use while maximizing supply. ELEMENT Water will also assist the city in updating its Water Efficiency Plan, and will develop a water supply model that staff can use to further water supply forecasting and planning. The cost shall not exceed \$127,650.

# Engineering Services for Wastewater Project

CR-58 – Council unanimously approved a professional services agreement between the city and Providence Infrastructure Consultants for engineering services for the Lift Station A and Forcemain Project. This project replaces Lift Station A and upgrades and realigns two miles of forcemain pipe. The lift station pumps sewage up to the city's Wastewater Treatment Plant in Weld County through the forcemain. The amount for engineering services shall not exceed \$1,439,059.

# School Zone Improvements for Stukey, Global Village

CR-59 – Council unanimously approved a contract with KECI Colorado Inc. for the School Zone Improvements Project. These modifications will be made at Stukey Elementary and Global Village Academy: Removal and placement of signage, installation of school zone flashers, curb striping and concrete work for ADA ramps. The cost shall not exceed \$216,531.

### **Open Space Grants Accepted**

CR-60 & 61 – Council unanimously approved the acceptance of two Adams County Open Space Grants. The first, for \$150,000, goes toward the Justice Center West Park Design Project. This new neighborhood park will have a nature play area, a children's play structure and drought-tolerant, low-water landscaping. The second, for \$375,000, will be used for along with new entryway arches. The playground sits in E.B. Rains Jr. Memorial Park, 11800 Community Center Drive.

#### Contract for Northwest Open Space Project Modified

CR-62 – Council unanimously approved an addendum to the contract with DHM Design Corporation for the Northwest Open Space Renovation Project. The city approved an additional \$18,700 for design and construction administration services for the project due to unforeseen site conditions and circumstances. This raises the total to \$239,947, which is still within the original project budget.

#### **Ordinances: 1st Reading**

#### Initial OK for Licensing of Short-Term Rental Properties

CB-1923 – Council unanimously approved on first reading an ordinance that would establish licensing regulations for shortterm rental properties. This ordinance would set regulations for administering short-term rental properties, including licensing, application, review, permitting and an appeals process.

# Initial Approval of Drainage and Stormwater Ordinance

CB-1928 – Council unanimously approved on first reading an ordinance that would amend the City Urban Runoff Drainage Ordinance and Stormwater Quality Ordinance of the Municipal Code. These would bring the city's Stormwater Program in line with state and federal stormwater regulations.

#### Initial Approval to Amend Definitions of Beer

CB-1929 – Council unanimously approved on first reading an ordinance that would amend Municipal Code sections 9-8-1 and 18-2-10. The maximum alcohol content limit in the definitions of "fermented malt beverage" and "malt liquor" would be removed to be consistent with state liquor and beer codes.

#### Initial Approval to Continue Franchise Deal with Xcel

CB-1930 – Council unanimously approved on first reading an ordinance to renew the franchise agreement with Public Service Company of Colorado, aka Xcel Energy, for 20 years. The current franchise agreement for Xcel Energy to provide natural gas and electricity service to the city expires on Aug. 17, 2019.

#### Updates to 2019 Budget

CB-1927 – Council unanimously approved on second reading a special ordinance to the Sensory Playground Improvements Project. This includes the replacement of worn playground equipment, site amenities and poured-in-place surfacing,

# Work Continues on Northwest OS

Northwest Open Space, the city's largest athletic complex, is undergoing a significant renovation.

Phase I of the project focuses on the central portion of the complex, and includes the addition of a new permanent restroom and concession facility, an expanded parking lot on the south side of the site, a shade shelter, new concrete trails and improvements to the landscaping, irrigation and drainage.

Construction began in late 2018 and is continuing to make progress. While a wetter than usual winter and spring caused delays, significant improvements are progressing quickly with drier weather. Northglenn staff and the contractor are coordinating to complete the northern portion of the site in advance of the work that needs to be completed through the center and on the southern side. This will allow users to have easier access to the fields from the northern parking lot.

Phase I is anticipated to be complete this summer and will provide an excellent improvement to the frequently-used space.

The city has plans for a Phase II and III of the project in the future.




2019 Actual Year to Date

# Adams 12 to Build New Career and Technical Education Campus

49,000-foot Facility to Break Ground on July 23; Courses to Include Construction, Science and More

Adams 12 Five Star Schools launched construction this month on a second Career and Technical Education (CTE) campus. The 49,000-square-foot campus at 126th Avenue and Washington Street is scheduled to open in fall 2020 and will increase CTE opportunities for district students by as much as 80 percent.

The start of construction on the new campus fulfills a promise of the community-supported 2016 Bond Program and the 2018 mill levy override to provide new opportunities for students across the district.

"With the addition of a second CTE campus," said Priscilla Straughn, Five Star Schools chief academic officer, "additional students will have the opportunity to receive a high-quality technical education experience and obtain in-demand skills that lead to post-secondary success."

Northglenn High School students and those who call Northglenn home make up more than 20 percent of students who currently attend Bollman Technical

Education Center in Thornton, a number that is expected to rise with the new campus.

The new campus will offer existing programs such as construction trades, welding, an introductory diesel mechanic course and EMT training. Programming will eventually expand to include criminal justice, forensic science and fire science programs as well as an advanced diesel mechanic program.

The additional campus is not the only CTE improvement in the district, as Northglenn High School will receive nearly \$1 million in upgrades to support their popular culinary program.

District, community and business leaders will celebrate the start of construction during a groundbreaking ceremony at 10 a.m., Tuesday, July 23. The public is invited. Email bondinfo@adams12.org to RSVP to attend.

# LETTER FROM THE CHAIR

2018 was a monumental year for NURA with the completion of the Huron Center Redevelopment Project. The board has been working on this since 2011, and it was not for the "faint of heart". With determination, and a lot of patience, the project has been completed and is a "poster project" of how urban renewal can transform communities.

In 2018, NURA paid for 16 business improvement grants and incentives totaling \$1.7 million in exterior and utility upgrades to commercial properties. The reinvestment of dollars leveraged more than \$12.3 million in private sector project improvements. Over the past 28 years, NURA has reinvested more than \$41 million.

I am sure you will all agree that we have seen substantial commercial redevelopment occurring throughout our five urban renewal areas in the past seven years. The major projects have been the Garland Center, Webster Lake Promenade and now the Huron Center. In just these three projects alone, NURA reinvested \$12.3 million to eliminate blight and improve infrastructure and keep Northglenn beautiful.

We are working with the owner of the Northglenn Marketplace to revitalize and

re-energize the shopping center. In 2019, you will see some exciting movement within the center to include Bed Bath & Beyond moving to the former Borders building, and construction beginning on a new 12-screen luxury movie theater.

Two of Northglenn's prized recreation assets are the Greenway Trail System and Webster Lake. The 28 miles of the Greenway Trails crisscross the city, while residents and visitors flock to the lake to rent kayaks and pedal boats.

So – why not combine them into an awesome new event?

Coming July 27 is the Northglenn Paddle & Run at E.B. Rains Jr. Memorial Park, home of Webster Lake. The race starts with a two-mile run, followed by a half-mile kayak trip and then concludes with another two-mile run.

Participants can compete by themselves or as part of a two-person team. The starts of the races begin at 7:45 a.m. and continue through 10:45 a.m.
