

Ordinances - 1st Reading:

### Initial Approval to Allow More Residents at Living Facility

CB-1916 - Council initially approved an ordinance to amend the Planned Unit Development zoning at 9777 Fred Drive, site of an assisted living facility. The resident capacity would increase from 12 to

### **Resolutions:**

### Cities to Pay for Video Services at County Facility

CR-139 – Council unanimously approved an Intergovernmental Agreement between the Adams County Sheriff's Office and the cities of Brighton, Commerce City, Northglenn, Thornton and Westminster. The municipalities will now pay for video services for defendants in custody at the Adams County Detention Facility. Adams County had been absorbing these costs, but will end starting Jan. 1. The cities will pay based on their usage. The cost for Northglenn is \$8,000 in 2019.

### Sheriff's Office to Provide Nighttime Administrative Help

CR-145 - Council unanimously approved an Intergovernmental Agreement with the Adams County Sheriff's Office to provide administrative services to the Police Records Division from 10 p.m. to 6 a.m., 365 days a year. From April 2017 to March 2018, the sheriff's office assisted the Police Department 4,207 times with administrative services. The Police Department will pay \$49,512 in 2019 for this assistance.

# Funding for Juvenile Offender Program Approved

CR-146 - Council unanimously approved an Intergovernmental Agreement for the provision and funding of The Link. They provide detention decisions, placement assessments and other related services regarding juvenile offenders to law enforcement agencies and schools in Adams County. Into November, the city had referred 50 juveniles to The Link in 2018. The total budget for The Link in 2019 is \$568,597; Northglenn's share is \$48,924, the same as in 2018. Brighton, Broomfield, Commerce City, Thornton, Westminster and Adams County are also part of the agreement.

# Fence Replacement on Huron

CR-147 – Council unanimously approved an agreement with Earth Green Soil Amenities for the South Huron Fence Project. The company will replace the resident-owned fences and remove plant material on the east side of Huron Street, south of 104th Avenue. Cost of the project will not exceed \$173,810.50.

### Grant for Bike Racks, **Repair Station Approved**

CR-149 - Council unanimously accepted a \$5,000 grant from Adams County Open Space. These funds will help pay for bike racks and a bike repair station. Northwest Open Space, Croke Reservoir, Wyco Park, Kiwanis Park, Central Park and South Park, along with city businesses, will receive new bike racks. Staff has pointed out Fox Run Open Space as an ideal location for the bike repair station.

### Grant for Wyco Park Tennis **Courts Approved**

CR-148 - Council unanimously accepted an Adams County Open Space grant for up to \$300,000 for the Wyco Tennis Courts Improvements Project. The three-court complex will have new asphalt, acrylic surface, fencing and lighting improvements. The total budget for the project is \$550,000.

### Addendum for 112th **Avenue Project Contract**

CR-150 - Council unanimously approved Addendum No. 1 to the professional services agreement with Stanley Consultants. The company handles project administration services for the 112th Avenue and York Street/Fox Run Parkway Roadway and Signal Improvements Project. This addendum extends the contract through the bidding and construction phase for

project administration. The initial contract was \$40,000; this addendum adds \$16,670 to the contract for a price not to exceed \$56,670.

### **Contingency Funds Approved** for Utility Emergency **Response Services**

CR-151 - Council unanimously authorized contingency funds of \$160,000 for the agreement with C&L Water Solutions for 2018 utility emergency response services. Work done by the company in 2018 has exceeded the original contract amount of \$100,000. The approved expenditure limit is now \$260,000.

### Replacement for Pressure **Reducing Valves Approved**

CR-152 - Council unanimously approved an agreement with C&L Water Solutions for the Waterline Replacement Project for an amount not to exceed \$199,957. The company will replace six pressure reducing valves throughout the city. These valves help maintain water pressure in the city.

### **Repairs Approved for Water Treatment Plant Clarifiers**

CR-153 – Council unanimously approved a contract with Dan's Custom Construction for the rehabilitation of clarifiers at the Water Treatment Plant. These clarifiers remove solid particles from the water. The cost will not exceed \$745,881.

## Firm Hired for Water Rights **Engineering Support**

CR-154 - Council unanimously approved a contract with Lamp, Rynearson & Associates, dba TZA Water Engineers. They will provide water and water rights engineering support in 2019. The cost will not exceed \$150,000.

## Firm Retained for Water **Rights Legal Services**

CR-155 - Council unanimously approved a legal services agreement with Fischer, Brown, Bartlett and Gunn. The firm will provide special water counsel and work on legal issues related to the city's water rights. The firm has provided these services to the city since 1985. The 2019 cost estimate is \$200,000.

## Placement of Cellular Facilities in Rights of Way Approved

CR-156 - Council unanimously approved a master license agreement with New Cingular Wireless PCS. The company will place small cell wireless facilities in the city's rights of way.

# DEC. 10, 2018

**Ordinances - 2nd Reading:** 

# Larger Capacity Permitted for Assisted Living Facility

CB-1916 – Council unanimously approved an ordinance to amend the Planned Unit Development zoning at 9777 Fred Drive, site of an assisted living facility. The resident capacity increased from 12 to 16.

### **Ordinances - 1st Reading:**

# Budget Amendments Initially Approved by Council

CB-1917 – Council unanimously approved on first reading a special ordinance to amend the 2018 Budget. This amendment:

- Reflects revenues received or expenditures approved outside the initial budget process
- Carries over capital projects
- Carries over operational contracts that overlap fiscal years

This amendment would reflect \$2.71 million in revenue and \$3 million in expenditures.

### November Ballot Issue Implementation Initially OK'd

CB-1918 – Council unanimously approved on first reading an ordinance amending Chapter 5, Article 18 of the Municipal Code. This article concerns implementation of the city's special marijuana sales tax. Changes include:

- Increasing the marijuana sales tax from 2 percent to 4 percent starting Jan. 1, 2019
- Language giving council the ability to increase or decrease the marijuana sales tax by no more than 1 percent each calendar year
- Sets the minimum tax rate of 4 percent and maximum of 10 percent that council may impose without further voter approval
- Amends the use of the tax revenue to include capital improvements and construction of public facilities.

These changes reflect the approval of Northglenn Ballot Issue 3E by city voters in the November election.

# Resolutions:

# Harvey Named to Liquor Licensing Authority

CR-157 – Council unanimously approved Larry Harvey's appointment to the Liquor Licensing Authority. His term runs Dec. 10, 2018 to Dec. 31, 2020. The Liquor Licensing Authority grants or refuses licenses for the retail sale of alcohol.

# Lovato Appointed to Youth Commission

CR-158 – Council unanimously approved Thomas Lovato's appointment to the Youth Commission. His term runs Dec. 10, 2018 to Dec. 10, 2019. The commission makes recommendations to City Council and staff about topics that impact youth in the community.

### Land Leased to Nonprofit

CR-159 – Council unanimously approved a resolution leasing the property at 2360 W. 112th Ave. to Ralston House. Ralston House is a nonprofit that provides a safe place for youth survivors of abuse to tell their stories and begin the healing process. They work with the Police Department and other law enforcement agencies in the area. Ralston House will pay \$1 per month in rent and cover utilities. The city will provide landscape and snow removal services. For more on Ralston House, go to www.ralstonhouse.org.

Jordan Sauers as an alternate member to the Victim Assistance and Law Enforcement (VALE) Board. Her term runs Jan. 1, 2019 to Dec. 31, 2021.

## **Public Hearings Scheduled**

CR-167 and 168 – Council unanimously approved these resolutions that set public hearing dates for CB-1917 and CB-1918 for the special meeting on Dec. 17, 2018. Normally, these public hearings would have been held on Dec. 24, but that meeting was canceled. City Hall closes at noon that day for Christmas Eve.

## Council Supports Climate Coalition Agenda

CR-169 — Council unanimously approved a resolution supporting the policy agenda of the Colorado Communities for Climate Action. The group is a coalition of local governments that advocate for state and federal policies to protect Colorado's climate. See Story on Page 4

### Police Reimbursed for Bulletproof Vests

CR-160 – Council unanimously approved the acceptance of a grant from the Department of Justice Bulletproof Vest Partnership for \$12,495. These funds will cover half of the cost of bulletproof vests purchased by the Police Department from Oct. 3, 2018 to Aug. 31, 2020.



### Weatherly Reappointed to Historic Commission

CR-161 – Council unanimously approved Lauren Weatherly's reappointment to the Historic Preservation Commission. Her term is Dec. 14, 2018 to Dec. 14, 2021. The commission protects, preserves and enhances the city's cultural, social, economic, political and architectural heritage.

# Pair Reappointed to Liquor Licensing Authority

CR-162 and 163 – Council unanimously approved the reappointments of Maxine Foster and Caron Lawless to the Liquor Licensing Authority. Their terms run Jan. 1, 2019 to Dec. 31, 2020.

# Marquez, Witkovich Both Reappointed to VALE Board

CR-164 and 165 — Council unanimously approved reappointments for Patricia Marquez and Ashley Witkovich to the Victim Assistance and Law Enforcement (VALE) Board. Their terms run Jan. 1, 2019 to Dec. 31, 2021. The board provides grants to law enforcement and community programs that assist crime victims.

# Sauers Reappointed as Alternate on VALE Board

CR-166 – Council unanimously approved the reappointment of Council Member

### Willford to Represent City Council on Climate Coalition

CR-170 – Council unanimously appointed Council Member Jenny Willford as the city's representative to the Colorado Communities for Climate Action Steering Committee. Her term runs Dec. 10, 2018 until the council meeting after certification of results of the November 2019 election. The committee is made of up representatives from member communities. They set the policy for the coalition.

# **DRCOG** Representatives Set

CR-171 — Council unanimously appointed Council Member Julie Duran Mullica as the Denver Regional Council of Governments (DRCOG) representative and Council Member Joyce Downing as the alternate. Their terms run Dec. 10, 2018 until the council meeting following certification of election results of the November 2019 election. DRCOG is a planning organization where local governments collaborate to establish guidelines, set policy and distribute funding in the areas of transportation, personal mobility, growth, development, aging and disability resources.






# **November 2018 Crime Statistics**

# Northglenn Joins Climate Action **Coalition of State Communities**

City Council voted unanimously on Dec. 10 to join Colorado Communities for Climate Action (CC4CA), a coalition of local governments pushing for strong state-wide climate policy in Colorado.

City Council also unanimously adopted a resolution appointing Council Member Jenny Willford to represent Northglenn on CC4CA's Steering Committee.

"It can be tough as a small city to effectively push for strong state policies," said Willford. "Becoming part of this coalition means Northglenn will have a seat at the table on state-wide climate policy and we 

Carol Dodge. "We want to do our part to can work together with a group of other communities to make sure all of our voices are heard at the Capitol."

CC4CA most recently helped secure strong emissions standards for passenger vehicles in Colorado, and is gearing up for an active legislative session that will likely include bills on energy efficiency, renewable energy, energy storage and reducing carbon pollution.

"We are working hard in Northglenn to become more sustainable," said Mayor protect our community from the impacts of climate change. But we can't achieve our own goals without strong state policies, and this coalition gives us a way to make that happen."

The coalition's 22 members span across the Front Range and western Colorado, suburbs and resort towns, municipalities and counties. The members collectively represent more than one-eighth of Colorado's population.





- New electrical system
- New flowmeters and pressure instrumentation
- New fiber optic communication
- Construction of a 3,000-square-foot administration building with office space and a laboratory

The project was completed on time and under budget in 2017.

"Winning an IEC National Award is a distinguished honor," said Marilyn Stansbury, IECRM CEO. "These accomplishments set the bar for industry best practices and contribute to the overall advancement of the independent electrical industry. We couldn't be more proud."







# "Wings of Freedom" Soars as People's Choice Award Winner

# Artist Lived in Dictatorship. Survived Time as Refugee and Political Prisoner

The Northglenn Arts and Humanities Foundation (NAHF) announces New Mexico artist Dimitry Domani is the recipient of the 2018/2019 People's Choice Award for his bronze and steel sculpture "Wings of Freedom".

The award is part of the city's Art on Parade program, which features on-loan, outdoor sculpture at E.B. Rains Jr. Memorial Park for one year. The public votes for their favorite, and NAHF works toward buying the piece for permanent display in the city. NAHF has already secured funding from the Scientific and Cultural Facilities District.

Domani was born in Romania and grew up in a communist dictatorship. His father and brother suffered 11 years of imprisonment under the Ceausescu regime. Displaying natural artistic skill and work ethic, Domani won admission to the highly competitive art school of Timisoara. After finishing his draft term in the Romanian Army in 1978, he began his journey toward the U.S.



He spent a year as a political pris-

oner in Yugoslavia and two years in

a refugee camp in Vienna. He inter-

viewed many times at its American

Embassy before finally obtaining a

visa to come to the U.S. in 1981.

Over the next few years, he gained

experience and confidence in art

foundries in Salt Lake City and Los

Angeles. After moving to Santa Fe in

1988, Domani started a studio and
