Civic Center Access Limited Due to New Rec Center Construction

Groundbreaking for Facility Oct. 28

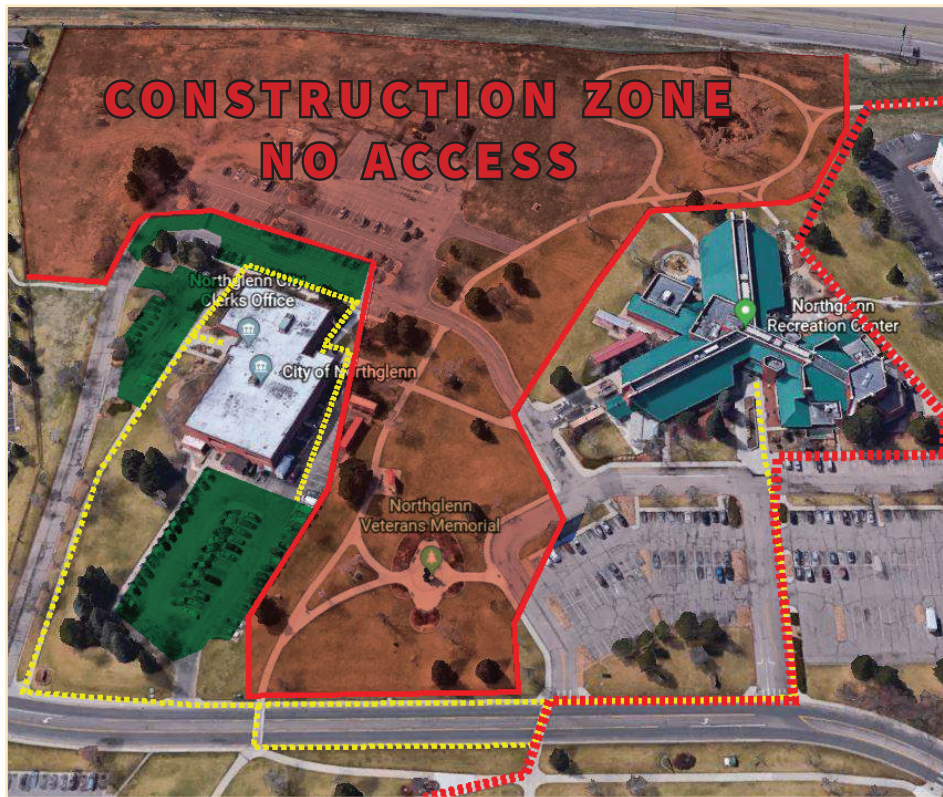
Visitors to the Northglenn Civic Center area will notice changes when accessing the site starting the week of Sept. 30.

Construction fencing and detour signs will be installed in preparation for construction on the city's new recreation center, theatre and senior center. Fencing will surround the entire construction area for the duration of the 18-month schedule. The construction zone includes the grassy area between City Hall and the current recreation center and much of the parking area between City Hall and Interstate 25.

The City Hall recycling bins will move to the northeast corner of the joint parking lot for Bill Goodspeed Happy Tails Dog Park/Jaycee Park, located at Leroy Drive and Irma Drive.

Pedestrian access to the I-25 underpass near 120th Avenue will be maintained throughout the project. There will be temporary changes to pedestrian routes and parking at times during construction, but signage will be posted to help pedestrians, motorists and cyclists navigate.

The facility will be built between City Hall and I-25. It will have a 320-seat theatre, senior center, preschool area, basketball courts, lap and leisure pools, and more. Learn more at www.northglenn.org/newreccenter.

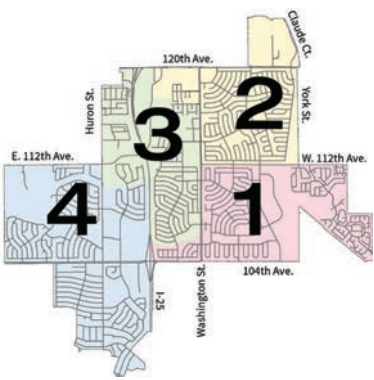

Resolutions:

Police Department Receives Grant for Vehicle Training

CR-99 – Council unanimously accepted a grant from Peace Officer Standards Training (POST)¹ for \$8,200. The funds will cover the cost to purchase and install vehicle bumper guards for Tactical Vehicle Intervention (TVI) training.

Civic Center Streets Named

CR-100 – Council unanimously passed a resolution to name two streets within the future Northglenn Civic Center.² The east-west street will be called “Memorial Parkway.” It will go from Community Center Drive to the front of the new Northglenn Recreation Center/Senior Center/Theatre. The north-south street will be “Northglenn Way.” It will run along the front of the new rec center.

Engineers Hired for Civic Center Project

CR-101 – Council unanimously approved an agreement with Group 14 Engineering to be the building enclosure and commissioning consultant for Phase I^{2a} of the Civic Center Master Plan. Group 14 will check building systems and enclosure early in design, during construction and upon completion. This will help identify any potential issues that have a long-term impact on building or occupant health. The cost will not exceed \$91,649. ► For more information on the project, go to www.northglenn.org/newreccenter.

Project to Address Pedestrian Mobility on East 112th Place

CR-103 – Council unanimously approved an agreement with Northern Colorado Concrete (NCC) for the 2019 CDBG Pedestrian Mobility Asphalt Project. NCC will:

- Install a raised crosswalk and two ADA ramps at East 112th Place at the Wyco Trail crossing
- Replace asphalt at several locations on Claude Court between East 112th Place and 120th Avenue

The amount will not exceed \$124,403.50. The city will use Community Development Block Grant (CDBG) funds.³

Lane Striping on Claude Court

CR-104 – Council unanimously approved an agreement with Kolbe Striping for the 2019 CDBG Pedestrian Mobility Lane Striping Project. Kolbe will install a bicycle lane and shared lane striping on Claude Court from 120th Avenue to the Wyco Trail crossing on East 112th Place. The amount will not exceed \$75,596.50. The city will use Community Development Block Grant (CDBG) funds³ for the project.

SEPT. 9, 2019

Ordinances – First Reading:

Initial Approval of Re-Zoning of Civic Center Land

CB-1932 – Council unanimously approved on first reading an ordinance that would re-zone a 7-acre portion of the Civic Center property from Mixed-Use Corridor to Public Facilities. The city is building its new Northglenn Recreation Center/Senior Center/Theatre on this property, located on city land between City Hall and Interstate 25. Mixed-Use Corridor is challenging to comply with for the size and location of the new facility. ▶ For more, see the story on the cover.

Funding Mechanism for New Rec Center Initially Approved

CB-1933 – Council unanimously approved on first reading an ordinance that would allow city officials to carry out a site lease and lease purchase agreement. The city would issue Certificates of Participation (COPs), a lease-purchase financing mechanism, to fund the new Northglenn Recreation Center/Senior Center/Theatre. This mechanism was used to finance the Justice Center in 2017. The city would issue \$42 million in COPs and make payments on them. The purchasers would receive their money back, with interest. The city would use the 1/2% sales and use tax and 4% special marijuana tax to pay for the facility. The estimated annual debt service is \$2.8 million over 20 years.

Change of Council Appointment Schedule Initially Approved

CB-1934 – Council unanimously approved on first reading an ordinance that would amend Section 2-2-3(b) of the Municipal Code. The timing for assigning council liaison and committee appointments would change. Instead of deciding at the organizational meeting after election results are confirmed, council would have up to 60 days after certification. Council members serve as members or liaisons with city boards and commissions, council committees and outside organizations. The extra time would allow council members to learn about the positions. ▶ For a list of all liaison and committee assignments, go to www.northglenn.org/council.

Initial OK for Ban on Smoking in City Parks, Rec Areas

CB-1935 – Council unanimously approved on first reading an ordinance that would prohibit smoking and the use of electronic smoking devices in public parks and recreational areas.

Resolutions:

Company Hired for Indoor Play Equipment at New Rec Center

CR-102 – Council unanimously approved a contract with Playtime, LLC for the Civic Center Master Plan Phase I² Indoor Play Equipment. Playtime will create and install a themed play place within the Indoor Playroom of the new Northglenn Recreation Center/Senior Center/Theatre. This includes a high play structure for older children and low to the ground

elements for younger children. The cost will not exceed \$100,000. ▶ For more on the new recreation center project, see the story on the cover.

Maintenance Needed on Standley Lake Pipeline

CR-105 – Council unanimously approved a resolution allocating funding to the Standley Lake Pipeline Joint Operating Committee escrow account to pay for maintenance of the pipeline. Both Northglenn and the City of Thornton receive water from Standley Lake through the pipeline. The two cities have an agreement where they will equally share costs for repairs and maintenance. Necessary repairs have been identified, and the city will pay \$75,000 to cover its share of the costs.

Street Striping for Grant, Melody Drives



CR-106 – Council unanimously approved a contract with Kolbe Striping for the 2019 Residential Street Program Lane Striping Project. Kolbe will stripe Grant Drive and Melody Drive to accommodate bicycle and pedestrian mobility. This is in accordance with Connect Northglenn, the city's bicycle and pedestrian master plan. A new layer of asphalt was placed on these streets, requiring the re-striping.

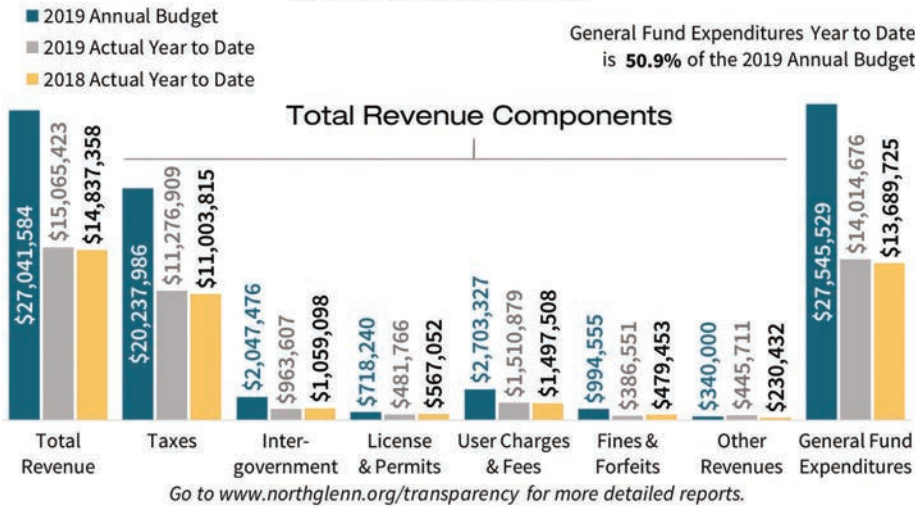

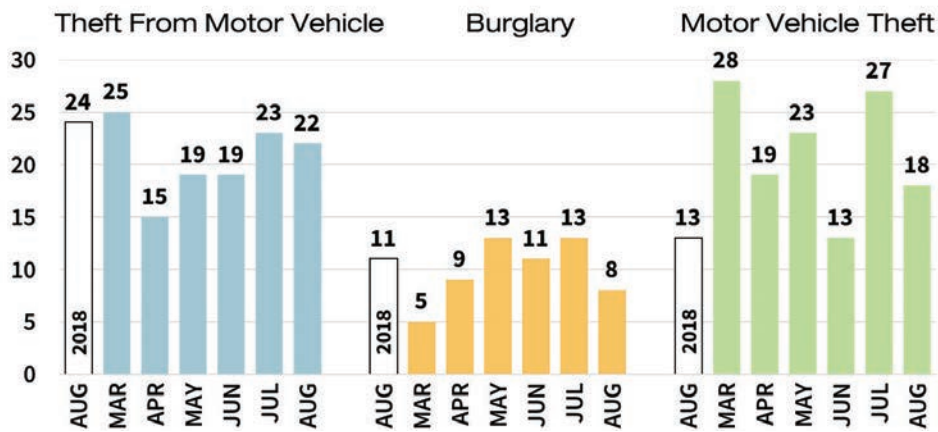

Voters to Receive Ballots in Mail for November Election

► City Candidate Forum on Oct. 16

Northglenn voters will elect a mayor and one council member in each of the city's four wards in the Nov. 5, 2019 election (*see list of candidates below*). Voters will also decide whether the language in the city's charter should be amended to be gender-neutral (*see wording below*).

Ballots for the Nov. 5 election will be mailed to registered voters by the Adams County Election Department beginning Oct. 11.

Ballots cannot be forwarded through the mail, so it is important that your voter registration record is accurate. The city encourages all voters to check your voter information to ensure you are receiving the correct ballot for your ward. Voters can review and change their registration address at www.GoVoteColorado.com.

Residents with a Colorado driver's license or ID card issued by the Department of Revenue can register on the website to vote. Voter registration can also be done in person at the City Clerk's Office, Adams County Election Department and at motor vehicle locations.

Completed ballots must be returned by 7 p.m. on Nov. 5 to be counted. Postmarks do not count. Instructions on returning your ballot, either by mail or at a drop-off site, will be included with your ballot.

Voters can also physically drop off their ballot at an Adams County Voter Service & Polling Center, or a 24-hour drop box (*see below for locations*).

Mayor Antonio B. Esquibel and City Council recognized the Healing Hoop Pow-Wow's fifth anniversary during a proclamation at the Sept. 9 council meeting. Afterward, dancers from the pow-wow gave a short performance.

The Healing Hoop Pow-Wow occurred Sept. 14 and 15 at the Stonehocker Farmhouse property. Organized by the Lakota Way Healing Center, the pow-wow was created in the spirit of togetherness and affirmation of Native American culture. It also honors the sacred connection of our community and the healing ceremony of song and dance.

\$120M Proposed Budget

The proposed 2020 City Budget was presented to City Council on Aug 5. The proposed city budget is built on a strategic framework to meet the desired level of services by the community, invest in city infrastructure and build financial sustainability for the future.

The proposed 2020 Budget does not anticipate any new tax increase.

The chart to the bottom shows projected revenue for the eight funds that comprise the budget.

Overall, citywide revenues for the proposed 2020 Budget stand at \$95 million with city-wide expenditures at \$120 million. The personnel budget expects a 4.27 percent rise. This includes three new police officer positions. The General Fund, which includes salaries and day to day operations, is balanced.

A public hearing on the proposed 2020 Budget is set for Oct. 14 and adoption of the budget is scheduled for Oct. 28.

Mayor's Memo: A Message from Mayor Antonio B. Esquibel

Police Department Moving Ahead With Officer Recruitment

One of the questions I often get as mayor is “what is the city doing to hire more police officers?”

In the fall of 2018, our city manager, Heather Geyer, and Police Chief Jim May developed a Five-Year Staffing Plan to hire additional police officers. City Council approved this plan, which incrementally increases the number of police officers between 2019 and 2023.

Over a five-year period, the city will increase sworn officers by 12 positions. In the 2019 City Budget, City Council increased police officer staffing by two positions. The 2020 proposed city budget includes three additional positions. This will bring the total number of police officers to 59.

In addition to police officers, the department is led by Chief May, nine sergeants and four

commanders. In late spring 2019, the department hired two new commanders, Heidi Walts and Mike Prange. We are fully staffed with nine sergeants.

The department has continued to build its team in accordance with the plan. Currently, the department has five vacant police officer positions. Chief May is working towards having these positions filled by spring of 2020. Once the vacancies are filled, one of the biggest changes you will see is a dedicated traffic unit.

The low unemployment that we have been experiencing along with societal challenges in the perception of policing has resulted in seeing a significant decline

in the number of applicants applying to fill vacancies. However, with this in mind, the Police Department offers a competitive salary and benefits. We have been running lateral recruitment processes and offering an award upon successful completion of the field training program to attract talent from local enforcement agencies in Colorado as well as out of state.

City Manager's Column: A Letter from Heather Geyer

City Dedicated to Code Enforcement

In my first year as City Manager, one area has received a lot of attention – Code Enforcement. I often get questions (and complaints) about things not being done or whether we have enough staff and why things take longer than we hope.

Like most things, code enforcement is a process and there are many things that happen once a complaint is filed and until it is closed out. In Northglenn, 30 percent of our code enforcement activity is complaint based and 70 percent is proactive enforcement. Our officers take complaints via phone, in person or through the Access Northglenn app. They also work a specific geographic area in the city, which allows them to become familiar with neighborhoods and to be proactive when they see properties with violations while on patrol.

Our Neighborhood Services Division is in the Planning Department. There are seven employees: five officers, one supervisor and an administrative assistant who in 2019 will have handled 2,195 cases. Of these total cases, 95% are residential, meaning this does

not include multi-family residential, commercial or industrial properties. With about 9,400 single family residential units in Northglenn, staff touches approximately 30% of these each year. Properties may have single or multiple violations at any given time.

What does this mean for our residents? We need you to be the eyes and ears

of our community. It means if you see something, say something. However, just because you see something, that doesn't mean nothing is being done about it. Within our process, a property owner is given a defined amount of time to get the property into compliance.

How to Report a Complaint

You can report a complaint through the Access Northglenn app on your phone or by calling 303.280.7876. Some residents have asked if they can submit anonymous complaints. The simple answer is yes. Most complaints can be made anonymously. However, because of the Fourth Amendment, when the violation cannot be seen from the public view of the officer, we will need your permission to gain access onto your property to view the violation. An officer may need to testify as to how they viewed the violation and who gave them permission to enter your property.

Northglenn is a beautiful community and we need your help in keeping it that way!

Keep Eye on Ash Trees

City Taking Steps to Prevent Spread of EAB

The presence of emerald ash borer (EAB) – an invasive, highly destructive tree pest – has been confirmed in Westminster.

Emerald ash borer (EAB) is a non-native, wood-boring beetle that is responsible for the death or decline of millions of ash trees in the United States and Canada. EAB attacks and kills stressed and healthy ash trees. It is so aggressive that trees typically die two to four years after becoming infested. As a non-native insect, EAB lacks predators in North America to keep it in check.

EAB was first confirmed in Colorado in 2013, in Boulder. Since then, the pest has been confirmed in five other municipalities in Boulder County, as well as in Broomfield in late August.

After the confirmation of this pest in Broomfield, Westminster forestry staff conducted further investigation and discovered the pest near 128th Avenue and Zuni Street.

Around 15 percent or more of all urban and community trees in Colorado are ash species susceptible to EAB.

Northglenn Response

So far, Northglenn has had no confirmed cases of EAB. However, with confirmed cases so close, city parks staff have begun treating about 250 ash trees on city property with a pesticide that makes them undesirable to EAB and other insects. Also, they have stopped planting any new ash trees susceptible to EAB.

EAB Tips for Residents:

- **Determine if you have any ash trees.** They have compound leaves with five to nine leaflets. Leaflets, buds and branches grow directly opposite from one another. Mature ashes have diamond-shaped bark ridges.
- **If you have an ash tree, start planning.** Decide if the health of your ash tree merits treatment or if it would be best to replace it. If you aren't sure, contact a certified arborist.
- **Recognize signs of EAB:**
 - Thinning of leaves in the upper tree canopy
 - 1/8-inch D-shaped holes on the bark
 - Vertical bark splitting with winding S-shaped tunnels underneath
- Report suspect trees by calling the state Department of Agriculture at 1.888.248.5535.

Sweeping Streets Throughout October

The city takes pride in keeping our residential streets as clean as possible. In order to do that, the Streets Maintenance Division sweeps all city streets in the spring and again in the fall.

The fall sweeping will begin on Oct. 8 and continue through the end of the month.

We need help from residents to get the job done. Please review the map below to see when your street is scheduled and

make sure you have moved any vehicles, trailers and any other items off the street or to the opposite side of the street on your scheduled day.

We will only be on each street the day(s) scheduled. **That means if a vehicle is not moved in time, that area will not get swept.** Please notify your neighbors if you see their vehicles parked incorrectly.

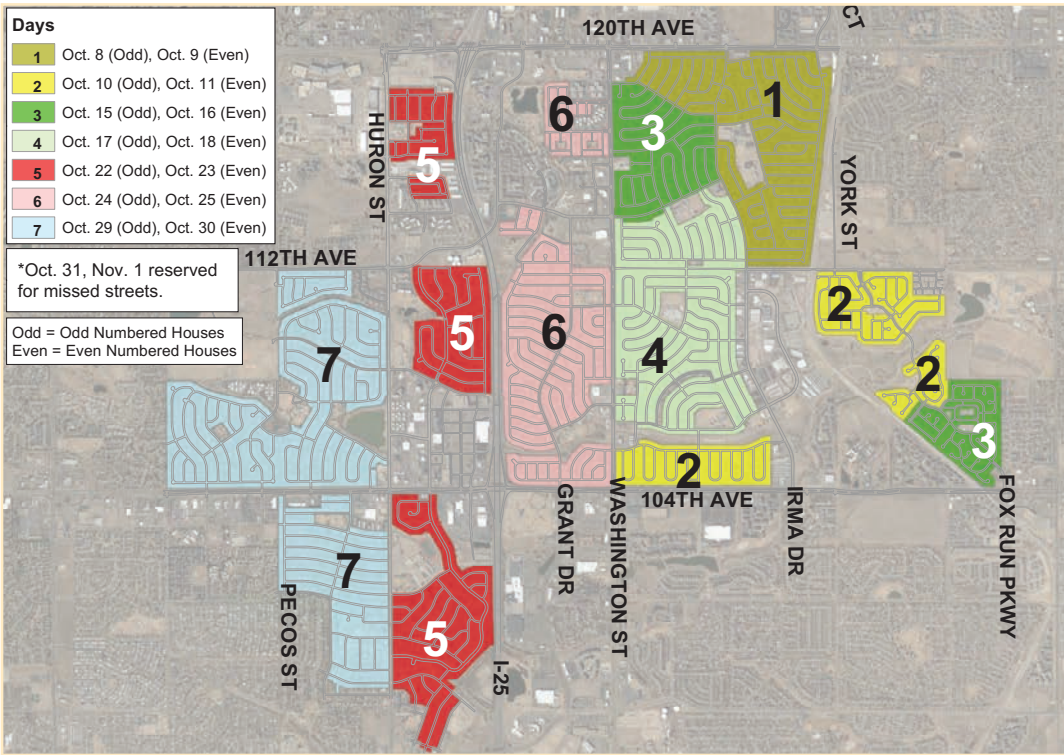
To help reduce confusion and disruption

to residents, once the schedule is made we must stick to it, weather permitting. If we have a weather or other emergency that causes us to miss any street(s), the affected streets will be rescheduled after this schedule has been completed. If needed, a new schedule will be posted at www.northglenn.org/streetsweeping.

Thank you for doing your part! Some of the benefits of street sweeping include:

- Prevents trash and other contaminant from running into local waterways
- Reduces dust and improves air quality
- Keeps pavement markings visible to improve safety for drivers, pedestrians and cyclists

STREET SWEEPING MAP

The map shows seven areas labeled 1-7. Each area requires two full days to complete. Your address determines your sweeping day.

If your address ends in 1, 3, 5, 7 or 9, you are on the odd schedule. If the number of your address ends with 0, 2, 4, 6 or 8, you are on the even schedule.

- The first date is the odd-numbered side of the street.
- The second date is the even-numbered side of the street.

Example: On the map, the area identified as 1 will have all streets in that area completed on Oct. 8 and 9.

On Oct. 8, the sweepers will clean from the middle of the street to the curb on the side with odd-number addresses.

On Oct. 9, the sweepers will clean from the middle of the street to the curb on the side with even-number addresses.

You must keep the sweeping side of the street clear from 7 a.m. to 4 p.m. for both days of the cycle. You may still drive on the street, but not park.

This process will continue throughout the entire schedule.



PUBLIC WORKS UPDATE: PROJECTS IMPACTING RESIDENTS AND ENSURING THE CITY'S INFRASTRUCTURE IS SOUND

Concrete Trails Replacement

- **Update:** The contractor, Keene Concrete, began work on Sept. 16.
- **Description:** Every year the city allocates money for concrete trail repair throughout Northglenn. This year sections of Huron Trail, Community Center Drive Trail and the Grange Hall Creek Trail will be repaired.
- **Anticipated Completion:** September

E. 112th Ave. and York St.

- **Update:** Signal poles were installed and paving scheduled for the last week of September. The signals will remain out of service until the Thornton portion of the project is further along and proper striping can be completed.
- **Description:** Roadway improvements to East 112th Avenue, including:
 - Extension of the sidewalk from the train crossing to York Street on the north side of East 112th Avenue
 - Improvements at East 112th Avenue and York Street intersection
 - Installation of a traffic signal at Fox Run Parkway and East 112th Avenue
- **Anticipated Completion:** November

Residential Street Program

- **Update:** The contractor completed work on 115th Avenue and moved to Phillips Drive. Truda Drive was added as an alternate and will be next, then crews will move on to Grant Drive and

Melody Drive.

- **Description:** The program maintains and improves Northglenn streets and sidewalks. Included this year is removing and replacing the top layer of asphalt on Melody Drive and adding bike lanes to it. The following streets will also be worked on:
 - Phillips Drive from Irma Drive to Claude Court
 - East 115th Avenue from Irma Drive to Claude Court
 - Grant Drive from Malley Drive to Muriel Drive
 - Larson Drive from Muriel Drive to East 105th Place
 - Melody Drive from West 104th Avenue to Huron Street
 - Truda Drive from Irma Drive to Claude Court
- **Anticipated Completion:** October



Community Center Drive Median Replacement

- **Update:** Completed ahead of schedule and under budget.
- **Description:** The Community Center Drive median block wall was reduced to ground level and sight distance

increased through the crosswalk area. A new curb, striping and signage have been completed.

104th Ave. Bridge Painting

- Streets crews painted both sides of the barrier crossing on the bridge in late August.

Grant Drive Four-Way Intersections

- **Update:** Complete
- **Description:** A couple of months ago Engineering Division staff received a request for crosswalks at Grant Drive and Leonard Lane. The resident was in a wheelchair and it was difficult crossing the uncontrolled intersection. Engineering performed the analysis and Streets Division crews made this intersection a four-way stop with crosswalks. The resident contacted engineering the same day and thanked the city for the work and accessible path. Later, crews made the intersection of Grant Drive and Northglenn Drive a four-way intersection with crosswalks.

Projects Starting Soon

- Rehabilitation of sewer line pipes by lining the areas that might have damage
- Water line replacement on a section of Garland Drive
- Storm drainage improvements on areas around the city that need repair

Free Landfill Day Oct. 12

Sat., Oct. 12, 7 a.m.-2 p.m., Tower Road Landfill, 88th Avenue, just east of Tower Road, Commerce City

Northglenn residents – this is your free chance to dispose of items that are too large to fit in your trash cart!

Free Landfill Day Rules:

- Only one load per residence.
- All loads must be covered.
- Proof of residency such as a driver's license or a current utility bill with picture ID is required.
- Mattresses and box springs cost \$30 each to drop off.
- People bringing a pickup truck or trailer face a gate charge plus taxes and fees if they have more than five cubic yards of materials.
- A safety vest must be worn when unloading. They are provided at the landfill entrance.
- The following are NOT accepted: Electronics, tires, car batteries, appliances with Freon, fluorescent bulbs and hazardous liquids or materials.

Plan Ahead, Know Options to Be Safe

► National Preparedness Month in Sept. and Fire Prevention Week in Oct.

STAY PREPARED, NOT SCARED BY PLANNING FOR EMERGENCIES

National Preparedness Month, recognized each September, promotes disaster and emergency planning.

Northglenn has generally been spared from the ravages of natural disasters. But depending on the season, blizzards, flooding and tornadoes are each very real threats.

This year's National Preparedness theme is "Prepared, Not Scared." With that in mind, the Police Department encourages residents to take these steps:

1. Sign up for CodeRED

CodeRED is the Emergency Notification System in Adams County. Notifications are based on information from local public safety officials, including



the Police Department and North Metro Fire Rescue. Alerts could include natural disasters, missing persons, shootings, shelter-in-place, evacuations, fires, road closures, etc.

CodeRED is set up to contact all home landline phone numbers within a geographical jurisdiction. **If you do not have a home landline and only a cell phone, you are not automatically in the notification system.** You will need to register your cell phone to receive alerts by going to www.northglenn.org/codered and click on the CodeRED button, shown to the right.

2. Shelter Plan

Taking appropriate shelter is critical in times of disaster.



Depending on the disaster and your location, it could be a basement, closet, crawl space, roof or pre-designated shelter. In your home or work, know where the safest location is, and pass along the information to family and colleagues.

3. Emergency Kit

A basic emergency kit should include the following items:



- Water – One gallon per person per day for at least three days, for drinking and sanitation
- Food – At least a three-day supply of non-perishable food per person
- Manual can opener for food

- Battery-powered or hand-crank radio and a NOAA Weather Radio with tone alert

- Flashlight
- Extra batteries
- First aid kit
- Whistle to signal for help
- Moist towelettes, garbage bags and plastic ties for personal sanitation

- Wrench or pliers to turn off utilities

- Local maps
- Cell phone with chargers and a backup battery
- Medications

4. Evacuation Route

Plan how you will leave and where you will go if you are advised to evacuate.



Identify several places you could go in an emergency, such as a friend's home in another town or a motel. Choose destinations in different directions so that you have options.

If needed, identify a place to stay that will accept pets. Most public shelters allow only service animals.

Always follow instructions of local officials. Remember, you may have to travel on foot.

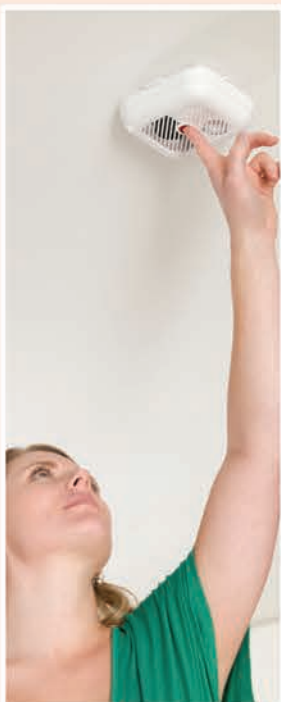
5. Communication and Re-Unification Plan

National Fire Prevention Week is Oct. 5 through 12

Whether seven years old or 77 years old, everyone should know at least two ways out of their home and any residence or business they are visiting.

With today's construction and home furnishings, families may have two minutes to get out of their home before they are overcome with smoke and fire.

However, planning out ways to escape during a fire is only the first step. In order for it to be effective, families must practice their plan throughout the year.

Here are some tips to help parents teach their kids about fire safety:

- Draw a map of each level of the home, showing all doors and windows.
- Have your children point out all the potential exits.
- Discuss who will help children, older adults and people with disabilities wake up and get out.

- Teach children how to escape on their own in case you can't help them.
- Establish a meeting place outside and away from the home.
- Have properly installed and maintained smoke and carbon monoxide alarms.
- Practice what to do in case there's smoke – get low and get out fast.
- Practice using different ways out.
- Set up a surprise alarm once your kids are asleep to test their reaction.
- Emphasize to never go back in the building after you leave for any reason.
- Teach your kids to go to your meeting place and call 911 from a cell phone or neighbor's phone.

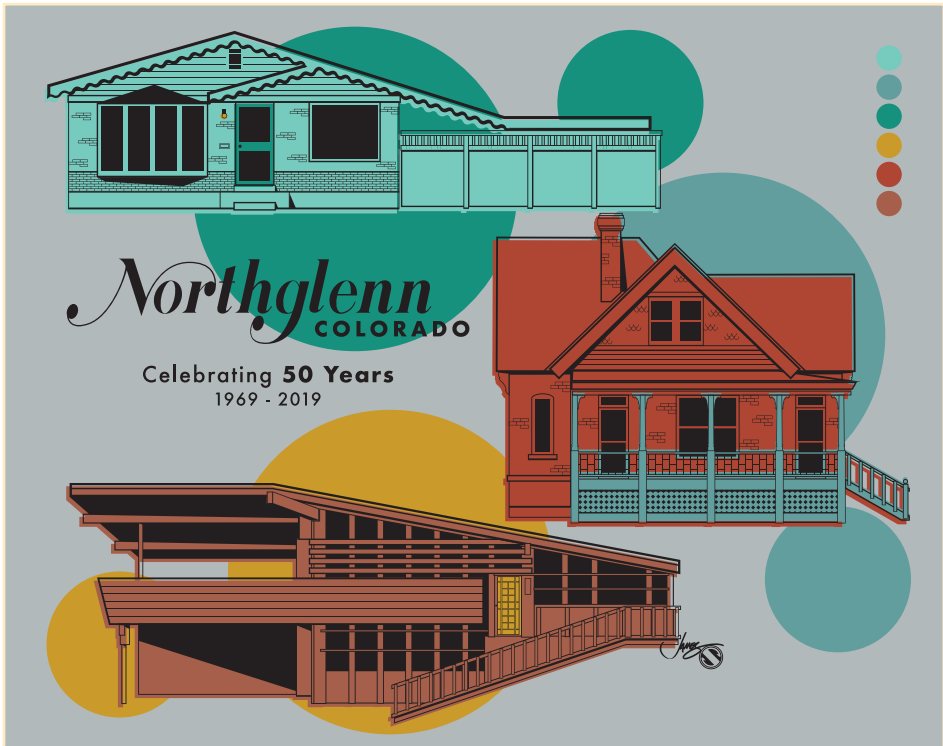

Unprecedented Academic Growth for Adams 12 District

► 4 City Schools Receive Highest Rating Ever

For the fourth consecutive year, Adams 12 Five Star Schools has been accredited as a Performance District, the second-highest rating for school districts in the state of Colorado. The Five Star District earned 61.9 percent of framework points, an increase of nearly 5 percentage points since 2016 when the district received its first Performance rating.

Based on the recent state release of preliminary ratings for school districts, the Five Star District has demonstrated the greatest sustained academic growth over the past five years as compared to districts with similar demographics. Comparable districts include eight additional school districts across the state with similar student enrollment, free and reduced lunch percentage, and the percentage of English language learners.

In 2014, the Five Star District was rated an Improvement District and ranked eighth out of nine comparable districts; in 2019 the Five Star District now ranks second among those same districts.

"We've now solidly arrived in the Performance category with peer districts and we're doing incredible work to serve our diverse group of kids, but we're within two points of being the top," said Superintendent Gdowski. 

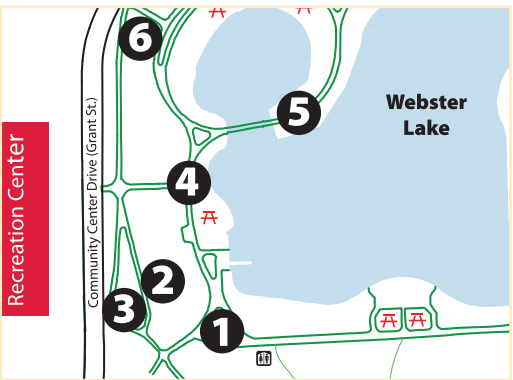
