STAY OFF THE ICE

Recently, North Metro Fire Rescue and the Thornton Fire Department teamed up to do ice rescue drills at local lakes. They used mannequins to simulate both pulling the person from the water and then helping the person recover from hypothermia.

Please remember that it is prohibited to go on the ice at any of the city's lakes and ponds no matter how cold the weather has been.

If you discover a person or animal that has fallen through the ice, call 911 immediately. Do not go out on the ice. Otherwise, authorities may have two rescues to make!

Force is Strong With This One

Necessary Sewer Pipe Project Will Affect Traffic, Water at Various Spots in West Northglenn Through January '22

The largest of the Northglenn Underground projects is about to dig in - literally. At the end of March, contractor BT Construction will begin the Force Main A project. This is a major sewer line replacement that stretches nearly the entire length of Northglenn along Leroy Drive and Irma Drive.

"Big infrastructure replacements are messy and disruptive...and also important," said city Civil Engineer Michael Roman. "Frequent sewer line breaks due to aging sewer lines are a lot more disruptive, though, so we really need to get this replacement done."

The project will take place from March 2021 to January 2022, but not the entire stretch the whole time. Work will be done in sections, and at times with two crews in different locations along the line.

What should you expect?

Traffic impacts due to construction will be the most noticeable to people in the area. Residents near the replacement area may have water/sewer interruptions or limited access to driveways for short periods of time when work is done nearby.

Early notification of impacts is a priority, so please watch for direct mail, door hangers and social media notifications so you know what to expect.

On Dec. 21, Council unanimously voted to issue Wastewater Revenue Bonds to finance this replacement and other improvements. The estimated cost to replace Force Main A is \$14 million.



He was chosen again to represent the residents of Ward 1 as a council member at a special election in 1986 to fill a vacancy on City Council.

While on council, Don served as the first Mayor Pro Tem, ex-officio member of the Planning Commission, and alternate representative to the Denver Regional Council of Governments.

He served on the Council Traffic Committee, Utility Commission, Liquor Licensing Authority, Committee on Appointments, 10th Anniversary Committee, Standley Lake State Parks

We honor Mayor Burback's service to the city both as an elected official and an engaged resident.



Through his campaigns, Don said he was running for the chance to be a public servant, not a politician. His priorities included providing services to residents, building trust, and maintaining honesty and openness in government.

Mayor Burback and his wife, Mary Lou, raised their sons Steven and David in Northglenn.

Don was a member of the Elks Lodge, a charter member of the Masonic Lodge, a leader in Cub Scout Pack 523, active in Boy Scouts, a Little League football and baseball coach, and a former director of the Northglenn Jaycees. Don was also active in his church.

Former mayor Burback was a member of the Northglenn City Council for 17 years in total and was well-respected for his experience, his priorities to see Northglenn become a safe, selfsustaining community, and his dedication to the City.



PROGRESS IS HOT, IN SPITE OF THE COLD



Despite the chilly weather, the sun shines on construction of the new Northglenn Recreation Center, Senior Center and Theatre.

The theatre side of the building is progressing well with some finishes going in such as wall and floor tile, and even millwork in the green room and rehearsal room. Also, the elevator cab has been installed in this side of the building.

The joists in the pool area are being painted and will allow for the finish work on the concrete pool deck to begin next month.

On the exterior of the building, siding installation has started on the north face of the building, which can be seen by passersby on Interstate 25.

Other major outdoor improvements have wrapped up for the winter months, with landscaping installation planned for this spring and summer.

The solar array subcontractor has been selected and has begun finalizing the

design details and project scope. Staff is also weighing the costs and benefits of expanding the solar array.

The new 87,887-square-foot facility, located behind City Hall and just south of the current center, will offer swimming, fitness areas, preschool, arts & culture programming and classes. Estimated completion is late 2021.




General Fund Expenditures Year to Date is 87.7% of the 2020 Annual Budget

the best course of action.

Tri-County Health Department is continuing to work with the State of Colorado to ensure vaccine equity, but until they are easily accessible we will take baby steps for everyone's safety. To date, eligible police officers, code enforcement officers and preschool teachers have been able to receive the vaccine under the state's vaccine framework. All other staff will not be eligible until Phases 2 and 3.

According to the Tri County Health Department's COVID-19 Page, *www. tchd.org/COVIDvaccine*, vaccination priority in Colorado is in this order:

- Now: Highest and moderate-risk health care workers; highest-risk individuals; people age 65 and older; first responders; pre-K-12 educators and child care workers in licensed programs; and continuity of state government
- Soon: Frontline essential workers and people age 16 to 64 with two or more high-risk conditions
- **Spring:** People age 60 to 64, people with high-risk conditions, continuation of operations for state government and continuity of local government
- Summer: Anyone age 16 to 59


NURA's primary purpose is to improve business areas in Northglenn by eliminating blight, assisting development **RENEWAL AUTHORITY** and redevelopment projects,


Since 2005, 153 grants and incentives have been awarded for a total amount of \$17.5 million.







A DRY COLD

City staff have been tracking the drought conditions throughout the state and how it is affecting the city. The graphic above shows Northglenn's supply of water in Standley Lake, the city's main source of water.

At the end of January, the total was only 4,061 acre feet. That's down 28% from the average for this time of year.

Although new restrictions are not in place, conservation now will make a difference later this year.
