Stage 1 Drought Declared

► City Committed to Reducing Water Consumption 10%; Residents Asked to Lower Usage

The City of Northglenn is taking a proactive approach in response to statewide drought conditions.

City Council declared a Stage 1 Drought in Northglenn at its April 12 meeting. This is the least-severe designation that council can declare.

The city is committing to reduce water usage by 10% at its facilities and parks. Residents are asked to voluntarily lower water use – see if you can beat our 10% mark!

City staff has been following the conditions in the Clear Creek watershed basin and Standley Lake Reservoir, as they hold the city's drinking water supply. Based on historical statistics including snow levels and storage levels, the amount of water predicted for Standley Lake in June is anticipated to be lower than normal.

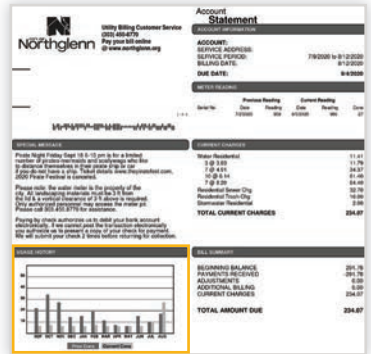
By reducing water use now, the city can hopefully avoid taking more drastic water-cutting measures if conditions don't improve.

As of April 20, 89.1% of the state is in moderate drought, while 60.5% is in severe drought. For more updated numbers, go to www.drought.gov/states/colorado.

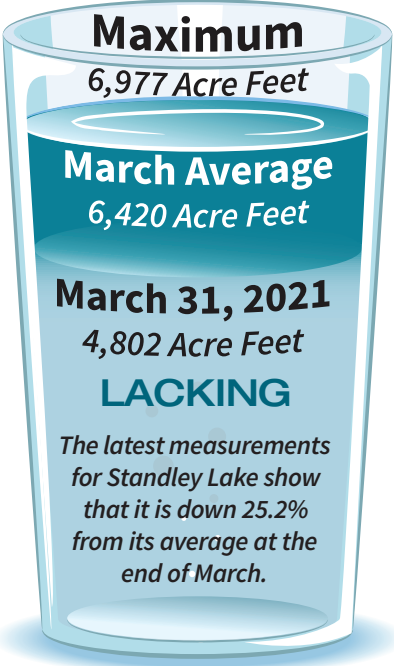

ESQUIBEL STEPPING DOWN

Council Member Antonio B. Esquibel announced he will be stepping down on June 11, 2021. He will be moving out of state to be closer to family.

Esquibel was elected to serve as the Ward 4 City Council representative in November 2015, was appointed as Mayor Pro Tem in November 2017, appointed mayor in June 2019, and elected to serve

again as Ward 4 Council Member in November 2019.

FOOD DELIVERY FEE CAP EXTENDED

City Council voted to extend the Food Delivery Fee Cap ordinance that expired on March 31. The extension took effect immediately and will be repealed following 30 consecutive days of retail food establishments being authorized by the State of Colorado and Tri-County Health Department to operate at 100 percent capacity.

The ordinance prohibits the following actions:

- Performing a delivery or other service, or offering that service for a restaurant without the restaurant's consent

- Charging commissions or fees for the delivery platform service (for delivery or pickup) exceeding 15% of the purchase price (based on the restaurant menu price, not including taxes, tips, or other fees)
- Garnishing tips to cover the fee limit
- Charging fees for phone orders through the platform that don't result in a transaction

The ordinance also requires clear disclosures of fees and other costs prior to concluding the order and on receipts.

City Council is required to have two meetings a month. They also typically have two study sessions monthly to learn about and discuss topics in-depth. Special meetings are scheduled if more time is needed to complete city business.

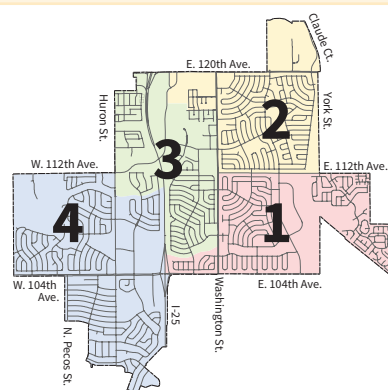

COUNCIL TO APPOINT NEW WARD 4 REPRESENTATIVE

Council Member Esquibel’s announcement that he will step down on June 11 will create a Ward 4 vacancy.

The process to fill a vacancy on City Council is provided in Section 3.8 of the City Charter and Section 2-2-7 of the Municipal Code. The code requires council to appoint a person qualified for the office of council member from the ward in which the vacancy exists.

There will be an application and interview process to appoint a person to serve in the position until the Nov. 2 election. Voters will determine who will serve a new Ward 4 four-year term and a two-year term in November (two years in order to preserve staggered terms of the two Ward 4 positions).

- In the preschool area, tile installation has started in the restrooms and the outdoor awnings over the windows are now in place.

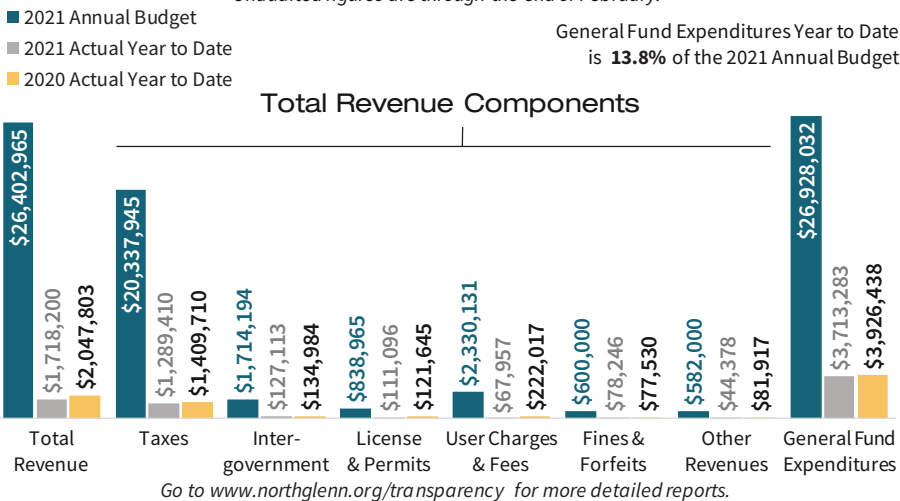
- The pool scaffolding has been removed and the finishing of the raw concrete edges has started.

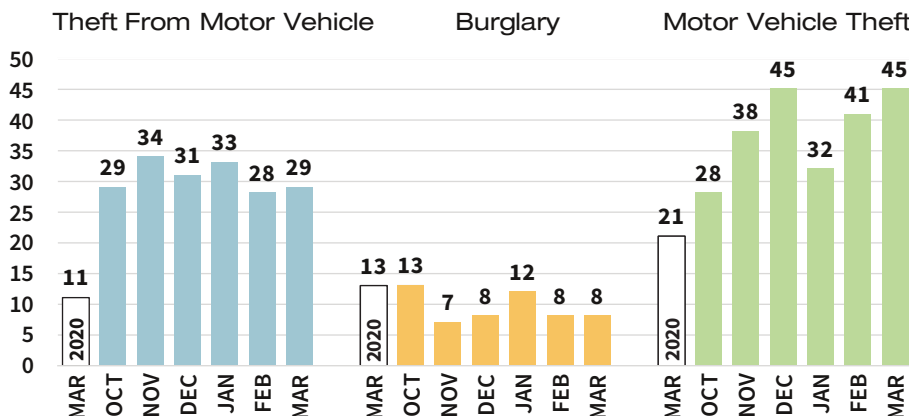
February 2021 General Fund Financial Report

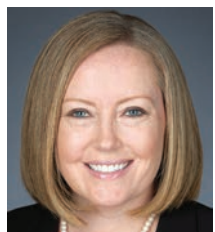

Strategic Moves

► Council, Staff Look at Updates to Strategic Plan

Pre-COVID, in what seems like a lifetime ago — but was really only two years — City Council adopted a new five-year strategic plan. The 2019-2023 Northglenn Strategic Plan (www.northglenn.org/strategicplan) has eight focus areas: High-Performance Government, Community Engagement, Public Safety, Business Retention and Growth, Housing Opportunities, Diverse Community, Sustainability, and Infrastructure. There were 174 action items in the original plan; 102 of the items are now ongoing operations or in-progress and 48 were completed. Originally 38 were on hold due to COVID-19; now only 13 are on hold. Since we are at the halfway point of the plan, it is a good time to revisit priorities.

At a Feb. 27 work session, City Council members and staff reviewed the current status, then brought forward 42 (!) new ideas for consideration. The eight ideas identified as the highest priority (in no particular order) include a restorative justice program, Police Department co-response program, Village Greens

fencing, an adventure course targeting youth ages 12+, Boys & Girls Club (likely a collaboration), N Line fare equity regional initiative, coordinated response to traffic issues (pedestrian safety, speeding, enforcement/engineering), and Webster Lake safety concerns.

Since then, staff has been evaluating different options for each of the priorities and identifying different ways to address the issues. In late May, City Council will review the progress to date on the updated Strategic Plan. In late June, staff will have an updated document available for public review.

In the months ahead, staff will bring forward the eight priorities individually for Council consideration of next steps. In these discussions, staff will present Council with realistic options for each of the priorities. They will decide the best way to proceed after evaluating and weighing aspects such as start-up/ongoing costs, staff time/needs, projected effectiveness, estimated number of residents impacted, possible outcomes, industry-best practices, lessons learned in our city and others, and more.

It is important as we move new initiatives forward that we have alignment with available resources. Just around the corner is the kick-off to budget 2022. Staff will begin budget planning and development in May. Look for details about how to provide input on the 2022 Budget in late summer!

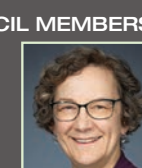

MASK UP & MOVE FORWARD | COVID-19 OPERATIONS

Still Need a Vaccine?

If you live in Northglenn, are 16 and older, and need help finding a vaccine appointment, contact the Senior Center at 303.450.8801!

All Coloradoans ages 16 and up are now eligible for the vaccine.

You can also visit www.tchd.org/covidvaccine to find local providers. If you need help scheduling an appointment, call 303.220.9200, press option 2 then option 1. **You must set an appointment with the vaccine provider FIRST. No walk-ins accepted.**

Indoor Mask Order At Least Through May 15

Face coverings are required to be worn by any individual 11+ years old when indoors in a public indoor place.

Masks are no longer required to be worn outdoors when 6-foot distancing is not maintained.

The order expires on May 15, when the Tri-County Health Department will re-evaluate the need based on community conditions. Statewide mask requirements may still be in place.

Fully vaccinated individuals may follow CDC guidance related to vaccination to determine when a mask/face covering is not required in private spaces.

Home Rental Assistance Available

Adams County

As part of its COVID-19 emergency response and recovery strategy, Adams County – in partnership with Maiker Housing Partners, Brighton Housing Authority, and Commerce City Housing Authority – has launched the Adams County Emergency Rental Assistance (ERA) Program. The Adams County ERA Program may be able to help eligible renters with past due rent, utilities, and future rent payments.

Eligible households must meet the following criteria:

- Qualify for unemployment or have experienced a reduction in

- household income, have incurred significant costs, or have experienced a financial hardship, directly or indirectly, due to COVID-19;
- Are at risk of experiencing homelessness or housing instability;
- Rent a home in Adams County; and

- Have a household income at or below 80% of the area median income.
- Additionally, landlords with tenants behind on rent may submit tenant’s contact information on behalf of the tenant through the Adams County ERA Program landlord portal.

On April 18, 2021, 16 Denver metro agencies, including the Northglenn Police Department, made a coordinated effort to show street racers their behavior will not be tolerated. More than 280 citations were issued and four arrests were made during the joint operation.

Thirty-four law enforcement agencies are continuing to work together to help put a stop to illegal street racing on Colorado’s roadways. This street racing working group was established in response to an increase in illegal street racing around Colorado. This group has been meeting and working on various methods to help curb the issue.

Street racing is a dangerous activity that puts lives at risk. Drivers who engage in street racing can quickly lose control and injure or kill themselves or other innocent roadway users. In addition, other criminal activities are often tied to these racers, increasing the level of danger. There have been reports of shots being fired during recent events.

Those who choose to take part in street racing can be subject to serious penal-

ties for crimes such as reckless driving, reckless endangerment, engaging in a speed contest, aiding in a speed contest, or obstructing a highway incident to a speed contest. These charges often carry enough points to lead to a loss of your driving privileges, fines, and possible jail time.

If you find yourself in a situation with vehicles racing around you or putting yourself and others at risk, try to separate yourself and safely move away from those vehicles. If you are witnessing street racing in Northglenn, call 911. You are also able to report these incidents to Colorado State Patrol at *CSP (*277) on your cell phone, or later at <http://reportstreetracing.com>.

FIREWORKS DON’T WORK HERE

July 4th is still two months away, but the city and the Police Department want to get the word out early that setting off fireworks is illegal in Northglenn.

By city ordinance, there is a mandatory MINIMUM fine of \$1,000 for private fireworks use – and last year 63 people found out first hand the law is enforced. Those caught using fireworks as well as the person who owns or lives on the property can be cited.

Though it’s impossible to stop all fireworks or catch all offenders, there will again be intentional Police enforcement to reduce illegal fireworks use.

The first portion of construction, on Irma Drive just north of East 112th Avenue, is now complete.

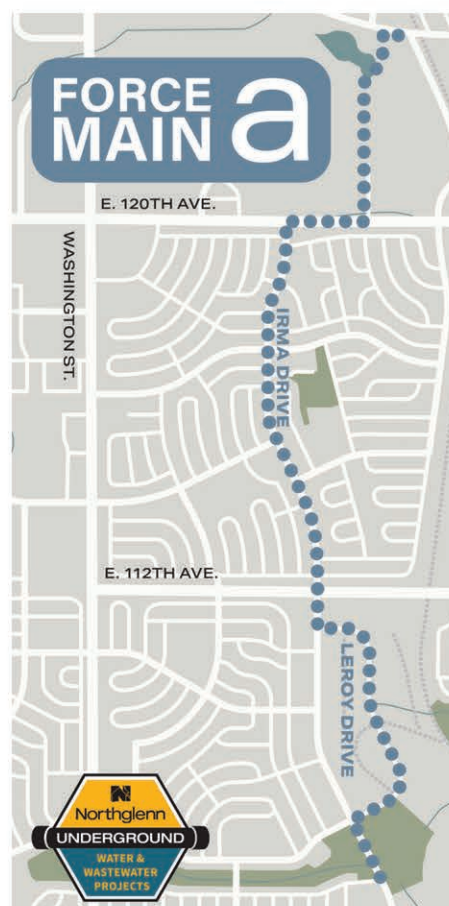
May will be a busy construction month with two open cut crews working, one continuing through the Irma Drive neighborhood and one in the Karl's Farm development. A bore crew will begin work on the first trenchless crossing at East 120th Avenue and Irma Drive.

A reminder – there will be detours and construction along Irma Drive and Leroy Drive between 104th and 120th avenues over the next 10 months. Electronic sign boards in the area provide some information.

Properties affected by the construction will receive notifications before work in the area begins via door hangers at least 48 hours in advance of any impacts.

fees if they have more than five cubic yards of materials.

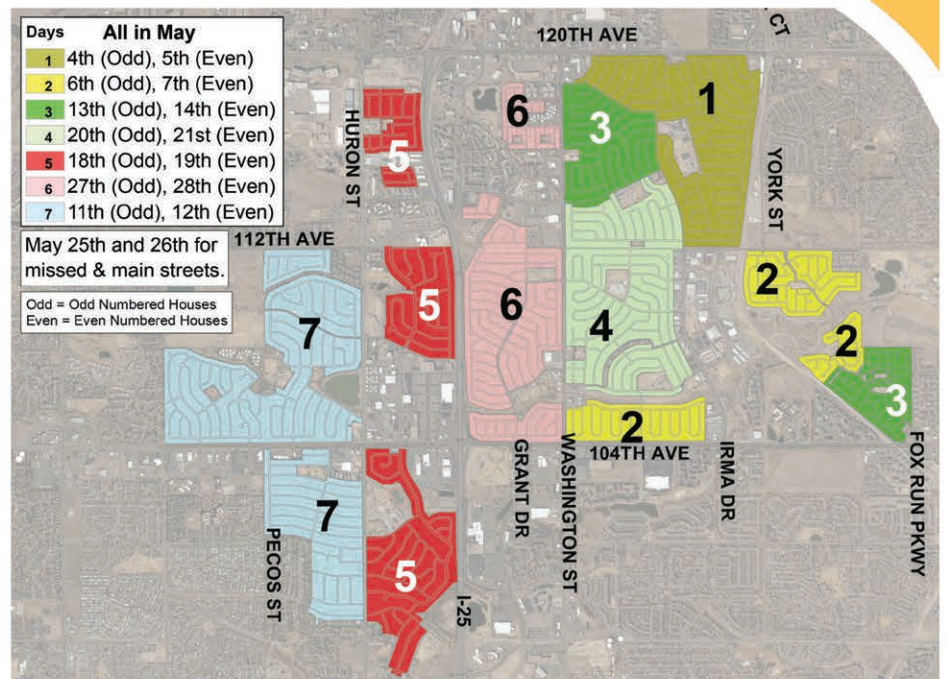
- A safety vest will be provided at the entrance and must be worn when unloading.

STREET SWEEPING MAP

The map shows areas labeled 1-7. Each area requires two days to complete. Your address determines your sweeping day.

If your address ends in 1, 3, 5, 7 or 9, you are on the odd schedule. If the number of your address ends with 0, 2, 4, 6 or 8, you are on the even schedule.

- The first date is the odd-numbered side of the street.

- The second date is the even-numbered side of the street.

You must keep the sweeping side of the street clear from 7 a.m. to 4 p.m. for both days of the cycle. You may still drive on the street, but not park.

This process will continue throughout the schedule.

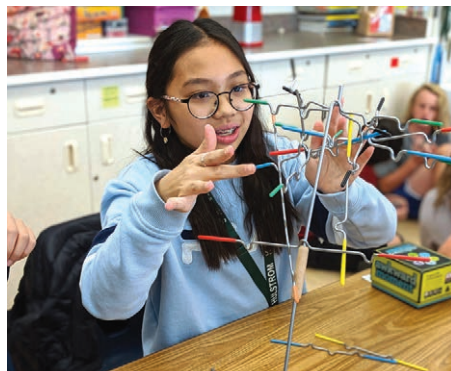

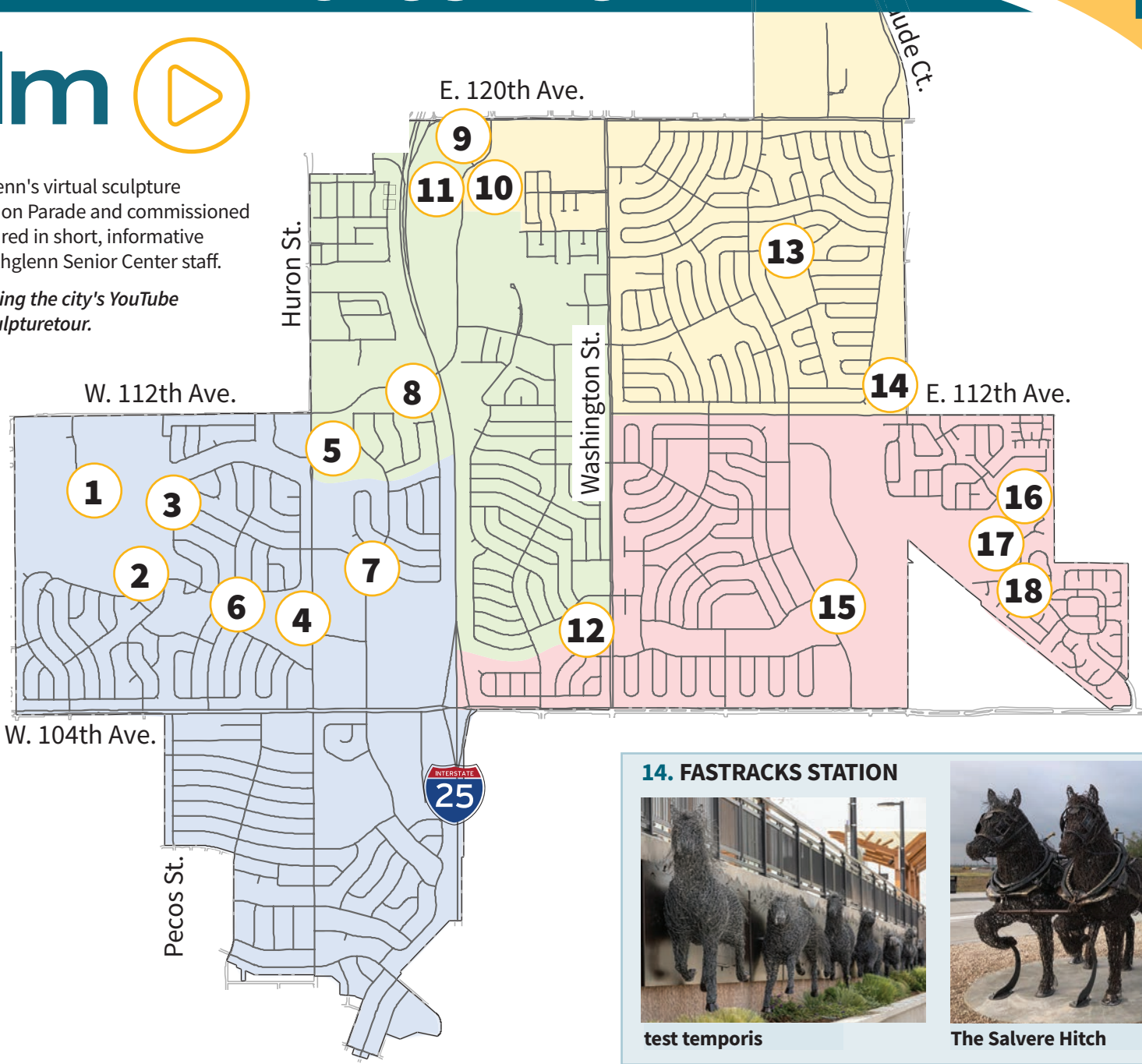

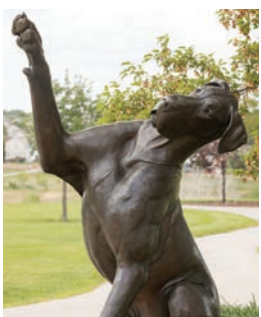
