## PROST

► Local Brewery Moving Headquarters, Operations and Biergarten to Marketplace

Prost Brewing Company is bringing its corporate headquarters, production and distribution center and a new biergarten to the Northglenn Marketplace.

The brewery portion is set to open in the first quarter of 2023, with the biergarten to follow in the summer or fall.

The Northglenn facility will create a family-friendly, affordable gathering place for the community to enjoy authentic bier and German chef-inspired food. It will include entertainment, live music, and special events that will attract more than 300,000 people annually to visit the biergarten, and more for special events and tours of the brewery.

The brewery will receive national recognition as one of the most sustainable and technologically advanced in the country. They plan to produce 20,000 barrels initially and grow to 40,000 to 50,000 over the next few years, which would solidify Prost as one of the top five largest craft breweries in the state.

Prost was founded in 2012 and is a family-owned and operated Colorado craft brewery focused on crafting German-style biers. They have locations in Denver, Fort Collins and Highlands Ranch, and distribute to four other states. They are one of the top 10 producing craft breweries in Colorado.

## Council Legislative Recap: July 2022

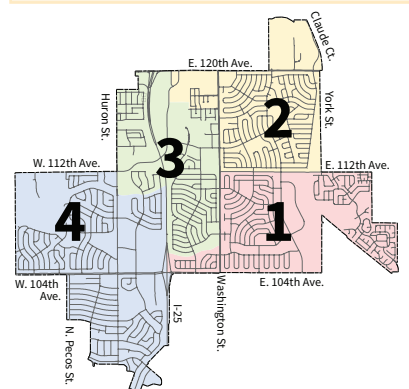

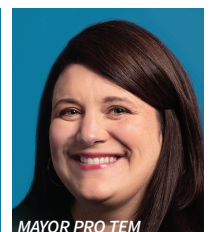

# No Reschedule For Fireworks

## ► Malfunction Forced Cancellation July 4; City Receiving Refund

After two weeks of thought and consultation, City Council has made the difficult decision to not reschedule the July 4th fireworks in Northglenn this year.

The city's July 4th event began wonderfully – the car show, duck race, music, food, honoring our flag, national anthem and gathering of family and friends was awesome. However, the fireworks show suffered a technical failure and could not be held as planned.

The evening of July 4 it was unclear why the fireworks would not fire – rain was the primary suspect. During later inspection, the vendor discovered one or more components were faulty. If the fireworks had been canceled due to rain, the rain date was the next day. Since the cause was an electronic component, rescheduling was more complicated. Everyone was disappointed that we couldn't hold the fireworks show.

The Northglenn fireworks show is a special-order, custom-made show because the space requires "proximate" fireworks due to the nearby structures and is shot off barges in the lake; this makes the setup complex. The vendor took full responsibility for the fireworks failure and offered a full refund or to reschedule the show.

"Not getting to watch the fireworks go off was a big disappointment to everyone attending the event or planning to watch from afar," said City Manager Heather Geyer. "July 4th is a huge deal for Northglenn, and the city apologizes that things didn't finish as we all hoped."

The city considered combining the fireworks show with a concert in the park/movie night on July 6. But with forecasted rain, challenges in providing staff on short notice, and most importantly, that many residents would not get the information about the rescheduled show, this plan wouldn't work. That, plus being a weeknight event, would undoubtedly impact attendance (a past fireworks rain date only drew 1,000 people, compared to 8,000 in attendance on July 4).

The city also pondered holding a new event later in the year that would include fireworks. At the July 11 meeting and again on July 18, council members discussed this option extensively, including new events on Labor Day weekend or Veterans Day. Public input varied widely – from "save the money" to "have fireworks at Pirate Fest or Noel Northglenn", along with many other suggestions. In the end, City Council felt a full refund was in the best interests of the city. They will discuss whether additional funding to have an enhanced fireworks show next year is feasible during 2023 Budget planning.

Thank you for your understanding, and we look forward to seeing you at future events, including next year's July 4th celebration.

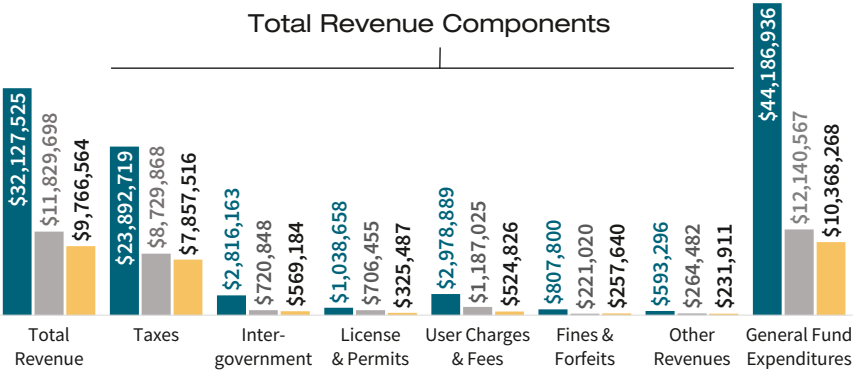

General Fund Expenditures Year to Date is **27.5%** of the 2022 Annual Budget

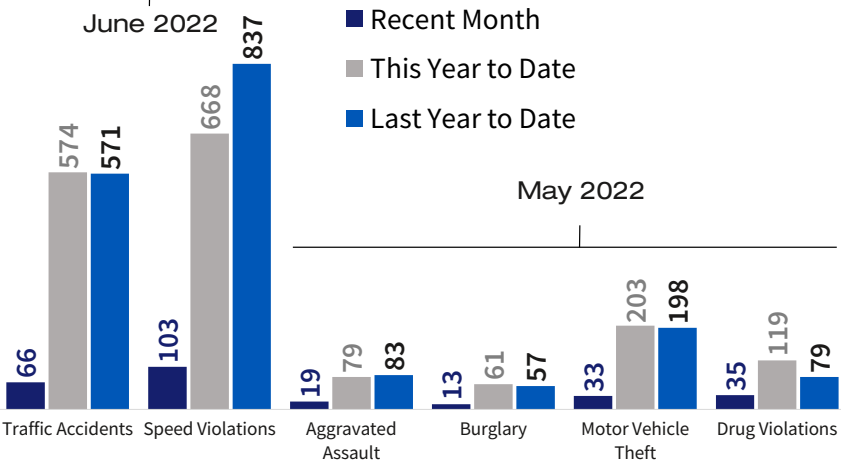

# Caring and Accountability

## ► City Pursuing Wide Range of Options to Address Homelessness

Both elected officials and city staff frequently receive questions from residents on issues related to people experiencing homelessness (PEH) such as park conditions, the tunnel under I-25, and loitering near businesses.

Since this is a frequent inquiry, we decided to combine our columns this month and give an update on several city efforts. Remember, homelessness is a complex issue that cannot be solved overnight.

Our city is working on wholistic solutions that are in-line with our community values and Strategic Plan. Some are a “warm hand” and others focus on accountability. The goal is to address underlying causes for lasting results. We believe a balanced approach of providing resources to PEH and enforcing laws will positively impact the quality of life for the entire community.

### Who Are Our Homeless?

Similar to other cities, there’s not one type of PEH in Northglenn. Some find short-term stays with friends and family. Others move into their vehicle. Some find refuge in the school system – an estimated 160 students in Northglenn currently experience homelessness. The most visible have nowhere to go. The number of PEH without any kind of shelter in Northglenn is estimated at 40 to 55. ► *More information on numbers can be found at [www.mdhi.org/pit](http://www.mdhi.org/pit).*

### Regional Collaboration

City Council approved a Regional Memorandum (MOU) in April between Northglenn, Adams County, and a number of neighboring communities. The key components of the three-year renewable agreement include:

- Adams County will lead in coordinating efforts, including convening meetings with elected officials and leadership in each municipality.

- Meetings with representatives from each of the municipalities are underway, and some new programs are in development.
- A central information hub has been created so the root causes of homelessness can be analyzed for opportunities and possible solutions. This allows for collaboration and combining of resources.

### Crisis Response Unit (CRU)

CRU focuses on helping individuals overcome barriers to establish food security, shelter, income, mental health support, employment and more. This year-old program has five members who work in the following areas:

- Co-responding to calls with police when residents need support and also following up with families who may need resources.
- Coordinating and advocating for services for residents and PEH in need (housing, food, lost documents, mental health). Over the past year, the CRU assisted more than 25 PEH to find permanent or transitional housing.
- Providing case management for participants in the Winter Housing Program (see below).

### Enforcement

Efforts to control nuisances often associated with PEH include enforcement of ordinances. Some key enforcement includes:

- No camping on public property (persons are asked to leave and/or given notice about removal of items left in public areas)
- No sitting or lying down in designated areas where there is blocking, obstructing, or interfering with the safe or free passage of a pedestrian or vehicle
- No trespassing (particularly helpful near businesses)
- No loitering on or around school property
- Enforcement of park hours (public parks in the city close at 10 p.m. daily and reopen at 5 a.m.)

### Crime Prevention Through Environmental Design (CPTED)

City staff are assessing what changes in lighting, vegetation, fencing, pathways and other design elements in public areas would help reduce crime and/or undesired behavior. This is not specific to PEH; CPTED addresses the safety of everyone while protecting the public’s investments. Graffiti, prop-

erty damage, loitering, theft, assault, and more can be reduced through CPTED.

### Facility Maintenance

We have received several complaints regarding the restroom conditions at E.B. Rains Jr. Memorial Park. In response, a private contractor currently maintains those facilities four times a day on the weekend in addition to city staff’s efforts during the week.

City staff thoroughly cleans the tunnel underneath Interstate 25 near 120th Avenue at least twice a week, graffiti is regularly removed, and increased patrols ask persons loitering in the area to move along.

### Impact to Businesses

The Economic Development staff holds meetings with tenants and property owners to better understand their concerns while providing strategies that can proactively reduce loitering and crime and offer more security for their business, customers and staff.



*The Winter Housing Program for People Experiencing Homelessness, which was located in the old recreation center, ends Aug. 31. The facility will be razed in the near future.*

### Winter Housing Program

The old rec center was used as a temporary winter shelter for 25 participants a night last year. Its success, defined by persons who secured reliable housing elsewhere and the number of unsheltered nights avoided, led to an extension beyond winter. This program ends Aug. 31 and the building will soon be demolished. We are pleased utilizing this empty building helped and are hopeful it will encourage neighboring municipalities to work together to establish a similar, permanent program in another location.

On Aug. 22, staff will bring forward several discussion items for council consideration on the next steps to address these ongoing challenges. We are always open to input on these issues, and especially appreciate hearing ideas for solutions.
