- The 2022 Residential Streets
 Program is scheduled to be done in October. When finished, about 9 miles of roads will be re-paved. The remaining work includes stretches of West 118th Avenue, Galapago Court, Melody Drive, Elati Court, and Delaware Court.
- The Huron Waterline project is just over 35% done. One mile of waterline is being replaced under-

neath Huron Street from 104th Avenue to the south city limit.

This work requires that Huron Street traffic is limited to one lane in each direction and occasionally side streets connecting to Huron are closed off. The project is planned to be done in spring 2023.

 In late August, one of the city's street sweepers was hit by a drunk driver. Thankfully no one was hurt, but the sweeper is totaled (see photo to the right).

Unfortunately, this leaves only one street sweeper left and to ensure it is available and operational (as required by EPA and other standards), **the city will not conduct**



the usual fall street sweeping of every street.

Instead, it will occur on an as-needed priority basis until the second unit is received and put in service.



• Only one load per household is allowed.

- All loads must be covered.
- Proof of residency such as a driver's license or a current utility bill with picture ID is required.
- Mattresses and box springs cost \$35 each to drop off.
- Appliances with or without Freon are now accepted free of charge and will be recycled.
- People bringing a pickup truck or trailer face a gate charge plus taxes and fees if they have more than five cubic yards of materials.
- A safety vest will be provided at the entrance and must be worn when unloading.




July 2022 General Fund Financial Report

Unaudited figures are through the end of July. General Fund Expenditures Year to Date





City Manager's Column: A Letter from Heather Geyer

In The Heart of Budget Season

Focus on Assisting Residents While Being Fiscally Conservative



The city manager is responsible for presenting a balanced budget and budget message to City Council each year. This collaborative, lengthy and detailed process is vital to high-performance government. What does our city need? What can our city afford? How do our decisions today affect city

finances in years to come? What investments can we make that move us towards our future vision of Northglenn?

All the input we receive from residents and businesses through public meetings, surveys, emails and calls influence these decisions. Balancing what our community has expressed as a need with responsible fiscal management can be a challenge ... and sometimes leads to robust discussions about our priorities.

proposals are prioritized by both staff and City

Council. Revenue and expense projections determine what funding remains for new city endeavors. We lean towards a conservative approach - that means we only recommend additions the city can afford in 2023 and subsequent years. Every year we propose a balanced budget.

After several working sessions starting in August, the proposed 2023 Budget was detailed during the Sept. 19 study session. The 2023 General Fund proposed budget is \$35,251,174 (2022 was \$44,186,936). The 2023 proposed Capital Projects Fund budget is \$55,603,702 (2022 was \$56,868,813). > Learn more about the budget in the story below.

If the proposed budget passes, we will break ground on a new city hall, make water and wastewater infra-Staff begins work on budget proposals in June, then structure investments, repair/replace playgrounds, continue the residential street overlay program,

\$125.8M Budget Proposed for 2023

The proposed 2023 City Budget was presented to City Council on Sept. 19. It is built on a strategic framework to meet the desired level of services by the community, invest in city infrastructure and build financial sustainability for the future.

The proposed 2023 Budget does not anticipate any new tax increase. The chart to the right shows projected revenue for the eight funds that comprise the budget.

Overall, citywide revenues for the proposed 2023 Budget stands at \$81 million with citywide expenditures at \$125.8 million, of which \$58 million are for one-time capital projects coming from reserves. The personnel budget expects a 13.3% increase. The General Fund, which includes salaries and day-to-day operations, is balanced.






