

Opening in Ward 3 on Council; Apply April 4 Through 22

At the City Council meeting on Feb. 28, Council Member Julie Duran Mullica announced she will be moving out of the city and resigning her position on council effective April 21.

This will create a vacancy in Ward 3 that must be filled by appointment by City Council no later than May 21. Anyone who lives in Ward 3 and is interested in applying for the vacancy may do so by submitting an application to the City

- April 4 to 22, 2022: Application period. Anyone interested must apply by 4:30 p.m. April 22.
- May 2 (Study Session): Council interviews applicants for the vacant council position. Interviews will be conducted during a public meeting and broadcast on Channel 8 and the city's YouTube channel.
- May 9 (Regular Meeting): Council will appoint a new member to fill the Ward 3 vacancy. The council member will serve until the regularly scheduled general municipal election in November 2023.

#### **Adams County**

Adams County and the cities of Northglenn and Westminster announced a regional collaboration with the nonprofit Solar United Neighbors to launch the Adams County Solar Co-op to help area residents go solar to support local climate and energy goals.

The solar co-op is free to join and is open to homeowners and business owners in Northglenn, unincorporated Adams County and Westminster.

Together, co-op members will learn about solar energy and leverage their numbers to purchase individual solar systems at a discounted group price. Joining the co-op does not obligate members to purchase solar. Instead,



members will have the option to individually purchase panels, electric vehicle chargers, and battery storage based on the installer's group rate.

"Northglenn is so excited to be a part of the Adams County Solar Co-op," said Mayor Meredith Leighty. "Sustainability is a key element in our strategic plan, and this will offer our residents another opportunity to reduce our carbon footprint."

• What Achievement, Action, or Work Were You Most Proud of During Your Tenure on Council? I'm proud of the regional relationships I created while serving on the city's

transportation committees. I took several leadership positions and made sure that Northglenn was always at the table, even if I had to elbow my way in. I'm also proud of the creation of the Diversity, Inclusivity, and Social Equity (DISE) Board. That was a top priority for me and I'm happy to see the board members actively participate in our community.

- What Was the Most Important Thing You Learned During Your Time on Council? I learned how lucky we are to have so many people be invested in our community. We have amazing staff members, police officers, business owners, volunteers, council members (former and current), and average citizens who give tirelessly to make our city better every day. Once you add up all of these people, it's easy to see why Northglenn is so exceptional.
- What Do You Feel Are The Biggest Issues That Northglenn Faces Right Now? Moving forward, our city needs to continue to focus on infrastructure investments and dedicate our focus to improving our public spaces. • So Far, What Achievement, Action or Work Are You Most Proud of During Your Tenure on Council? The creation of the Diversity, Inclusivity, and Social Equity Board and its work so far. This board has sponsored events, presented educational opportunities, and worked to help make Northglenn a safe and welcoming place for all residents. I am

also proud of the work I have done to help bring the new recreation center to the finish line. Before I was elected to council, I worked as a volunteer on the advisory panel to help envision this new building.

- What is the Most Important Thing You Have Learned During Your Time on Council? How hard the city staff works to make Northglenn such a wonderful place to live. From the streets and trails to events to services such as passports, the dedication of the staff continues to impress me. I have also learned just how compassionate and thoughtful the residents of Northglenn are. The positive response and support of the Winter Housing Program for our homeless residents have been amazing!

# **Success Through Collaboration**

When you think about City Council, most of us focus on "local." That makes sense since we are looking at issues, setting priorities and allocating funding to benefit Northglenn residents. However, a significant portion of council's behindthe-scenes work is regional, and sometimes national.

Several of us recently attended the National League of Cities conference in Washington, D.C. The opportunity to hear about other cities' innovative programs and how they are handling challenges similar to ours is always worthwhile. We also made sure to meet



with our federal-level elected officials from Colorado to discuss issues at the Capitol that affect us at home. With Northglenn passing the 50-year mark, much of our focus this year was infrastructure funding. Each council member and I serve on boards or participate on committees to ensure Northglenn's interests are represented in a variety of arenas. Some are our local boards and commissions. others involve north metro area transportation, environment, public safety, and education efforts. A few are regional and statewide, such as the Metro Mayor's Caucus, Denver Regional Council of Governments, and Colorado Municipal League.

Between the nine members of council, we participate in over 40 different groups to make sure Northglenn's voice is heard and to ensure we get our fair share, establish partnerships, and hear about opportunities.

The relationships are key to our success. We leverage county, state and federal dollars to take on big water, sewer, and road needs. We team up for projects such as the Adams County Solar Co-op (see cover). We collaborate to support those experiencing homelessness. And those are just a few! By working with our partners, Northglenn achieves more.

## City Manager's Column: A Letter from Heather Geyer

# **City Addressing Public Safety Concerns**



Recently, City Council expressed a need to directly respond to resident concerns about crime in Northglenn.

In response, this spring Chief Jim

May and Deputy Chief Randall Darlin are speaking openly to residents about public safety in our community.

The Police Department has already presented at meetings for Ward 3 and Ward 4, with Ward 1, Ward 2 (see Page 3) and Mingle with the Mayor (see above) meetings in April. I encourage you to attend one of these, or watch a video of the presentation at *www. northglenn.org/safetypresentation.* The chiefs do an excellent job of explaining the reality of our crime rates, a few of

the "whys" behind the trends, what our city is doing in response, and how you can support our public safety efforts.

Is crime up? The short answer: yes. Like the rest of the metro area, state and many places in the nation, we are experiencing more crime. Specifically, we are tracking an increase in property and firearms crimes. Despite what you may hear on the news or social media, drug offenses have decreased and crimes involving violence have only slightly increased.

Why is crime up? There are a variety of reasons – the economy, fewer persons held in jail, changes in state laws, and COVID to name a few.

What are we doing? Numerous things. Thanks to support from City Council, we have increased the number of patrol officers. In addition, we've added different types of responses such as the Crisis Response Unit, made body-worn and vehicle cameras standard through the department, are moving towards wholistic efforts like data-driven policing and Crime Prevention Through Environmental Design (CPTED), and are engaging the community more.

What can you do? Learn the facts.

Listen to and practice police safety suggestions like locking your car and not leaving valuables in plain sight. Call the police if you witness crimes or suspicious activity.

I know many of you are asking, "Am I safe? Is my neighborhood safe?" Yes, but that doesn't mean you or I will never be a victim of a crime. Please remember, we know that most serious crimes are between parties that are known to each other. Most of us are law-abiding people that care about our community. Again, I highly recommend you take advantage of one of our police community outreach efforts or watch online. Get your facts from the source and learn how you can discourage crime, avoid being a victim and support public safety.

# Start By Believing



#### CAMPAIGN

The global campaign began in 2011 by End Violence Against Women International. Many victims of sexual assault never talk about or report the crime, and when they do, the victims face doubt and blame, rather than compassion and support. This often prevents the victim from seeking help through the justice system.



# **INFRASTRUCTURE & SUSTAINABILITY**



A quick roundup of roadwork activities in your city.

#### Force Main A

Force Main A, a new major sewer line, has been completely installed. The new pipe runs through the east side of Northglenn, from Lift Station A, near East 105th Place and Irma Drive, to the Maintenance & **Operations Facility.** 

Crews are working on restoring sections of Irma Drive and Leroy Drive. After this, the only work left is to connect the pipe to the line that leads to the Wastewater Treatment Plant in Weld County, and to turn on the soon-to-becompleted Lift Station A. Both of these are scheduled to occur in late spring/early summer.

#### Traffic Signals Upgrade

Staff is installing new controllers, radios, and cameras to upgrade all traffic signals. The first upgrades will go in at:

8

- 104th Avenue, from Irma Drive to Ura Lane
- Huron Street & Kennedy Drive
- 117th Avenue & Washington Street
- Irma Drive and 120th Avenue
- Claude Court and 120th Avenue

Next up are Washington Street from 104th Avenue to Sylvia Drive, then Huron Street from 104th Avenue to 116th Avenue. The remaining signals will be upgraded based on need and traffic volumes.

#### Sanitary Sewer Rehabilitation

The sewer rehabilitation project will line approximately 7,000 feet of sanitary sewer pipeline this year. The work began in mid-March.

# Northglenn High **School Students Win** State STEM Contest

#### **Adams 12 Five Star Schools**

A team of students at Northglenn High School won the state competition for the 2022 Samsung Solve for Tomorrow Contest, banking the school \$6,500 to be redeemed on DonorsChoose.com.

Samsung Solve for Tomorrow is a program that encourages students to solve real-world issues in their communities using STEM. The Northglenn team is working to create a solution to prevent the extinction of the boreal toad species. Boreal toads are endangered in large part because of a deadly bacterial disease called the chytrid fungus.

The team has created a 3D printed, waterproof and easily accessible the team developed an app called GeoToad to collect and help analyze the data. The device and app will help create citizen scientists to collect data to help Colorado Parks and Wildlife with Boreal toad conservation.

"These students have spent a tremendous amount of time and energy to see their solution to the problem on the national level," said Todd Corn, STEM coordinator. "It is always exciting to work with motivated and thoughtful students who want to make the world a better place."
