2023 GENERAL ELECTION

Seven Council Spots on Ballot

Northglenn voters will elect a mayor and six council members at the Nov. 7, 2023 regular municipal election.

One council member will be elected in Ward 1 and Ward 2, and two council members will be elected in Ward 3 and Ward 4.

The mayor and one council member from each of the four wards will serve four-year terms. Two of the positions

in Wards 3 and 4 will serve two-year terms due to the previous vacancies created by the resignations of council members Julie Duran Mullica and Jenny Willford.

Candidates in Wards 3 and 4 must decide whether they want to run for the two-year terms or four-year terms when they pick up nomination petitions from the City Clerk's Office; they cannot be a candidate for both positions. The shortened two-year periods are necessary to keep the terms on City Council staggered.

City Evaluating Washington Point



Leighty

The current condition of the Washington Point shopping center is a topic that often comes up in my conversations with residents. The center is located near 120th Avenue and Washington Street, where Safeway and the ARC Thrift Store are located. Concerns of loitering, misuse of shopping carts, storefront vacancies, and personal safety are the comments that are heard most.

The city is actively communicating with the property owners within the

center to address concerns. There is not a simple fix as there are multiple property owners and the number of people experiencing homelessness has increased across the metro area. There are specific actions the city and some property owners have taken, which include:

- Police patrol more frequently.
- Outside outlets have been turned off to discourage loitering.
- Lighting has been increased.
- Neighborhood Services visits often to ensure businesses follow city codes.
- Shopping carts are returned frequently.

- The Crisis Response Unit regularly visits the area and speaks with persons experiencing homelessness and others in the area that need assistance.
- Our economic development director is evaluating strategies to facilitate improvements to the shopping area.

If you witness issues at the Washington Point shopping center, I encourage you to take action as well. If you see a crime in progress, injured person or dangerous situation, call 911. If you see suspicious behavior or people in need, call the Police non-emergency number, 303.288.1535. If you have







May 2023 General Fund Financial Report



City Manager's Column: A Letter from Heather Geyer

Looking Ahead ▶ City Beginning 2024 Budget Talks



Geyer

Our City Charter stipulates an annual budget for the next year be approved by City Council by Dec. 31 every year. Budget work starts in May for staff and is initially presented to council in August to enable them the time to make decisions and confirm strategic goal alignment of our spending. We work hard to conduct the budget process as transparently as possible.

One of the first steps in the budget process is looking at projected revenues and next at organizational

priorities that are influenced by the Strategic Plan, resident input, council concerns, regulatory requirements and laws. Public safety, infrastructure, and parks are the areas that typically receive the most budgetary discussion.

Many funding sources are designated for specific purposes like capital improvement projects, grant projects, and water investments. For these funds, going through the list of needs and prioritizing them is the key task.

The city's General Fund has the most flexibility. It does not increase dramatically from year-to-year, yet this is often where the bulk of the

budget conversation takes place. The questions staff and council wrestle with are:

- With the limited resources we have, what is most important to fund next year?
- Is this a one-time expense or an ongoing expense?
- If it's ongoing, can we afford it in future years?
- How does the expense improve our level of service to Northglenn residents and businesses?
- Does the proposed expense address a community concern?

On Aug. 7, staff will take their

proposals to council for them to discuss and decide what should be in the 2024 Budget and what will have to wait.

2023 GENERAL ELECTION

Council Considering Two Questions for Ballot

City Council is considering placing two local issues on the ballot this fall:

Tax Extension

Should an existing 1/2% sales and use tax be extended?

This sales tax was originally approved by voters in 2001, then extended twice by voters, and is currently still in place through 2025. Anyone who makes a purchase in Northglenn pays the sales tax (resident or not); for example, any purchase of \$100 is taxed 50 cents.

The sales tax generates about \$3.5 million each year and has been used to purchase water rights, which helps ensure a stable water supply for our residents and businesses.

Council is considering asking voters to

broaden the use of funds for investments in roads, public safety, parks and other general uses.

Charter Language Update

May the city update language in the City Charter?

The city's Home Rule Charter was adopted in 1975. The City Charter details the structure and powers of the

city's government, and amendments must be approved by the city's voters.

Council is considering placing a question on the ballot asking voters to update the language in the charter. Specifically, the changes would be to use titles throughout the document to improve accuracy and clarity. Below is an example of typical language in the document and possible updates.

Council discussed the possibility of the ballot items on June 5 and will discuss the matter further in August to make a final decision on which, if any, issues will go on the ballot for voters to decide.

Section 6.10 – Police Department

The Police Department shall be supervised by a Director, who may also be known as the Chief of Police. Except as otherwise provided in this Charter, **he** shall, in times of public danger or emergency, have exclusive power to deputize, appoint, and administer the oath of office to any necessary and additional **policemen, patrolmen or firemen**, as the nature of the emergency may require during the period of such public danger or emergency.

The Chief of Police may create or abolish, from time to time, such bureaus and divisions within the Department as **he** shall deem necessary and proper to the proper organization of the Department.

The Police Department shall be supervised by a Director, who may also be known as the Chief of Police. Except as otherwise provided in this Charter, **the Chief of Police** shall, in times of public danger or emergency, have exclusive power to deputize, appoint, and administer the oath of office to any necessary and additional **police officers, patrol officers or firefighters**, as the nature of the emergency may require during the period of such public danger or emergency.

The Chief of Police may create or abolish, from time to time, such bureaus and divisions within the Department as **the Chief of Police** shall deem necessary and proper to the proper organization of the Department.

WHO IS ELIGIBLE?

Candidates must:

- Be a U.S. citizen and registered voter
- Be a resident of the City of Northglenn for at least one year immediately preceding the election
- Be a resident of their ward for at least 32 days immediately preceding nomination for council member positions
- Have no felony convictions

GET ON THE BALLOT

- Each candidate must be nominated by petition.
- The petitioning process takes place in August.
- Only petitions obtained from the City Clerk's Office may be circulated for signatures.
- Petitions must be signed by at least 25 registered voters residing within the candidate's ward for council member positions or by at least 25 registered voters residing within the city at-large for mayoral candidates.

KEY DATES

- **Aug. 7** – Nomination petitions will be available in the City Clerk's Office.
- **Aug. 8** – First day a nomination petition may be circulated for signatures
- **Aug. 28** – Deadline to file signed nomination petitions with the City Clerk. Petitions must be received by 4:30 p.m.

Groundwork Underway for New City Hall Facility

Construction is progressing on the new City Hall! In July the project saw the installation of two 10,000-gallon and one 5,000-gallon underground water tanks that will capture rain and snow run-off for irrigation of the landscaping material on the site once it is planted.

Also, the foundation area for the building has been graded and the foundation caissons have been poured. There are 144 total caissons being drilled at a depth between 20 and 30 feet in order to anchor to the underlying bedrock for structural support. The foundation slab will be tied to those caissons.

When it opens in the fall of 2024, this

32,600-square-foot facility will be Net Zero and have a CORE Green Building rating – the first municipal building in Colorado to achieve that certification. The \$33.8M building is being funded completely through reserves and is located next to the current City Hall.

Parking

The south entrance to the Civic Center will be closed for the duration of construction. To reach City Hall, the Parsons Theatre or Northglenn Senior Center, go up Memorial Parkway and make a left at the front entrance of the rec center.

ADAMS COUNTY OPEN SPACE GRANTS

\$575K For City Parks Projects

Adams County

On June 27, the Adams County Board of Commissioners awarded \$575,000 to Northglenn for three parks and recreation projects. Overall, more than \$9 million was awarded to 21 projects throughout the county. Funding came from the Adams County Open Space Sales Tax, which was passed by county voters in 1999, and in perpetuity in 2020.

Grants for Northglenn include:

Fox Run Playground Project

This includes a complete renovation of playgrounds at North Park, Central Park and South Park in the Fox Run subdivision. Aging equipment will be replaced with thematic, engaging new play structures and enhanced ADA-accessible, poured-in-place safety surfacing.

• Grant Award: \$250,000

Aquatic Adventure Project


NinjaCross is a retractable system that adds a whole new fun fitness element to the lap pool. It is mounted directly to the roof and lowered into position for use. The course is creatively designed with interchangeable obstacles that are fully customizable. With more than 20 obstacles placed above, below, and on the water, the courses create three-dimensional challenges for swimmers and aquatics exercisers of all ages and at any fitness level. It is scheduled to be installed in August 2024.

• Grant Award: \$300,000

Trail Map and Signage Stewardship Project

The Trail Signage and Stewardship Project will improve utilization of the trail system by providing accurate maps, informative trail signage, and increased engagement with park rangers. Funding is needed to improve the design of the trail map, print pocket trail maps for the community, and design and install trailway finding signage at key areas around the city. This will be paired with improved patrol of the trail system by the city's park ranger staff with two additional electric bicycles, safety equipment, and park ranger program materials.

• Grant Award: \$25,000



A quick roundup of roadwork activities in your city.

• **2023 Residential Streets:** Paving is complete; there is still a line item for crack sealing left to do and it will be completed later this year.

• **Huron Waterline:** Paving is now complete; only striping remains.

• **120th Avenue Improvements Project:** Work – both obvious and hidden to the public – continues.

- The storm drain is nearly complete for the entire project.
- Underground work is in place for traffic signals at Irma Drive, Race Street and Claude Court. Signal

poles, mast arms and cabinets will be installed as soon as they arrive, starting with Race Street.

- On the north side, sidewalk and ADA curb ramps are in place, so crews will soon turn their attention to landscaping. Also, streetlights should start going up early this month on that side.
- And most obvious to the public, paving, sidewalk and curb instal-

lation continues on the south side.

When finished, East 120th Avenue will be widened from two lanes to three in each direction from Sylvia Drive, just east of Washington Street, to the N Line overpass. This will eliminate a bottleneck over that stretch.




IN A GREAT STATE OF THE CITY



The program offers homeowners and small businesses a convenient way to learn about and install rooftop solar panels and battery storage. Solar Switch leverages the power of group buying, and the expertise of nonprofit SUN, to ensure participants get a quality system at a discounted price. Solar Switch vets qualified installers to compete for the group and runs a reverse auction to secure a competitively priced solar package.

“Northglenn has prioritized sustainability efforts, and this program supports our goal of reducing our carbon footprint. Helping our residents and businesses learn about the benefits of solar and access to affordable options is an excellent way to move our community toward clean energy sources,” said Council Member Katherine Goff and Colorado Communities for Climate Action president. “There is power in joining with our neighbors! It adds leverage we can use to attract more people to install solar panels, and that means cleaner air in our

community and world.”

With the dropping cost of solar panels, new federal clean energy incentives, and the Solar Switch group discount, going solar is more accessible than ever. Thanks to the Inflation Reduction Act (IRA), participants may be able to use the solar tax credit for residential solar and save 30% on their total system cost. A similar tax credit is also available to small businesses, who are invited to take part in the program.

Residents can register for the program through Oct. 4. Registration is free, and there is no obligation for homeowners to purchase solar panels. Residents will have the option to move forward with a solar installation based on program-negotiated pricing that includes the group discount. Solar Switch's auction is expected to save residents an average of \$5,000 on a standard-sized system in addition to the available solar tax credit for residential installations.

PREVIOUS SUCCESS

Last year, Adams County, Northglenn, and Westminster partnered with SUN to provide the first countywide solar co-op program. The program exceeded its goals with 202 members and 39 rooftop installations that will reduce greenhouse gas emissions from electric generation by more than 5,600 metric tons CO₂e over 25 years. Those members saved anywhere from 8 to 25% off statewide average costs for solar installations – saving a total of more than \$1.3 million across the co-op over 25 years. ▶ *Visit <https://bit.ly/3pXxHs7> to learn more about the results and impacts of the 2022 Adams County Solar Co-Op.*


