FAST FACTS

There were a total of 348 hearings held in Court in June 2023.

213 hearings were held in-person, a 61% attendance success rate.

135 defendants did not appear for Court.

There were a total of 51 Stay of Execution cases pending with the Court for failure to pay.

Defendants made their payment.

31

Defendants had an extension granted.

The Top-3 most common citations in Municipal Court for June were Speeding 10-19 over (101), Careless Driving (49), and Trespassing (25).

In June, there were 642 text messages sent out by the Court. Only 87 text messages failed, creating an 87.5% successful delivery rate.

There were 17 victim impact statements sent out during the month, with 0 being returned successfully. There were 5 restitution hearings in total held.



CUSTOMER SERVICE SURVEY

In April 2022, the Municipal Court created a 12-question customer service survey in limited distribution. Starting in March 2023, the Court began sending post-court text notifications referencing the survey. The responses have increased recently. To date, there have been 45 responses in total. Here are some highlights from the results:

79% of respondents said when they first received their ticket, they understood what they needed to do.

66% of respondents said the Municipal Court reminder gave them the information needed to prepare for Court.

68% of respondents felt the Court Clerks paid attention to the defendant's needs, treated them fairly, and was courteous.

80% of respondents were clear on their rights as a defendant when attending Court.

87% of respondents felt when appearing before the Judge, they felt understood, could tell their side of the story, and everything was explained clearly

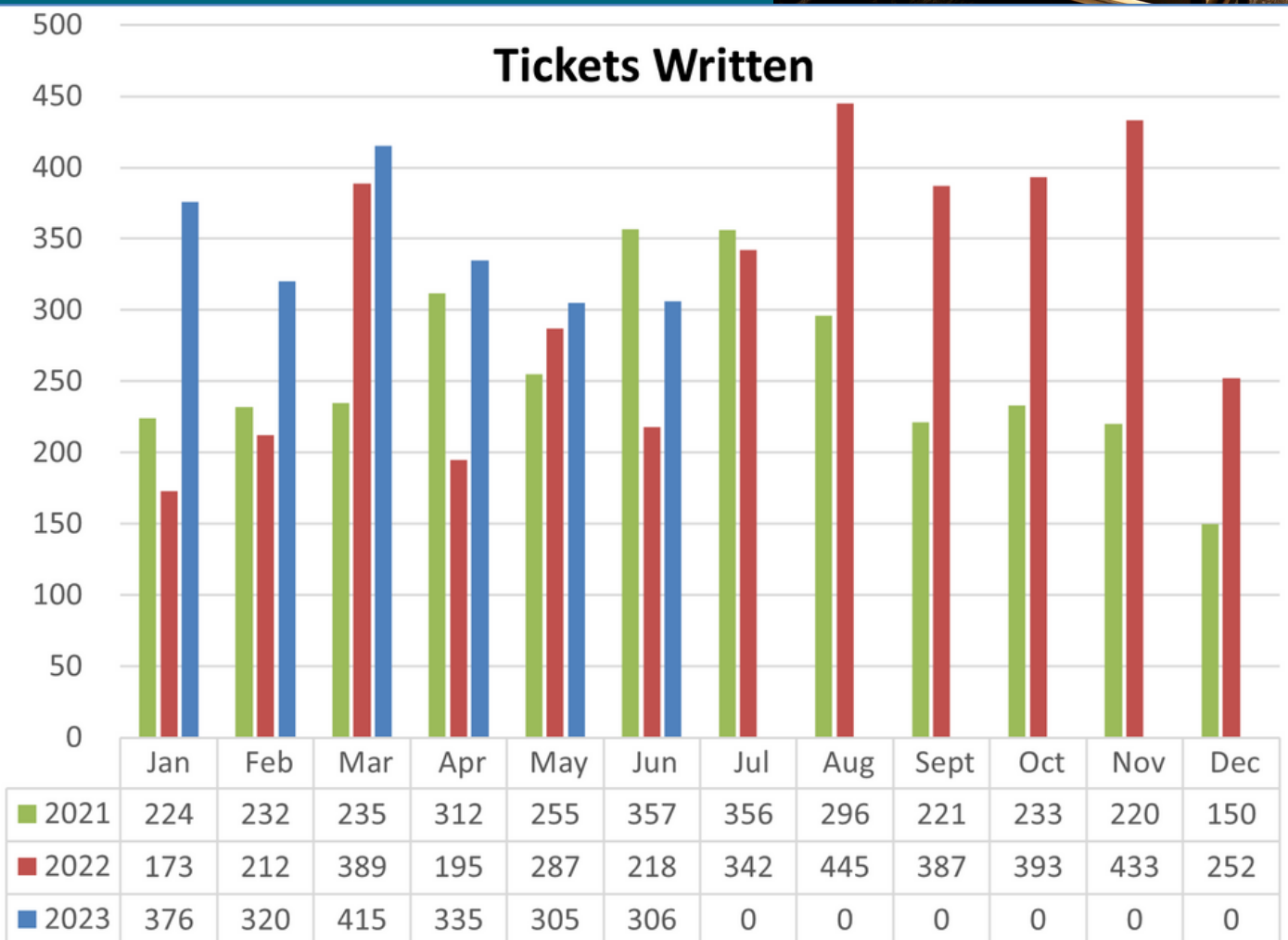
