# FAST FACTS

There were a total of 370 hearings scheduled in Court in March 2023.

271 hearings were held either virtually or in-person, a 73% attendance success rate.

99 defendants did not appear for Court.

There were a total of 81 Stay of Execution cases pending with the Court for failure to pay. The Top-3 most common citations in Municipal Court for March were Speeding 10-19 over (153), Speeding 20-29 over (33), Careless Driving (33), and Failed to Stop at Stop Sign (29).


