



State of the City On the Move in '15



2015 was an exciting year for the city of Northglenn. We experienced new growth as businesses moved in, and current businesses continued to thrive. There's a lot to be proud of in our city.



2015 was an election year. We said farewell to outgoing City Council members Wayne Dodge, Ward 1; Leslie Carrico, Ward 2; and Gene Wieneke, Ward 4. In their place we have some new faces – Jordan Sauers, Ward 1; Becky Brown, Ward 2; and Antonio B. Esquibel, Ward 4. Marci Whitman from Ward 3 was re-elected. We thank the outgoing council members for their service to the city and look forward to what the next four years will bring.



Ground broke on the new SCL Health Community Hospital in July.

Northglenn continues to focus on economic development. Northglenn has its first hospital! In July, SCL Health broke ground on a full service hospital and medical office facility on Community Center Drive. The restaurants and businesses at Webster Lake Promenade are thriving, business is even better than anticipated, and the 4th Annual Business Appreciation Breakfast was a great success.



Work continues on the multi-million dollar improvements on the Wastewater

Treatment Plant, road work is nearly done on 112th Avenue and a new combined police station/municipal court is being considered for the area near the water towers on Community Center Drive and Huron Street. Northglenn continues to grow and improve what we have.



Planning for the city's future, a Civic Center Master Plan is being developed to help us make the best decisions for land use on Community Center Drive. Also, RTD's Commuter Rail will launch in Northglenn in 2018, but we are preparing now. Planning is underway for the station and the area around the station to be built at 112th Avenue and York Street. A public forum was held in November to gain public input, and that information is shaping the planning process.



Residents continue to support city events. Family-friendly and community-oriented, the 4th of July Family Festival, Kids Fishing Derby, the brand new Pirate Fest, Safe Street Halloween and Noel Northglenn all drew large crowds from the city and beyond. The city also participated in Colorado Cities and Towns Week, a statewide event, with tours of the Water Treatment Plant and a BBQ. After a well-received opening in 2014, the city held an expanded Summer Movie Series in August.



Thousands embarked on Northglenn for the inaugural Pirate Fest. The second voyage is in September.

The recreation center saw improvements in 2015 with remodeled locker rooms and bathrooms, along with a renovated pool. Also, over \$600,000 in grants were received to restore and improve our parks and recreation facilities.



Northglenn continues to grow and change. The city has gone green by purchasing solar power. This step will save the city nearly \$600,000 over the next 20 years. Northglenn and CDOT have made improvements on the Northglenn section of I-25, adding an express lane and building new sound walls.

Ordinances: 2nd Reading

Amendment for Industrial Pretreatment Regulations

CB-1858 – In a unanimous vote, council approved amending certain sections of Chapter 16, Article 15, of the Municipal Code, regarding industrial pretreatment regulations for public sewers. The purpose is to control industrial pollutants that could cause interference with the wastewater treatment process.

Ordinances: 1st Reading

Zoning Amendment OK'd

CB-1860 – Council unanimously approved an amendment to the existing Planned Unit Development zoning of parcels at 12155 Claude Court. Several reasons for the amendment were cited, including that the proposed development for the site is not inconsistent with the city's master plan.

Regulations Amendment to Minimize Flood Losses

CB-1861 – Council unanimously approved changes to Article 52 of the Northglenn Zoning Ordinance, pertaining to regulations to minimize flood losses. This is based on planning performed by the Urban Drainage and Flood Control District, which includes Adams County.

New Facility for Ralston House Approved

CR-123 – In a unanimous decision, council approved the agreement between the city of Northglenn and cities of Thornton, Westminster, Federal Heights, Brighton, Commerce City and Aurora, the city and county of Broomfield, and Adams County regarding the construction of the Ralston House in Northglenn.

Pair Reappointed to Youth Commission Board

CR-153 & 154 – Council unanimously approved the reappointments of Alexandra Donnici and Savannah Van Duyn to the Northglenn Youth Commission Board of Directors for one year. Both terms expire Nov. 25, 2016.

Two Added to Parks and Recreation Board

CR-155 – In a unanimous decision, council approved the appointment of Avery Anderson as the Ward 2

member of the Parks and Recreation Advisory Board to fill the unexpired term of Brian Swinbank. Anderson's term began Nov. 23, 2015, and expires May 24, 2018.

CR-156 – In a unanimous decision, council approved the appointment of Susan Waldman as the Ward 4 member of the Parks and Recreation Advisory Board to fill the unexpired term of Leonard Avery. Waldman's term began Nov. 23, 2015, and expires May 24, 2016.

\$120K Grant Approved for Northwest Open Space Renovation

CR-157 – Council unanimously approved the acceptance of an Adams County Open Space Grant and approved the grant agreement between the city and the Adams County Board of Commissioners for \$120,000 to be used for the Northwest Open Space Design Project.

\$94K Grant OK'd for Fox Run Renovation Project

CR-158 – In a unanimous decision, council approved the acceptance of an Adams County Open Space Grant and approved the grant agreement between the city and the Adams County Board of Commissioners for \$94,355 to be used for the Fox Run Renovation Project.

\$3,500 Grant OK'd for Honeybee Habitat Project

CR-159 – In a unanimous decision, council approved the acceptance of an Adams County Open Space Grant and approved the grant agreement between the city and the Adams County Board of Commissioners for \$3,500 to be used for the Honeybee Habitat Project.

Standley Lake Pipeline Expenditures Approved

CR-160 – Council unanimously approved the authorization of necessary expenditures to accomplish the annual Capital Improvement Program (CIP) for the Standley Lake Pipeline in the amount of \$159,000. Funds will be transferred from the city's Water and Wastewater Fund to the Standley Lake Joint Operating Escrow Account.





The budgeting process for the city is thoughtfully and carefully planned, with several steps taken before the final Annual Operating and Capital Improvement Budget, totaling \$56 million in 2016, is approved by City Council.






City of Northglenn Nov. 2015 Crime Statistics

Unattended Cars Ripe for Theft

Running Vehicles Left Alone Illegal

In cold weather, many of us have gone out to start the car so it can warm up, then we run back inside.

That's a bad idea.

Every year, a number of these "puffers" (auto thieves' term for vehicles left alone with the motor running), are stolen from metro area driveways.

Other potential consequences include:

- The stolen car could be used in another crime
 - The stolen car could be involved in a traffic accident
 - Criminals could gain access to your home by having your house keys or garage door opener
 - Your insurance rates could rise
 - Criminals would have possession of any important papers in your car
- Also – it's illegal.

Secure the Call Cleans Out Data, Gives Them Away for Emergency Use

Did you receive a cell phone for the holidays? Great! Now, what are you going to do with your old phone?

One option may be to drop it off in the Secure the Call receptacle at the entrance of the Northglenn Police Department.

Secure the Call is a nonprofit organization that provides free cell phones to senior centers, domestic violence shelters and law enforcement agencies

to distribute as needed. Since all cell phones can connect to 911 whether it has service or not, they can be used in case of an emergency.

All private information is removed from the phones before they are given away.

Denver Escape Room isn't just a fun place to go with friends on a weekend; it is also a great teambuilding experience, especially for corporations. Coworkers have to communicate and work together to solve a problem in a specific time-limit. After the game is over, the team works with a corporate trainer to facilitate discussion. As the team debriefs, they talk through their experience relating what they saw in the room back to their workplace.






