Utility Rate Increase for City

Due to Needed Upgrades

The city is as efficient and careful as possible when providing safe and reliable utility services to customers.

Still, the cost of obtaining water and treating it before and after residential and business use continues to increase. A water rate increase is something city staff and council would like to avoid. However, due to the costs of maintaining and improving our water and wastewater treatment systems, a water rate increase is scheduled for the city.

Beginning Jan. 1, 2018, water and sewer rates will go up by 6.7 percent, with a small increase scheduled for each January through 2022. For example, if your monthly water bill for 15,000 gallons is \$100, after Jan. 1, your bill will be \$106.70.

Even with this increase, rates for Northglenn residents are still mid-range compared to other cities in the north metro area.

WHAT'S WASTEWATER?

Water that you use for any purpose, bathing, laundry, or flushing, is wastewater. It leaves your home and travels to the Wastewater Treatment Plant for treatment before it is released back to the earth.

WHY THE INCREASE?

- An increase will help to ensure that the city can continue to provide clean drinking water and dependable wastewater service to Northglenn residents.
- The Wastewater Treatment Plant is currently undergoing work to improve the aging facility; \$32 million will be invested in the plant between 2019-21. This construction is essential if we are to continue to provide the residents of our city with reliable wastewater service.

Assessment for New Rec Center

Focus Now on Program, Budget, Market Analysis

The city has been evaluating the possibility of a new recreation center, senior center and theater.

The process has five steps: 1. front end public input, 2. program/budget/market analysis, 3. operational costs, 4. conceptual design and 5. implementation plan.

The initial public process finished in mid-October. This included informational events at the recreation center and Pirate Fest, a public open house, focus groups and a survey that received over 500 responses. The survey was designed to ask people for feedback and rank potential elements by importance.

The city has also been working with a project advisory group to help guide the assessment. This group is made up of a

variety of community members and current facility users.

This group has outlined the following vision: "Northglenn's new recreation center, senior center and theatre should support and enhance health, wellness, culture and quality of life for all Northglenn residents for generations to come."

Goals were also established with the group to help guide the assessment moving forward. These include:

- Create a multi-generational facility that serves the needs of all user groups.
- Ensure that successful existing programs and activities are supported in the new facility.
- Maintain affordability of facility while ensuring fiscal responsibility and revenue generation.
- Prioritize the needs of Northglenn residents while still ensuring more users are attracted to the facility.
- Remain genuine to Northglenn's past, present and future and continue to celebrate the "small-town feel".

Currently, the assessment is in the program/budget/market analysis step. Using the input received from the community, the committee is evaluating what amenities may be in a new facility.

The project team is working on determining size and location of program elements within the facility, as well as completing a market analysis to better understand potential costs and revenues.

City staff will be bringing draft components of the assessment to City Council for a study session on Dec. 4. A second open house for the public to review the assessment and recommended programs will occur on Feb. 13 at 5 p.m. at the Northglenn Senior Center, 11801 Community Center Drive.

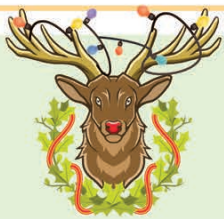

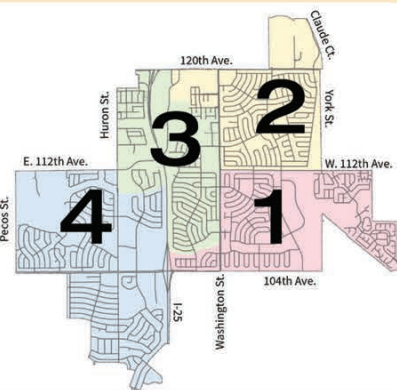

OCT. 23, 2017

Ordinances – 2nd Reading:

Water, Wastewater Rate Increase Approved

CB-1897 – In an 8-1 vote, council approved on second reading water and wastewater rate increases for the city beginning Jan. 1, 2018, and each year through and including Jan. 1, 2022. The rate of increase is 6.7 percent over 2017 for 1,000 gallons. ► *No: Dodge. Yes: Snetzinger, Mullica, Sauers, J. Brown, B. Brown, Downing, Whitman, Esquibel.* ► See cover for more details.

Resolutions:

Mill Levy Set

CR-110 – In a unanimous vote, council approved the mill levy established at 11.597 mills, four mills of which shall be dedicated to rehabilitation and reconstruction of city streets, collectible in 2018 for city purposes.

2018 Budget Approved

CR-111 – Council unanimously approved the 2018 Budget, adopting it as the official budget for fiscal year 2018.

2018 Pay Plan Accepted

CR-112 – In a unanimous vote, council approved the 2018 Pay Plan, which supersedes and replaces all pay plans previously adopted.

Salary Ranges for City Department Heads Set

CR-113 – Council unanimously approved the minimum and maximum salary ranges for city department heads, as referenced in the Home Rule Charter and Municipal Code, effective Dec. 23, 2017.

Delinquent Charges Certified

CR-114, CR-115, and CR-116 – In a unanimous vote, council approved authorizing the city to certify delinquent municipal, nuisance abatement, and water and sewer charges to the Adams County Treasurer to be collected as special assessments with property taxes and then remitted to the city.

Roadway, Traffic Signal Contract Amended

CR-117 – Council unanimously approved an amendment to the Construction Manager Contract with FCI Contractors, Inc., in an amount not to exceed \$368,444.26, for Roadway and Traffic Signal Improvements.

Construction Agreement on Ralston House

CR-118 – In a unanimous vote, council approved the first amendment to the Phase 2 Agreement among the City of Northglenn, Ralston House, the cities of

Initial OK for Additional Fund Appropriations to 2017 Budget

CB-1900 – Council unanimously approved on first reading an increase to the 2017 Budget appropriations by \$1,973,688. Funds are distributed in the following manner: General Fund, \$345,828; Conservation Trust Fund, \$300,000; Capital Projects Fund, \$1,127,860; and Stormwater Fund, \$200,000.

Preliminary OK for Regulation on Wireless Service Facilities

CB-1901 – In a unanimous vote on first reading, council approved the repeal and re-enacting of the Municipal Code Article 55 of Chapter 11 concerning the regulation of wireless service facilities (WSF), specifically building or roof mounted WSF's.

CR-109 – Council unanimously approved the reappointment of Margaret Rebaza as a Ward 1 member to the Citizens' Affairs Board for a five-year term commencing Nov. 8, 2017, and expiring Nov. 8, 2022.

Cunis Named to Northglenn Youth Commission

CR-119 – In a unanimous vote, council approved the appointment of Isabelle Cunis to serve as a member of the Board of Directors of the Northglenn Youth Commission for a one-year term, commencing Nov. 13, 2017, and expiring Nov. 13, 2018.

Abatement Services Contract Approved

CR-120 – Council unanimously approved an on-call abatement services contract to retain a hearing officer to preside over show cause hearings for abatements.

Bank Hired for Treasury Management Services

CR-121 – In a unanimous vote, council approved the agreement with UMB Bank for treasury management services.

Project Resolution Tabled

CR-122 – Council unanimously voted to table CR-122, regarding the Farmers Highline Headgate Replacement Project.

Company Hired for Traffic Signal Improvements

CR-123 – In a unanimous vote, council approved the agreement with W.L. Contractors, Inc., for an amount not to exceed \$101,680, for the 2017 Traffic Signal Improvements Program.

District Working on Strategic Plan

Adams 12 Five Star Schools has launched a year-long engagement process to develop a new five-year strategic plan. Called ELEVATE, the districtwide process will engage parents, community members, students and staff starting this fall and ending with a strategic plan in August 2018. Based on insight and feedback, the plan will feature district strengths, new priorities and outcomes for the next five years.

This fall parents and community members attended ELEVATE community sessions where they shared stories of student success and identified the strengths that made those stories possible. The new strategic plan will look to amplify and build upon those strengths.

Due to high student achievement, the Five Star District has been accredited as a Performance District for the second consecutive year by the State of Colorado. In addition, the percentage of students

meeting and exceeding state expectations increased in six of seven grade levels from 2016 to 2017.

With tremendous student success leading the way, the district has begun to look ahead to ensure students are set up for further achievement and paths to success. Instead of focusing on issues to fix, the district is building on district strengths to elevate student and district success.

By starting with listening sessions in the fall, the ELEVATE process will learn how staff and community feel about the district today and where they want the district to be in five years. In the spring, the process will culminate with a full day session to begin to design our future based on fall feedback. The new plan is expected to be unveiled by August 2018.

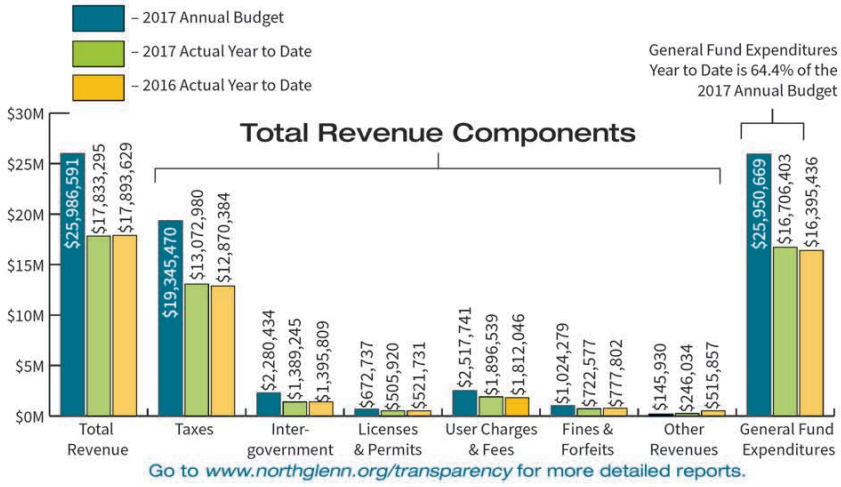

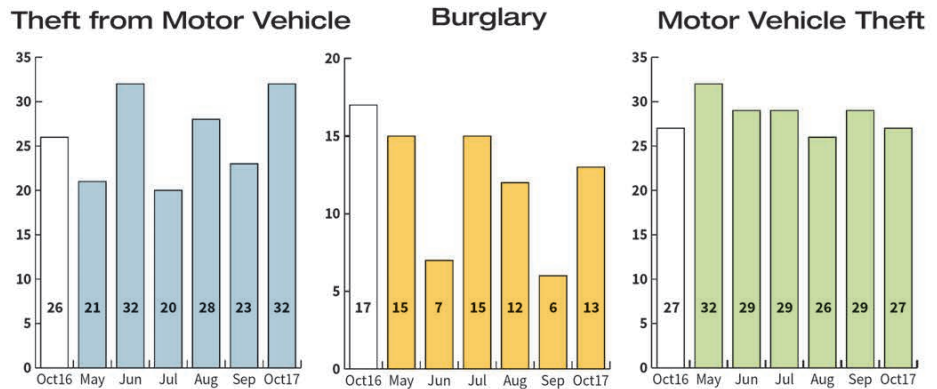

Neighborhood Services Handles Code Enforcement

In Northglenn, Neighborhood Services is code enforcement.

The Neighborhood Services Division handles the enforcement of the city's Municipal Code that relates to health, safety, property maintenance and public nuisances on private property.

This could include litter, graffiti, weeds and more. (See list of top code enforcement violations, right.)

Neighborhood Service Officers drive around neighborhoods or respond to reports of potential violations.

If an officer sees a violation on private property, they will leave a notice on the front door. This notice is simply a warning. It is not a citation, a summons and complaint, and definitely not a fine. The notice only states the issue and how long the property owner has to correct the problem.

(Almost 90 percent of the notices are fixed quickly by residents – thank you Northglenn!)

If you receive a notice and either don't understand the issue or cannot fix the problem in time, please call Neighborhood Services at 303.280.7876. That way, we can work together to find a solution that works for you, the city and the neighborhood.

The goal of Neighborhood Services is to keep our parks, trails, businesses and homes beautiful.

TOP 10 CODE VIOLATIONS

1. Litter on public property
2. Grass taller than 8 inches
3. Illegal vehicles: *All cars parked in view of the public, including the driveway or street, must be generally intact, operable and have current license plates.*
4. Overhanging trees and shrubs: *Overhanging tree branches must be at least 14 feet above the street and 8 feet above a public sidewalk. Also, trees and branches can't block the view of a traffic sign or signal.*
5. Properties that are not substantially weed-free
6. Graffiti
7. Dead or diseased trees and shrubs
8. Snow and ice on sidewalks: *Sidewalks must be cleared of snow and ice 48 hours after the stop of snowfall. If the ice or packed snow cannot be removed without damage, sand or salt must be put down.*
9. Lack of residential landscaping
10. Vehicles not parked on an approved surface such as a full cement or brick pad.

REPORT GRAFFITI IMMEDIATELY

If you see graffiti in Northglenn, call 303.252.3849 IMMEDIATELY! That's whether the graffiti is on public property or not. The sooner graffiti is washed off, the less likely that location will be vandalized again.

WHO TO CALL?

Although you might think of contacting Neighborhood Services for these issues, they're actually handled by someone else:

- **Illegal vehicles parked on the street** (not private property) – Call the police at 303.288.1535

The city has three locations for residents to drop off Christmas trees that have been cleared of tinsel and decorations:

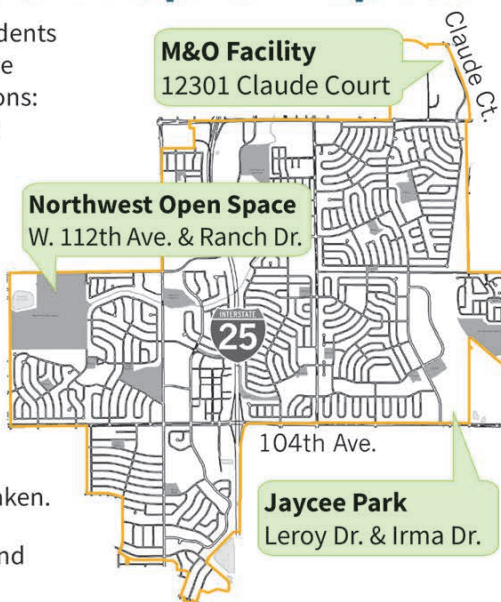
- Maintenance & Operations Facility

NO TRASH PICKUP ON CHRISTMAS OR NEW YEAR'S DAY

The city will NOT pick up trash on Christmas – Monday, Dec. 25, or New Year's Day – Monday, Jan. 1.

If your trash is normally picked up on Monday by the city, it will instead be collected the next day.

Households that normally have Tuesday pickup will still have their garbage and recyclables taken away on

Tuesday. Residents are urged to have their trash and recycling carts out on the curb by 7 a.m. on Tuesday.

The trash schedule for the rest of the week will not be affected.

Snow Removal Priorities for Paths and Sidewalks



When it starts snowing, the city begins clearing the 30 miles of public sidewalks and paths in the Greenway Trail System.

A priority system is in place so the most-used paths, trails and sidewalks are cleared first. These are usually near businesses, government offices, high-density residential areas, schools and school bus pickup areas.

The next priority is paths that are connectors to the city's Greenway Trail System or lead to regional trail systems. The last priority is internal loops in city parks.

The city aims to have all paths cleared 24 hours after the snow has ended, but weather can delay that. Patience with our snow removal efforts is appreciated.

Enterprise Zone Businesses Eligible for Tax Credits

Business owners may be eligible to earn tax credits when purchasing equipment, training employees or providing health insurance. In order to earn these credits, **you must be pre-certified** before you make any qualifying purchases. Log on to www.choosecolorado.com to request the Pre-Certification of Enterprise Zone (EZ) Tax Credits.

You must pre-certify on an annual basis and pre-certification can be done up to three months in advance of your business' tax year start date.
