When Northglenn residents dial 911 their call is sent to the Adams County Communications Center (ADCOM), one of the largest and busiest emergency call centers in Colorado, receiving more than 453,000 calls in 2016.

Of those calls, 37 percent, or approximately 170,000, were for emergencies. The other 63 percent were non-emergency calls including residents seeking

information, reporting a barking dog or loud music, locking their keys in their car or other non-emergent issues.







Water, Water Everywhere ..?

Long Journey for Water to Arrive at Your Home

Water, water everywhere...we've heard that saying, but is it true?

It's not in Colorado! In spite of the recent rain and snow Northglenn is still enforcing the Waste of Water Ordinance, so please water your lawn in the morning or evening, use a shut off nozzle on your hose, and never let water run down the curb and into the storm drain.

But let's back up...where does our water come from?

For Northglenn, it starts with snow melt and rain in the Clear Creek watershed eventually flowing into Standley Lake, where our water is stored.

From there, water flows in a pipeline to the Water Treatment Facility on 112th Avenue, where it is cleaned and purified. Then the clean and great tasting water is ready for you to use for drinking, cooking, showering and laundry, all you need to do is turn on the faucet!

When the water you use goes down the

Safe Lead Levels in Schools

Tests on Water Fixtures

Over the last few months, Adams 12 School District has been sampling water fixtures in all of their schools to test for the presence of lead.

Samples were taken from drinking fountains, food prep sinks, or any other fixture where water could potentially be consumed.

Lead exposure can come from many sources, one of which being older plumbing fixtures. Rest assured, lead has never been found in the city's water source or water that is delivered to residents.

The district completed sampling at all 12 Northglenn schools, totaling over 700 samples. Any fixtures that tested over 15 parts per billion of lead (the Safe Drinking Water Act "action level") were removed or replaced.

DID YOU KNOW?

- The Water Treatment Facility and Wastewater Plant operate 24 hours a day, 365 days a year.
- Average production of the Water Treatment Plant is about 4 million gallons of water per day.
- More than 70,000 tests are done on the water each year to ensure quality.
- The Wastewater Treatment Plant treats over 3 million gallons of water each day.
- About 35 percent of water is for outdoor use, making conservation important.
- It takes 10-12 inches of snow to create 1 inch of water.

Irma Drive Fire Station Construction Continues

If you've driven down Irma Drive lately, you'll notice some big changes to North Metro Fire Station 63.



Mark Young Construction crews began demolition on May 25, taking down the apparatus bay that housed the fire engine and ambulance and clearing out much of the existing interior. In the weeks ahead, construction crews will add on to the current foundation in order to build a larger apparatus bay that can house an additional emergency response vehicle. The firefighters' living quarters will be constructed above the new bay to best utilize the existing lot space.

In order to minimize any impact on response times, the fire engine and its

crew are remaining on site at Station 63 during the entire remodel project. The ambulance and its crew run calls from Station 63 during the day and reside at Station 62 on Huron Street overnight. The remodel project is estimated to be complete in November of this year.
