City Considering Water Rate Increase

Work Needed on Wastewater System

The city is considering a 6.7 percent water and wastewater (sewer) rate increase as part of the 2018 Budget. A rate increase would help ensure that the city can continue to provide clean drinking water and dependable wastewater services to Northglenn residents.

Why do rates increase?

The city is as efficient and careful as possible when providing safe and reliable utility services to customers. However, the cost of obtaining the water and treating it before and after residential and business use continues to increase. Water and wastewater treatment is an extensive process and includes chemicals, parts and repair or replacement projects.

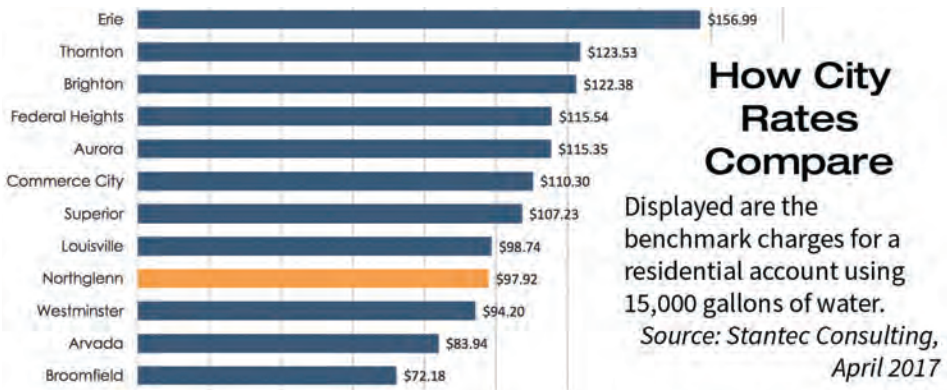
Where does water come from and where does it go?

The city's water supply starts as rain and snowmelt in the mountains and travels

through a series of creeks and waterways to Standley Lake, where it is stored for the city. When we need it, the water then travels to the city's Water Treatment Plant on 112th Avenue, where it is cleaned and made ready for your use. After the water is used for whatever purpose – laundry, bathing, or flushing – it is then called wastewater and it passes through one lift station and several pump stations. It then travels nine miles in a force main to the Northglenn Wastewater Treatment Plant in Weld County, where it is treated before being discharged into Big Dry Creek or Bull Canal for agricultural irrigation. Our city's water starts in the mountains, is treated and made ready for your use, then treated again before returning to the earth, a long journey.

What do rates pay for?

The system uses a combination of electricity, chemicals for treatment and technical

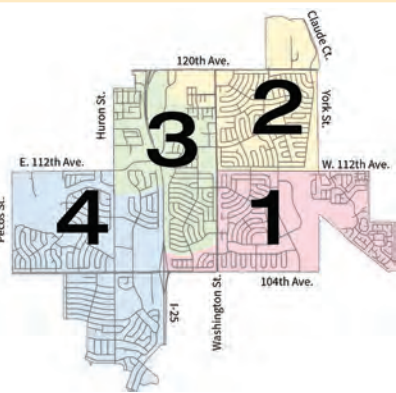

JULY 24, 2017

Ordinances – 1st Reading:

Initial Approval for Marijuana Business Hours Change

CB-1893 – In a 7-1 vote, council initially approved on first reading amending the Municipal Code regarding the hours that marijuana retailers may be open for business. Both retail and medical marijuana businesses could be open no earlier than 8 a.m. and would close no later than 10 p.m. the same day. Both could be open seven days a week. *No: Esquibel. Yes: Snetzinger, Mullica, Sauers, J. Brown, Downing, B. Brown, Whitman.*

Preliminary Approval to Update Electrical Code

CB-1894 – Council unanimously approved on first reading repealing its adoption of the 2011 National Electrical Code, and adopting the 2017 National Electrical Code, sponsored by the National Fire Protection Association, as adopted by the State of Colorado.

Ordinances – 2nd Reading:

Cell Phone Use While Driving Restricted

CB-1892 – Council unanimously approved on second reading to add traffic offenses in keeping with 2017 state legislation prohibiting using a cell phone while driving and texting while driving.

Resolutions:

Weatherly Appointed to Planning Commission

CR-74 – Council unanimously approved the appointment of Bryan Weatherly as a regular member to the Planning Commission. His term started July 24, 2017, and expires June 16, 2020.

Olivieri Named to Liquor Authority

CR-75 – In a unanimous vote, council approved the appointment of Michael Olivieri as a regular member to the Liquor Licensing Authority to fill the unexpired term of Verna Sullivan. His term began July 24, 2017, and will expire Dec. 31, 2017.

Support for Northwest Open Space Grant Application

CR-76 – Council unanimously approved supporting a grant application to be submitted to Adams County Open Space for funding for the Northwest Open Space Improvements Project. The project includes the expansion of parking, the addition of a restroom and concession facility, relocation of the playground, the addition of trees and landscaping and improvements to the trails and irrigation system.

CR-77 – Council unanimously approved an Intergovernmental Agreement with the Colorado Department of Transportation (CDOT) regarding funding in the amount of \$1,033,740 to construct roadway and intersection improvements on 112th Avenue between York Street and Fox Run Parkway.

Contractor Hired for South Huron Landscape Project

CR-78 – In a unanimous vote, council approved the Trade Contractor Agreement with Western States Reclamation, Inc., in an amount not to exceed \$160,008, for the South Huron Street Landscape Project.

Support to Seek Funds from Great Outdoors Colorado

CR-79 – Council unanimously approved the grant application requesting \$350,000 from The Great Outdoors Colorado for Phase 1 of the Northwest Open Space Improvements Project.

Agreement with Counties Over Holding Elections

CR-80 – In a unanimous vote, council approved Intergovernmental Agreements with Adams and Weld counties for the purpose of participating in the Nov. 7 coordinated election.

Fines for Wasting Water Approved

CR-81 – In an 7-1 vote, council approved revising the fee schedule for the Waste of Water Ordinance. Enforcement of the ordinance will help prevent the waste of water from excessive watering in the city. *No: Snetzinger. Yes: Mullica, Sauers, J. Brown, Downing, B. Brown, Whitman, Esquibel.*

CR-83 – In a unanimous vote, council approved providing the city's private activity bond allocation to the Colorado Housing and Finance Authority for the purpose of financing qualified residential rental properties for low and moderate income persons and families.

City Receives Grant From Tri-County Health

CR-84 – Council unanimously approved acceptance of a grant award from the Tri-County Health Department in the amount of \$1,000 for the Worksite Wellness Initiative Program to support employee wellness activities.

Relocation for Plant Generator

CR-85 – In a unanimous vote, council approved an agreement with Bryan Power Generation, in a total amount not to exceed \$219,341, for the Generator Relocation Project at the Water Treatment Plant.

Contractor Hired for Minor Drainage Repairs

CR-86 – Council unanimously approved the trade contractor agreement with Hallmark, Inc., in a total amount not to exceed \$104,038, for the 2017 Minor Drainage Repairs Project.

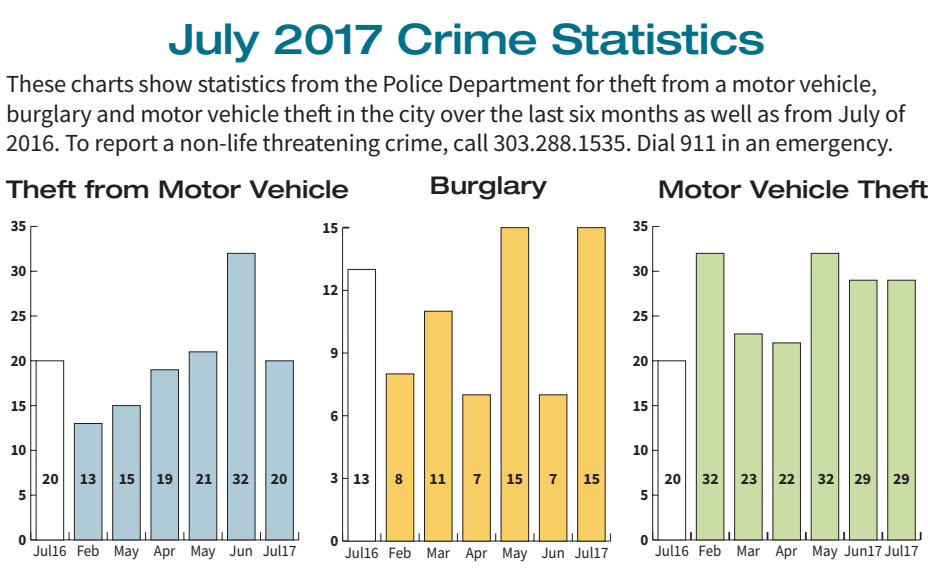
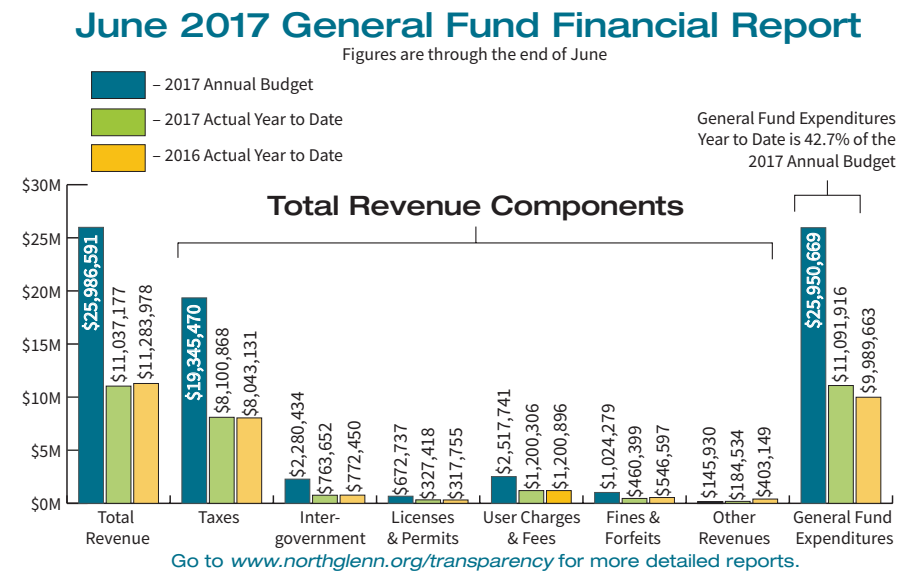

New this year, the Five Star District may announce a two-hour delayed start if temporary adverse weather conditions exist in the morning, including but not limited to high winds, cold temperatures or unfavorable road conditions for morning rush hour.

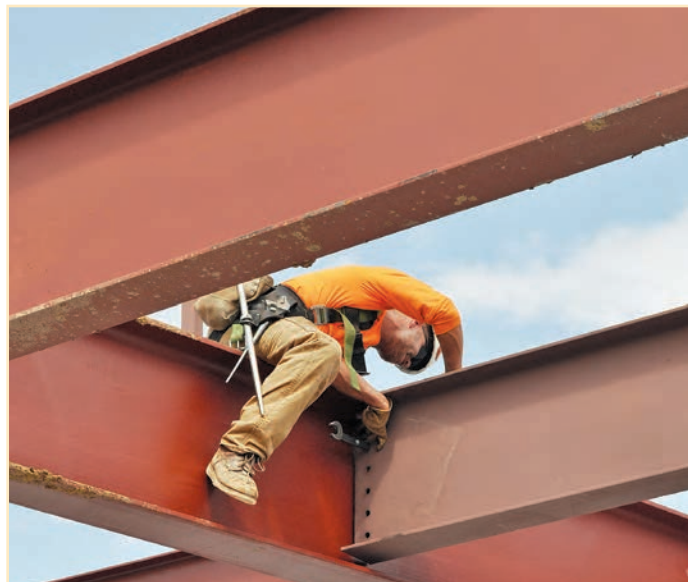

equipment and is managed by highly trained city staff to deliver water 24/7. The city's annual budget for water and wastewater operations is \$15 million and serves over 10,000 utility accounts, providing service to over 38,000 residents and 914 businesses with the highest quality, safest and best tasting water possible.

Because nothing lasts forever, periodic upgrades to treat water in accordance with federal standards is necessary. To that end, extensive work is in process at the Wastewater Treatment Plant, an aging facility, where Northglenn's wastewater is sent to be treated. In 2017, \$13 million was spent on construction at the plant, and \$32 million (\$3 million for water and \$29 million for wastewater) will be invested from 2019-21. This construction is essential if we are to continue to provide the residents of our city with reliable wastewater service.

The city is continually repairing and replacing system components, including the collection and distribution system pipes. Since the system continues to age, more components will need repair or replacement over time. The city plans major construction or repair projects in a 5-10 year cycle. The necessary upgrades at the Wastewater Treatment Plant have been planned for several years.

Planning for the future

Northglenn will continue to offer the best water and wastewater service at the lowest cost possible, but, like nearly everything else, that cost will likely continue to rise. Rest assured that increased rates are carefully thought out and based on real need.

The tree will receive a metal sign to honor the achievement. Also, its photo will be added to the display honoring past Most Magnificent Trees, which is located just outside City Council Chambers. The Adam family will receive a credit on their next water bill.

Council Seats Up for Vote in November

This November, Northglenn voters will elect a mayor and one council member from each of the city's four wards. A list of candidates is available after Aug. 28 at www.northglenn.org/election.

The November 7, 2017 regular municipal election will be coordinated with Adams and Weld counties and will be conducted as a mail ballot election.

Ballots will be mailed to all active registered voters October 16-20. Ballots must be returned by 7 p.m. on Election Day to be counted. Voters may return their ballot by mail or by delivering it to a ballot drop-off site. For voter convenience, a 24-hour drive-up ballot drop box is located in the south parking lot at City Hall, 11701 Community Center Drive. Information about other drop-off locations will be included in the mail ballot package voters will receive in October. Voter service and polling

centers will also be available prior to and on Election Day for voters who may need a replacement ballot or who may need to use an accessible voting system.

New residents may register to vote at any time prior to the election and on Election Day if they have resided in Colorado for 22 days prior to the election. Online voter registration is available at www.govotecolorado.com for residents who have a Colorado Driver's License or ID card issued by the Department of Revenue. Voter registration is also available in-person at the City Clerk's Office, the County Election Department and at motor vehicle locations.

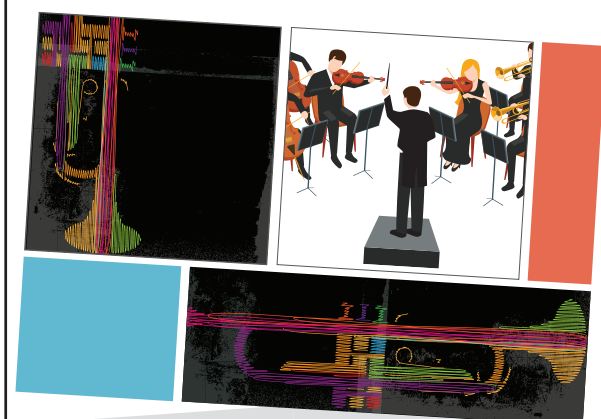
