

The Council of the City of North Royalton met in the North Royalton City Hall Council Chambers, 14600 State Road on **June 30, 2020 in Special City Council Meeting**. The meeting was called to order at **6:16 p.m.** by President of Council Paul Marnecheck and opened with the Pledge of Allegiance.

Subsequent thereto Mr. O'Donnell and I had a very nice telephone conversation. Mr. O'Donnell has conferred with Mr. Langshaw and as I understand it, based on our conversations, Mr. Langshaw prefers now the matter be heard in Executive Session format.
