



AN ORDINANCE ADDRESSING THE PROVISIONS OF AMENDED SUBSTITUTE H.B. 172 CONCERNING THE RIGHT OF MUNICIPALITIES TO RETAIN THE REGULATIONS AND PROHIBITIONS ON THE DISCHARGE, IGNITION AND EXPLODING OF FIREWORKS THAT EXISTED PRIOR TO THE ENACTMENT OF AMENDED SUBSTITUTE H.B. 172, AND DECLARING AN EMERGENCY

WHEREAS: On October 27, 2021, the Ohio General Assembly passed Amended Substitute House Bill 172

("H.B. 172") concerning, among other things, the regulation, possession, discharge, ignition

and exploding of fireworks in the State of Ohio; and

WHEREAS: Governor DeWine signed H.B. 172 into law on November 8, 2021; and

WHEREAS: Various aspects of H.B. 172 will, without legislative action by Ohio municipalities and other

governmental entities, permit the discharge, ignition and/or exploding of what are commonly

referred to as "fireworks" on certain conditions and on certain days of the year; and

WHEREAS: Provisions of H.B. 172 (including what is now RC 3743.45(D) and (E) and RC 3743.451(B))

expressly grant municipalities with home rule authority the right to retain all or any municipal ordinances that regulate and/or prohibit the discharge, ignition or exploding of fireworks and to retain all Ordinances that regulate noise, disturbance of the peace and disorderly conduct;

and

WHEREAS: The discharge, ignition and/or exploding of fireworks poses significant danger to the public

and will cause injuries as well as property damage, especially in densely populated residential

areas; and

<u>WHEREAS</u>: Council desires to opt-out of H.B. 172 before its provisions take effect and to reaffirm the

existing ban on discharging, igniting or exploding fireworks as set forth in Section 672.10 of

the Codified Ordinances; and

<u>Section 1</u>. All existing ordinances of the City of North Royalton that govern the possession, discharge, ignition and/or explosion of fireworks are hereby reaffirmed and ratified and shall be in full force and effect as permitted by the terms of H.B. 172 and the Ohio Revised Code and the City of North Royalton affirmatively opts out of the provisions of H.B. 172 that would and do otherwise allow for the use of fireworks as specified therein.

<u>Section 2</u>. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements.

<u>Section 3</u>. This Ordinance is hereby declared to be an emergency measure immediately necessary for the preservation of the public peace, health, safety and welfare of the city, and for the further reason that it is immediately necessary to regulate the possession, discharge, ignition and/or explosion of fireworks for the safety and protection of all and to do so before the effective date of H.B. 172.

<u>WHEREAS</u>: Council finds that it bears no higher obligation than the obligation to protect the lives and

<u>Section 1.</u> Part 4 Traffic Code, Title Six, Chapter 432 Operation Generally, Section 432.30 Stopping for School Bus; Actuating Visual Signals; Discharging Children, Paragraph (f)(1) of the Codified Ordinances of the City of North Royalton be and is hereby amended as follows:

432.30 STOPPING FOR SCHOOL BUS; ACTUATING VISUAL SIGNALS; DISCHARGING CHILDREN

(f) (1) Whoever violates division (a) of this section may be fined an amount not to exceed one thousand dollars (\$1000.00) is guilty of a misdemeanor of the first degree as defined in the Ohio Revised Code and shall be sentenced according to the provisions of NRCO Section 698.02 and subject to a fine of not more than \$1000.00 and a term of incarceration of not more than 180 days. A person who is issued a citation for a violation of division (a) of this section is not permitted to enter a written plea of guilty and waive the person's right to contest the citation in a trial but instead must appear in person in the proper court to answer the charge.

<u>Section 2</u>. Section 432.30 of the Codified Ordinances of the City of North Royalton is hereby amended as provided for herein and all other provisions of Chapter 432 shall remain in full force and effect.

Section 3. This Ordinance shall supersede all previously adopted Ordinances in direct conflict herewith.

12 Planning and Zoning Code, Chapter 1260 General Provisions and Definitions, Section 1260.07 Definitions to add appropriate definitions that define Accessory Building structures.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTH ROYALTON, COUNTY OF CUYAHOGA AND STATE OF OHIO, THAT:

<u>Section 1</u>. Part 12 Planning and Zoning Code, Chapter 1260 General Provisions and Definitions, Section 1260.07 Definitions of the Codified Ordinances of the City of North Royalton is hereby amended to hereinafter read as follows:

1260.07 DEFINITIONS.

- (f) Building and Structures.
- (1) "Accessory building" means a subordinate building detached from, but located on, the same lot as the main building, the use of which is incidental and accessory to that of the main building or use.
- (2) "Basement" means the space of a building where the floor level is more than four feet below the average finished grade.
- (3) "Building" means a structure which is permanently affixed to the land, having one or more floors and a roof, being bounded by either open space or lot lines, and used as a shelter or enclosure for persons, animals or property.
- (4) "Accessory Shelter" means an Accessory Building that is permanently affixed to the land, having not more than one floor and a roof. The shelter may be entirely open, or enclosed with fully transparent exterior walls and doors, or whose non-transparent exterior walls and doors shall not enclose more than 20% of the total building perimeter.
- (5) "Private Garage" means an Accessory Building or portion of a dwelling which is fully enclosed and used for the sheltering of permitted vehicles and storage of household equipment incidental to the residential occupancy.
- <u>Section 2</u>. Chapter 1260 General Provisions and Definitions, Section 1260.07 Definitions is hereby amended as provided for herein and all other provisions of Chapter 1260 shall remain in full force and effect.
- Section 3. This Ordinance shall supersede all previously adopted Ordinances in direct conflict herewith.

<u>Section 4</u>. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements.

B. For all lots containing one acre or more, all accessory structures shall not
exceed 1,200 square feet, regardless of size of the main use structure. For all lots containing one acre or more
and a main use structure that exceeds 2,500 square feet, all accessory structures shall not exceed fifty percent
of the main use structure foundation inclusive of attached garage. Such accessory structures shall not exceed
the basic footprint of thirty-five percent of the lot. Such footprint shall be permitted to be split to
accommodate the maximum lot use.
C. The thirty-five percent of lot coverage limitation shall include the following:
The main use structure, any accessory structures, parking areas, sidewalks, driveways, swimming pools, any
recreation areas that are hard surfaced with concrete or blacktop or similar materials.
D. Accessory structures and detached garages commonly associated with R1-A
and R1-B Districts are not permitted in a cluster development in accordance with Section 1270.33(d)(4)F.
E. Swimming pools, whether in-ground or above-ground, shall be permitted
regardless of size providing such pool does not exceed the thirty five percent lot coverage inclusive with all
other accessory structures.
